Summary

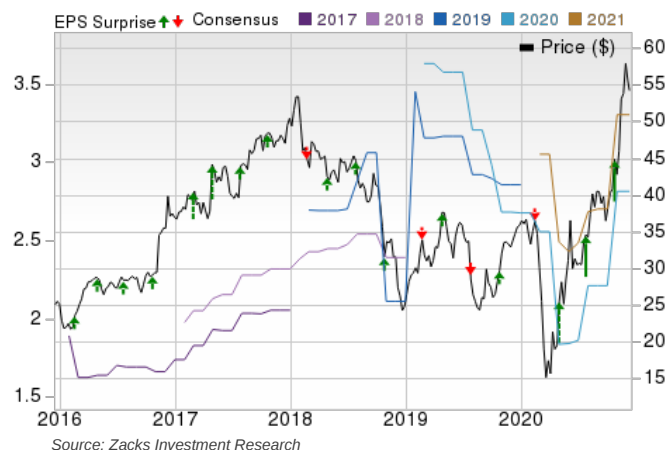
In the past three months, Altra Industrial's shares have outperformed the industry. Strength in the company's semiconductor, defense and transportation markets are likely to drive its top line in the quarters ahead. Also, diversified businesses, focus on deleveraging balance sheet, a healthy liquidity position and shareholder-friendly policies will favor the company. Further, its technological expertise, e-commerce capabilities and working capital improvement program are expected to be beneficial. For 2020, it raised earnings and sales projections to \$2.70-\$2.82 per share and \$1,690-\$1,710 million, respectively. It earlier predicted earnings of \$2.05-\$2.30 per share and sales of \$1,580-\$1,640 million. However, weakness across multiple end markets, including commercial aerospace, metals, mining and others, is concerning.

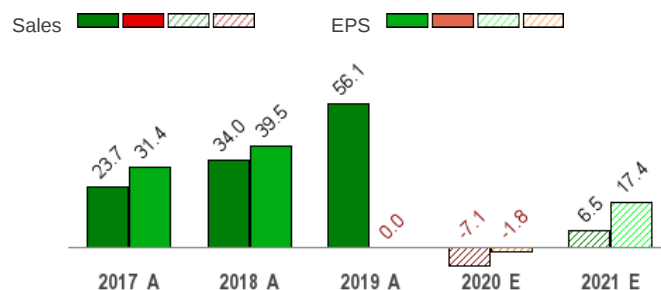

Overview

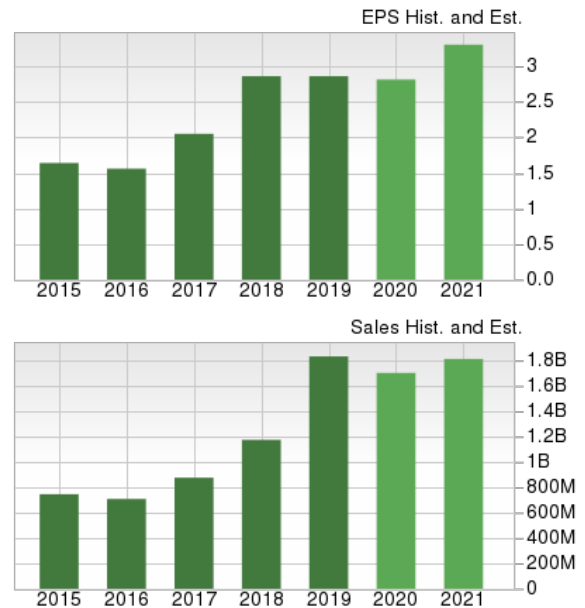
Altra Industrial Motion Corp., incorporated in 2004, is currently headquartered in Braintree, MA. The company is one of the leading manufacturers and distributors of a diversified range of motion control, electromechanical power transmission and automation products. Its product line includes clutches & brakes, couplings, gears, motion control products, and others. It has production facilities in 16 countries.

The company caters to customers in the energy, general industrial, material handling, food processing, mining, industrial automation, transportation, turf & garden, and other industries.

In the fourth quarter of 2018, Altra Industrial completed the combination of its business operations with four companies of the Automation and Specialty business of Fortive Corporation. Effective from the fourth quarter, the company started reporting revenues under the following heads/segments — Automation & Specialty, and Power Transmission Technologies. The segments are briefly discussed below.

- **Power Transmission Technologies (PTT)** segment primarily offers electromagnetic clutches & brakes; couplings, clutches & brakes; and gearings. While electromagnetic clutches & brakes are mainly used in material handling, agricultural machinery, turf & garden, and motion control markets, couplings, clutches & brakes are used in energy and heavy industrial markets. Gearings are used in industrial markets.
- **Automation & Specialty (A&S)** segment includes the results of the majority of product brands, including Kollmorgen, Thomson, Portescap and Jacobs Vehicle Systems, acquired as part of the business collaboration with Fortive.

It is worth mentioning that Kollmorgen-branded products are mainly used in aerospace and defense, medical, material handling, packaging, factory automation, semiconductor, robotics, printing and other markets. Portescap-branded products are used in general industrial, medical and industrial power tool markets while Thomson products are used in material handling, medical, food processing, factory automation, mobile off-highway and others. In addition, Jacobs Vehicle Systems-branded products are used in heavy-duty Class 8 trucks.

Reasons To Buy:

- ▲ Altra Industrial reported better-than-expected results for third-quarter 2020, with earnings and sales surpassing estimates by 77.6% and 9.9%, respectively. A solid demand in Class 8 truck markets in China, medical and renewable energy markets along with benefits from cost actions drove the results. For 2020, the company increased its sales projection from \$1,580-\$1,640 million to \$1,690-\$1,710 million, whereas earnings expectation was revised from \$2.05-\$2.30 per share to \$2.70-\$2.82. Also, the tax rate is now expected to be 20-21% (compared with the earlier mentioned 21-23%).
- ▲ Over time, Altra Industrial's presence in multiple end markets has been proving advantageous. In third-quarter 2020, the company's sales performance in factory automation & specialty machinery, defense, transportation, renewable energy, turf & garden, and medical equipment markets improved in the quarter. In the quarters ahead, demand for automation, driven by the pandemic, will favour business in the semiconductor market. On the other hand, prospects are bright in defense and transportation markets too. Over the long term, the company believes that solid product portfolio, diversified businesses, pricing actions, cross-selling programs and supply-chain initiatives will be beneficial. Further, its technological expertise, e-commerce capabilities and working capital improvement program are expected to benefit.
- ▲ Altra Industrial seems to be working hard for deleveraging its balance sheet. In the third quarter of 2020, it repaid \$60 million of borrowing under its term-loan facility. Such deleveraging actions are supported by the company's strong cash position. Notably, its free cash flow in the quarter increased 13% year over year to \$81.1 million, while cash and cash equivalents grew 8.5% sequentially. Exiting the third quarter of 2020, the company had \$239 million cash available and \$295 million of liquidity under its credit line. Further, restricted capital spending of \$34-\$40 million for 2020, down from \$40-\$45 million stated previously, will likely help in adding to its liquidity position. In addition, deleveraging actions, healthy cash helps in rewarding shareholders handsomely. In the first nine months of 2020, the company paid out dividends of \$24.9 million. In October, its board of directors approved a 50% hike in the company's quarterly dividend rate, which now stands at 6 cents.
- ▲ In the past three months, Altra Industrial's shares have gained 28.2% compared with the industry's growth of 12.2%. Also, it seems that analysts have become increasingly bullish about the company over the past 60 days. The company's earnings estimates have been raised 38% for the fourth quarter of 2020, 27.1% for 2020 and 22.2% for 2021.

Altra Industrial's deleveraging actions, diversified end-market exposure, cost-reduction efforts and healthy liquidity might aid, going forward. It raised quarterly dividend rate and financial projections for 2020.

Risks

- For the fourth quarter of 2020, Altra Industrial predicts a modest decline in revenues from the third quarter of 2020. The fall is likely to stem from sequentially lower sales in China. In addition, the company expects sequential increase in its selling, general and administrative expenses. Investments to enhance technology and expand automation initiatives are expected to increase capital expenditure in the quarter.
 - In third-quarter 2020, Altra Industrial's organic sales decreased 2.4% year over year. Businesses in multiple end markets, including mining, oil & gas, distribution, metals, and agriculture, were weak in the quarter. For the fourth quarter of 2020, the company expects issues related to supply chain to impact business in the renewable energy market. Also, business in the commercial aerospace market is expected to be weak in the quarters ahead. Also, it believes that business in metals, oil & gas, and mining markets will be soft for the rest of 2020.
 - With operations spread globally, Altra Industrial's performance is exposed to risks arising from geopolitical issues, trade relations, adverse movements in foreign currencies and governmental policies. In third-quarter 2020, sales in Europe declined 8.5% year over year, while the same in North America decreased 7.9%. In addition, despite a healthy liquidity position and efforts to deleverage the balance sheet, the company's huge debt level is concerning. Exiting third-quarter 2020, its long-term debt was at \$1.5 million.

Last Earnings Report

Altra Industrial Beats on Q3 Earnings, Hikes '20 View

Altra Industrial reported better-than-expected results for the third quarter of 2020, with earnings surpassing estimates by 77.6%. This is the third consecutive quarter of earnings beat by the company. Also, its third-quarter sales beat estimates by 9.9%.

The machinery company's non-GAAP earnings in the reported quarter were 87 cents per share, surpassing the Zacks Consensus Estimate of 49 cents. Also, the bottom line rose 26.1% from the year-ago quarter figure of 69 cents.

The company noted that it benefited from healthy demand in renewable energy and medical markets, and Class 8 truck markets in China in the third quarter. Along with this, its cost-reduction measures and healthy cash-flow generation in the quarter were encouraging.

Revenue Details

In the reported quarter, Altra Industrial's revenues were \$437.8 million, reflecting a decline of 1.2% from the year-ago number.

Foreign currency translation had a positive impact of 1.2 percentage points. However, organic sales declined 2.4% year over year due to weakness in several end markets — including distribution, metals, mining, oil & gas, and agriculture. Notably, business in renewable energy, factory automation & specialty machinery, defense, transportation, turf & garden, and medical equipment markets improved in the quarter.

However, the company's revenues surpassed the Zacks Consensus Estimate of \$398 million.

Altra Industrial reports revenues under two heads — Automation & Specialty, and Power Transmission Technologies. A brief snapshot of the segmental sales is provided below:

Revenues generated from Power Transmission Technologies amounted to \$197.7 million, declining 9.6% year over year.

Automation & Specialty's sales were \$240.8 million in the third quarter, up 7.1% from the year-ago reported quarter.

Margin Profile

In the reported quarter, Altra Industrial's cost of sales decreased 4.3% year over year to \$273.7 million. Notably, cost of sales represented 62.5% of net sales. Non-GAAP gross profit was \$164.1 million, up 4.5% year over year. Gross margin increased 200 basis points (bps) year over year at 37.5%.

Non-GAAP selling, general and administrative expenses decreased 7.3% year over year to \$64.6 million and represented 14.8% of net sales. Research and development expenses were \$13.8 million versus \$14.4 million in the year-ago quarter.

Non-GAAP adjusted earnings before interest, taxes, depreciation and amortization (EBITDA) were \$101.8 million, the margin being 23.3%. Non-GAAP operating income in the reported quarter increased 17.6% year over year to \$85.7 million, with non-GAAP operating margin increasing 310 basis points to 19.6%.

Net interest expenses totaled \$18 million in the reported quarter, reflecting a decrease of 1.1% from the year-ago quarter.

Balance Sheet & Cash Flow

Exiting the third quarter, Altra Industrial's cash and cash equivalents were \$238.7 million, increasing 8.5% from \$220.1 million recorded in the last reported quarter. Long-term debt was \$1,476.9 million, reflecting a 3.8% decline from \$1,535.6 million in the last reported quarter.

During the first nine months of 2020, the company repaid \$90 million of borrowing under its term-loan facility and \$100 million under its revolving credit facility. Additional borrowing under its revolving facility totaled \$100 million.

In the first three quarters of 2020, the company generated net cash of \$161.8 million from operating activities, down 10.3% from the year-ago comparable period. Capital invested for purchasing property, plant and equipment totaled \$24.3 million, decreasing 34.1% year over year.

In the first nine months of 2020, the company paid out dividends amounting to \$24.9 million, down from \$33.1 million distributed in the prior-year comparable period.

Outlook

Altra Industrial noted that its diversified businesses, initiatives to boost opportunities in end markets, debt reduction actions and healthy cash generation might be beneficial in the quarters ahead.

It upwardly revised its financial projections for 2020. Sales are now projected to be \$1,690-\$1,710 million, higher than the previously mentioned \$1,580-\$1,640 million.

Non-GAAP earnings are expected to be \$2.70-\$2.82, up from \$2.05-\$2.30 per share stated earlier. Also, non-GAAP adjusted EBITDA is likely to be \$355-\$370 million (up from the earlier mentioned \$305-\$330 million). The tax rate is still anticipated to be 20-21%, lower than 21-23% mentioned previously. Capital spending is expected to be \$34-\$40 million (down versus \$40-\$45 million stated previously).

Recent News

Dividend

On **Oct 21, 2020**, Altra Industrial announced that its board of directors approved the payment of a quarterly dividend of 6 cents per share. Notably, the quarterly dividend rate — pertaining to the fourth quarter of 2020 — is 50% higher than the previous rate of 4 cents paid by the company for the third quarter of 2020.

The dividend payment for the fourth quarter will be made on Jan 5, 2021, to shareholders of record as of Dec 18, 2020.

Valuation

Altra Industrial shares are up 46.1% in the year-to-date period and 50.5% over the trailing 12 months. Stocks in the Zacks sub-industry and the Zacks Industrial Products sector are up 8.9% and 15.6%, respectively, in the year-to-date period. Over the past year, the Zacks sub-industry and the sector are up 9.9% and 16.4%, respectively.

The S&P 500 index has increased 13.9% year to date and 15.1% in the past year.

The stock is currently trading at 16.12X forward 12-month earnings per share, which compares to 27.88X for the Zacks sub-industry, 22.95X for the Zacks sector and 22.56X for the S&P 500 index.

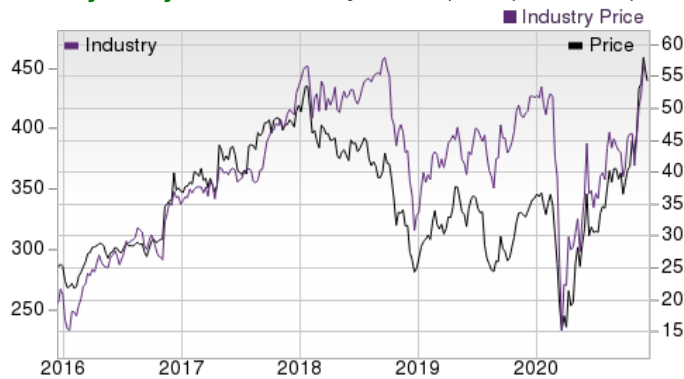
Over the past five years, the stock has traded as high as 25.37X and as low as 4.89X, with a 5-year median of 16.37X. Our Outperform recommendation indicates that the stock will perform better than the market. Our price target of \$61 reflects 18.54X forward 12-month earnings per share.

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. We also produce the VGM Score (V for Value, G for Growth and M for Momentum), which combines the weighted average of the individual Style Scores into one score. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
