Summary

Shares of B&G Foods have outperformed the industry in the past six months. The company's retail business has been seeing continued momentum since last summer as more Americans are embracing cooking and seasoning meals at-home amid COVID-19. Also, the foodservice business is showing signs of rebound. These were reflected in first-quarter fiscal 2021, with earnings and sales rising year over year. Moreover, it is actively pursuing strategic acquisitions to boost growth. However, the company is witnessing a spike in SG&A expenses for a while. Also, it has been incurring high COVID-19 costs at its manufacturing facilities. These hurdles together with cost inflation put pressure on first-quarter performance. That being said, the company is focused on undertaking cost-cutting efforts and revenue-enhancing actions across many brands.

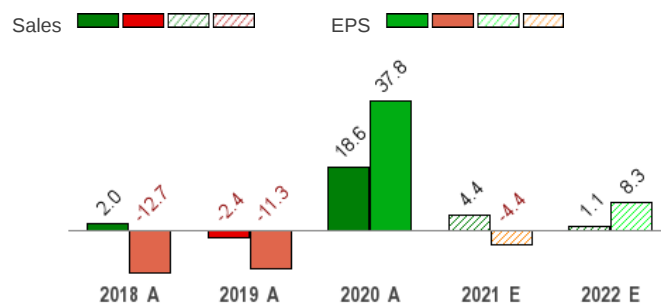
Price, Consensus & Surprise

Overview

Based in Parsippany, NJ, B&G Foods, Inc. along with its subsidiaries manufactures, sells and distributes high quality, shelf stable, frozen food and household products across the United States, Canada and Puerto Rico.

The company boasts of a diversified portfolio of 50 brands, including Back to Nature, B&G, B&M, Cream of Wheat, Green Giant, Las Palmas, Le Sueur, Mama Mary's, Maple Grove Farms, Mrs. Dash, New York Style, Ortega, Pirate's Booty, Polaner, SnackWell's, Spice Islands and Victoria. Many of these brands hold leading market shares in different regions.

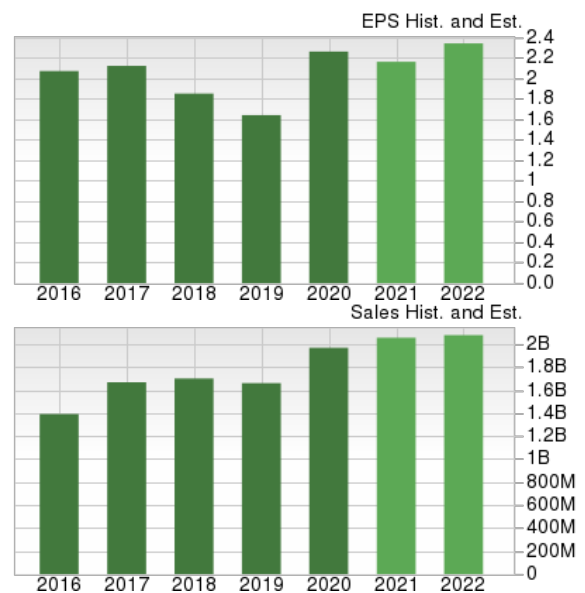
In order to further strengthen portfolio, the company frequently engages in acquisitions and innovations. Since 1996, B&G Foods has acquired and integrated more than 45 brands.

The company sources raw materials from suppliers located in the United States as well as overseas. In order to meet production need, it procures a range of raw materials such as agricultural items as well as meat, poultry and flour amongst others. Ingredients and packaging materials are sourced from growers, commodity processors other food companies and packaging suppliers

Alongside retail sales, the company also engages in institutional, foodservice and private label sales. It sells, distributes and markets products to supermarkets, mass merchants, warehouse clubs, specialty food distributors, wholesalers, foodservice distributors and direct accounts, military commissaries and non-food outlets such as drug and dollar store chains.

Many of these channels procure the company's products through broker sales network. Owing to differential product characteristics, the company maintain a different distribution system for frozen and shelf-stable products. Such items are handled by third-party logistics providers.

Further, marketing and trade spending support the company's brands. Such endeavors typically consist of advertising trade promotions, coupons and cross promotions with other products. It makes use of a range of media platforms to supplement its marketing and promotional ventures.



Reasons To Buy:

▲ **Q1 Sales & Earnings Rise:** B&G Foods' retail business has been seeing continued momentum since last summer as increased number of Americans' are embracing cooking and seasoning meals at-home amid the pandemic. Moreover, the foodservice business is showing signs of rebound. Notably, the away-from-home channel is improving as shelter at home measures are easing. These were reflected in first-quarter fiscal 2021, with earnings and sales increasing on a year-over-year basis. Notably, the company posted adjusted earnings of 52 cents per share that increased 13%. Further, net sales of \$505.1 million advanced 12.4% on contribution from the Crisco acquisition — concluded on Dec 1, 2020 — and persistent strength in base business net sales. Shares of B&G Foods have rallied 16% in the past six months compared with the industry's growth of 12%.

B&G Foods is gaining from strategic acquisitions. Further, the company is benefiting from robust demand amid coronavirus-led higher at home consumption.

▲ **Robust Margins:** During the first quarter of fiscal 2021, the company's adjusted gross profit rose from \$107.2 million to \$123.3 million. Further, adjusted gross margin increased to 24.4% from 23.9% reported in the year-ago quarter. Further, B&G Foods' adjusted EBITDA increased 15.2% to \$92.9 million, driven by the impact of higher net sales mainly driven by contributions from the Crisco acquisition. Moreover, adjusted EBITDA margin improved from 18% to 18.4% during the quarter. Further, adjusted EBITDA before COVID-19 expenses increased 18.5% to \$95.8 million. We believe that persistence of such trends is likely to keep aiding the company's performance in the future.

▲ **Strategic Acquisitions:** The company is actively pursuing strategic acquisitions to boost growth. In this regard, B&G Foods, acquired Crisco brand from J.M. Smucker in December 2020. Notably, the company's net sales in first-quarter fiscal 2021 reflect gains worth \$58.1 million from the Crisco acquisition. In 2021, Crisco is expected to make favorable contributions to B&G Foods' top line.

Prior to this, the company acquired Farmwise (in February 2020), while it also acquired and integrated retail baking powder maker, Clabber Girl (acquired in May 2019). Apart from this, the company has acquired notable brands such as Back to Nature, Green Giants, Victoria, Mama Mary, TrueNorth, McCann's and Ortega. The company remains committed to product innovation and other brand enhancement investments.

▲ **Solid E-Commerce Sales:** B&G Foods is benefiting from higher online sales, especially thanks to increased social-distancing trends. During the quarter of fiscal 2021, retail sales of the company's brands through e-commerce platforms surged more than 60% to reach \$50 million. In its last earnings call, management highlighted that it expects e-commerce retail sales for fiscal 2021 to keep growing at this rate and come in at \$275 million. E-commerce sales are accelerating with pace, mainly attributable to efficient delivery services of the company's retail customers. The company expects to continue seeing solid online trends in 2021 and is making investments to strengthen its online presence and market with several retailers on their websites.

Reasons To Sell:

▼ **Escalated Costs:** The company's SG&A expenses have been rising year over year for quite some time now. During first-quarter fiscal 2021, B&G Foods' SG&A expenses increased 26% to \$50.4 million, thanks to rise in consumer marketing costs, acquisition/divestiture-induced and non-recurring expenses, warehousing costs as well as general and administrative expenses. As a percentage of sales, SG&A expenses expanded 1.1 percentage points to 10%. Prior to this, SG&A expenses increased 31.5%, 13.9% and 11.3% in the fourth, the third and the second quarter of 2020, respectively.

Additionally, during the quarter B&G Foods incurred nearly \$2.9 million in additional pandemic-led costs at its production facilities including temporary enhanced competition for manufacturing employees, compensation to manufacturing employees in quarantine as well as costs associated with take precautionary health and safety measures.

▼ **Input Cost Inflation:** B&G Foods has been battling cost inflation for a while now. During the first quarter of fiscal 2021, the company saw low to mid single-digit inflation on a blended basis in basket of goods with notable spike in agricultural products and commodity associated input costs. Also, inflation in corrugated steel and aluminum led to the downside. Further, management expects to keep seeing input cost inflation for ingredients, packaging and transportation in fiscal 2021. That being said, the company is focused on undertaking cost-cutting efforts coupled with revenue-enhancing actions across many brands.

▼ **Financial Status:** Although B&G Foods' long-term debt of almost \$2,330 million as of the end of the first quarter of fiscal 2021 (Apr 3, 2021) inched down 0.2% sequentially, its debt-to-capitalization ratio stands worse than the industry. The company's ratio at the end of the quarter was pegged at 0.74, higher than the industry's ratio of 0.44. Further, the company's times interest earned ratio stands at 2.7, lower than the industry's ratio of 3.5. The times-interest-earned ratio is very important for some companies, as it measures a company's ability to meet its debt obligations based on its current income.

B&G Foods' SG&A costs have been rising year over year. Also, the company continued to incur high costs associated with COVID-19 at its production facilities.

Last Earnings Report

B&G Foods Q1 Earnings Miss Estimates, Sales Rise Y/Y

B&G Foods reported first-quarter fiscal 2021 numbers, with the top and the bottom line missing the Zacks Consensus Estimate. Nevertheless, earnings and sales increased on a year-over-year basis.

The company's retail business continues to witness elevated demand as Americans are still cooking and seasoning meals at home amid the pandemic. Further, the foodservice business is showing signs of rebound. Notably, the away-from-home channel is improving as shelter at home measures are easing.

Quarterly Highlights

The company posted adjusted earnings of 52 cents per share, which missed the Zacks Consensus Estimate of 55 cents. Nonetheless, the bottom line increased 13% year over year.

Net sales of \$505.1 million advanced 12.4% year over year on contribution from Crisco acquisition concluded on Dec 1, 2020, as well as persistent strength in base business net sales. Notably, net sales reflect gains worth \$58.1 million from the Crisco acquisition. However, the top line missed the Zacks Consensus Estimate of \$517.7 million.

Base business net sales inched down 0.6% to \$446.9 million from \$449.4 million reported in the year-ago quarter. We note that significant year-over-year base business net sales growth during January and February were countered by declines in base business net sales in March, thanks to pandemic-led demand and pantry loading in March 2020. Incidentally, unit volumes declined \$9.8 million. Nonetheless, gains from net pricing coupled with positive impact of product mix to the tune of \$6.6 million offered some respite. Also, favorable impacts of foreign currency translations of \$0.7 million were an upside. Despite solid demand, the company expects base business net sales to decline year over year in the second quarter of 2021. The projected decline takes into account unfavorable comparisons stemming from massive spike in demand and pantry loading during the same time last year.

Net sales of spices & seasonings, Maple Grove Farms and Ortega increased 41.2%, 12.1% and 0.4%, respectively. Net sales of Green Giant (including Le Sueur), Clabber Girl and Cream of Wheat declined 16.4%, 6.8% and 4%, respectively. All said, net sales of all other brands in the aggregate fell 5.6% year on year.

Adjusted gross profit rose from \$107.2 million to \$123.3 million. Further, adjusted gross margin increased to 24.4% from 23.9% reported in the year-ago quarter.

SG&A expenses increased 26% to \$50.4 million, thanks to rise in consumer marketing costs, acquisition/divestiture-induced and non-recurring expenses, warehousing costs as well as general and administrative expenses. Nonetheless, decline in selling expenses offered some cushion. As a percentage of sales, SG&A expenses expanded 1.1 percentage points to 10%.

Adjusted EBITDA increased 15.2% to \$92.9 million, driven by the impact of higher net sales mainly driven by contributions from Crisco acquisition. Moreover, adjusted EBITDA margin improved from 18% to 18.4% during the quarter. Further, adjusted EBITDA before COVID-19 expenses increased 18.5% to \$95.8 million.

During the quarter, the company incurred nearly \$2.9 million in additional pandemic-led costs at its production facilities including temporary enhanced competition for manufacturing employees, compensation to manufacturing employees in quarantine as well as costs associated with take precautionary health and safety measures.

Other Updates

The company concluded the quarter with cash and cash equivalents of almost \$43.1 million, long-term debt of almost \$2,330 million and total shareholders' equity of \$840.6 million.

In a separate press release, the company informed that it has appointed Kenneth C. "Casey" Keller as the president and chief executive officer, effective Jun 14, 2021.

Guidance

B&G Foods reaffirmed its net sales guidance for fiscal 2021. Management anticipates net sales of \$2.05-\$2.10 billion in fiscal 2021. This includes positive impact from the acquisition of Crisco brand.

Moreover, management expects to keep witnessing solid consumer demand for its products for the rest of fiscal 2021. However, management expects to keep seeing input cost inflation for ingredients, packaging and transportation. That said, the company is focused on undertaking cost-cutting efforts coupled with revenue-enhancing actions across many brands. Due to the uncertainties surrounding the coronavirus outbreak, the company did not provide detailed guidance for fiscal 2021.

B&G Foods Announces Dividend – May 18, 2021

B&G Foods declared quarterly cash dividend of 47.50 cents per share, payable on Jul 30, 2021 to shareholders of record as on Jun 30, 2021.

Valuation

B&G Foods shares are up 22.8% in the year-to-date period and 40% over the trailing 12-month period. Stocks in the Zacks sub-industry are up 10.3% and the Zacks Consumer Staples sector gained 7.3% in the year-to-date period. Over the past year, the Zacks sub-industry went up 22.7% while the sector gained 22.1%.

The S&P 500 index is up 13.9% in the year-to-date period and 38.1% in the past year.

The stock is currently trading at 15.2X forward 12-month earnings, which compares to 19.8X for the Zacks sub-industry, 20.84X for the Zacks sector and 21.85X for the S&P 500 index.

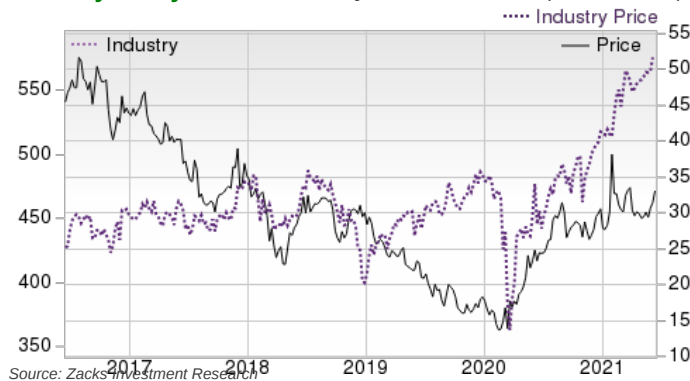

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
