Summary

Shares of Big Lots have increased and outpaced the industry in the past six months. Notably, the company is gaining from its transformation initiative, including Operation North Star that focuses on top-line growth, cost containment, and technological enhancement. The company is leaving no stone unturned with respect to leveraging marketing strategies and expanding its e-commerce platform. Recently, management issued impressive comparable sales and earnings outlook for third-quarter fiscal 2020. The company has been witnessing robust sales performance, which poise it well ahead of the holiday season. Comparable sales are likely to grow in mid-teens for the quarter under review. Notably, Big Lots envisions earnings in the band of 50-70 cents a share. However, pandemic-related incremental costs may weigh on margins to an extent.

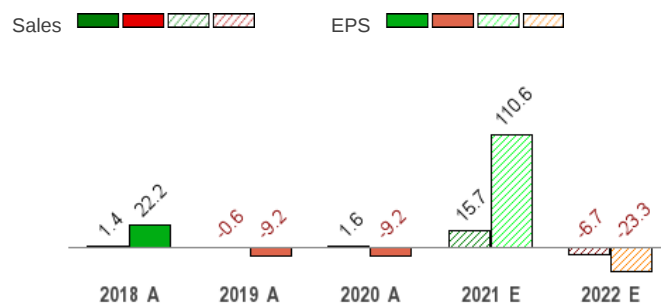

Overview

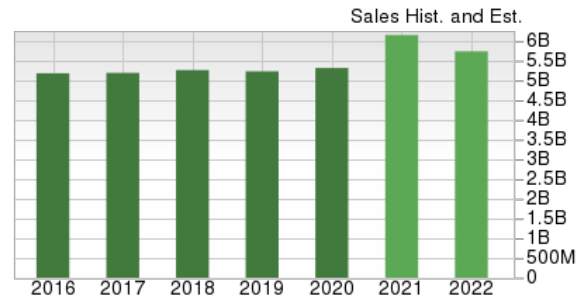
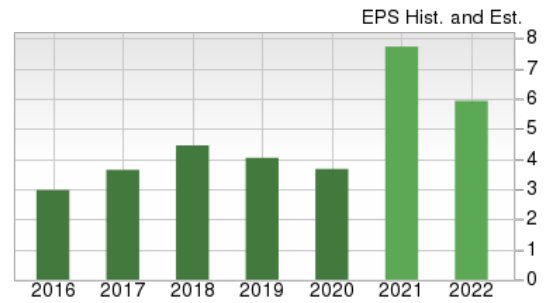
Based in Columbus, OH and founded in 1967, Big Lots, Inc. along with its fully-owned subsidiaries is a broad-line closeout retailer in the United States.

The company offers products under various merchandising categories, which include Food, Consumables, Furniture, Seasonal, Soft Home, Hard Home, Electronics and Toys & Accessories. The company's furniture category includes upholstery, mattress, case goods, and ready to-assemble departments while the seasonal category includes Christmas trim, lawn & garden, summer, and other holiday departments.

Further, its Soft Home category includes fashion bedding, utility bedding, bath, window, decorative textile, home organization, area rugs, home décor, and frames departments. Consumables category comprises health, beauty and cosmetics, plastics, paper, chemical, and pet departments.

Food category comprises beverage & grocery, candy & snacks, and specialty foods departments. Electronics, Toys, & Accessories category comprises our electronics, toys, jewelry, and hosiery departments. Small appliances, table top, food preparation, stationery, greeting cards, and home maintenance departments form a part of the Hard Home category.

These products are processed for retail sale and distributed to its stores that are located in five regional distribution centers including Pennsylvania, Ohio, Alabama, Oklahoma, and California. Currently, Big Lots operated 1,407 stores across 47 states.

Reasons To Buy:

- ▲ **Growth Drivers:** Shares of Big Lots have surged 103.9% compared with the industry's rise of mere 24% over the past six months. The company has been gaining from its transformation initiative, referred to as Operation North Star, which encompasses driving top-line growth, cost containment, and enhancement in systems and infrastructure. Operation North Star has been focusing on streamlining the cost structure and core enablers with significant capabilities and tools in several areas of business such as real estate, supply chain and store engagement. Management remains focused on improving the performance by enhancing digital capabilities and expansion of Broyhill brand. During second-quarter fiscal 2020, Broyhill performed outstandingly and surpassed expectations. The brand is projected to contribute more than \$250 million in sales in its first year, with potential to become a \$1-billion brand in future. Additionally, the company is on track to expand assortments this fall, as well as extend Broyhill into housewares and kitchen textiles in the next year. Its everyday essentials' assortment and stay-at-home products position the company well going ahead. Big Lots is also on track with its pantry-optimization initiative, which involves repositioning of the assortment by shifting square footage from food staples to food, entertainment and consumables. This includes a 20-foot expansion in chemicals, and health and beauty.
- Big Lots has been gaining from its transformation initiative that encompasses driving top-line growth, cost containment and enhancement in systems and infrastructure.
- ▲ **Solid Q3 View:** Recently, Big Lots provided a business update for third-quarter fiscal 2020. Management cited that it has been witnessing robust sales performance, which is likely to help deliver a sturdy quarter. Encouragingly, this also poises the company well ahead of the holiday season. In addition, the Operation North Star initiative along with strong assortment and early encouraging signs before Christmas, have been tailwinds. Management now projects comparable sales growth in mid-teens for fiscal third quarter. In the third quarter of fiscal 2019, comparable sales dipped 0.1%. Based on impressive sales performance, third-quarter earnings per share are now envisioned in the bracket of 50-70 cents per share against a loss of 18 cents reported in the same quarter a year earlier.
- ▲ **Robust Q2 Performance:** Big Lots reported a robust second-quarter fiscal 2020, wherein both the top and bottom lines outpaced the Zacks Consensus Estimate and grew year over year. While higher sales and margins fueled the bottom line, robust comparable sales (comps) drove the top line. Impressively, comparable sales (comps) increased 31.3% in the reported quarter, on double-digit rise in store traffic and solid growth in basket across the channels. Comps were up strongly in May, however the pace moderated in June and more so in July. Nevertheless, the company recorded a high single-digit comps growth in July. Management has been seeing an acceleration of comps from July into August. Following a robust second quarter, Big Lots' third quarter is off to a solid start.
- ▲ **E-commerce and Rewards Growth:** Big Lots is leaving no stone unturned to tap the best in the market, as clear from its efforts to leverage marketing strategies, with loyalty databases and e-commerce enhancement. The company is experiencing strong e-commerce growth, buoyed by the success of the "Buy Online Pick-up In Store" (BOPIS) functionality. Notably, BOPIS has helped the company to increase their rate of orders. In order to tap higher volume, the company is also leveraging loyalty database with one-to-one marketing, which resulted in increased site traffic in number of orders and higher average basket. The company remains focused on enhancing the omni experience, aimed at, higher capabilities, removing friction and increasing customer base. It has also launched same-day delivery through Instacart. Moreover, it has been expanding the payment options online with lease-online, pick-up-in-store, the online version of the Easy Leasing program by Progressive, and the Big Lots credit card.
- Coming to the Rewards program, the penetration reached nearly 58-60%, equivalent to about 370-bps improvement. The net promoter scores, active membership and new customer acquisition have been robust. The Rewards enrollment increased 60% year over year in the quarter, with active membership encroaching on 20 million, representing about a 9% rise on a year-over-year basis.
- ▲ **Store of the Future and New Stores Strategy:** Apart from the company's initiatives, Store of the Future and new stores strategy are worth a mention. The Store of the Future initiative is a key driver of the company's recent positive trends in sales. This positions its shareholders for solid returns and its business for long-term success. The positive sales trends in these store formats (Store of the Future and new stores) are being backed by bigger basket as well as higher transactions. Additionally, management has been progressing well with rolling out of The Lot and queue lines to existing Store of the Future locations, along with 240 outlets in legacy or balance-of-chain format. Big Lots currently has about 694 stores with the queue and 630 with The Lot. The Lot gives an opportunity of testing new merchandise categories or assortments on being part of the themed presentations.
- ▲ **Debt Analysis:** As of Aug 1, 2020, Big Lots had a long-term debt of \$43.1 million, down significantly from \$467.8 million in the prior-year quarter. Also, it suggests a decline from long-term debt of \$463.7 million. Again, the company's times interest earned ratio of 67.8 at the end of fiscal second quarter has improved from 23.1 at the end of the previous quarter and compares favorably with that of the industry's 20.1. Moreover, the company ended the quarter with cash and cash equivalents of \$898.6 million, which shows significant improvement from \$311.9 million as at the end of the previous quarter.
- ▲ **Shareholder-Friendly Moves:** The company's board has authorized repurchasing of nearly \$500 million outstanding shares. Also, management announced a third-quarter cash dividend of 30 cents a share. Big Lots looks well placed on the dividend-payout front. We note that the company has a current annualized dividend rate of \$1.20 a share, flat with the year-ago period. Notably, Big Lots has a dividend payout of 19.3%, dividend yield of 2.3% and free cash flow yield of 22.4%. With an annual free cash flow return on investment of 37.6%, the dividend payment is likely to be sustainable.

Reasons To Sell:

- ▼ **COVID-19 Related Expenses:** Management anticipates continued pandemic-related incremental expenses in the second half of the fiscal, however, lower than that experienced in the first and second quarters. Consequently, the overall SG&A growth is likely to moderate in the third and fourth quarters than in fiscal second quarter. The company expects less gross-margin rate benefit from seasonal and mix in fiscal third quarter. As a result, gross margin is expected to remain similar year over year.
- ▼ **Higher S&A Cost:** During second-quarter fiscal 2020, selling and administrative expenses came in at \$500 million, up 14.8% year over year. This included roughly \$24 million with respect to the pandemic-related actions such as the temporary rise in the wage rate of \$2 per hour through early July. Also, associate discount of 30% discretionary bonuses, cleaning costs, personal protective equipment for staffs and certain miscellaneous expenses led to the increase. The company also made around \$6 million of rent expense in connection to the sale-leaseback transaction completed in the quarter and outstanding additional bonus expense of \$11 million in comparison to the prior year.
- ▼ **Stiff Competition:** Big Lots is facing intense competition from other general merchandise, discount, food, furniture, arts and crafts, and dollar store retailers, which operate in traditional brick and mortar stores and online. This may result in loss of market share as well as fall in sales and operating margins. Competitors with larger number of stores, greater market presence and better financial resources will continue to weigh on the company's results.
- ▼ **Macroeconomic Factors:** The company's customers are sensitive to macroeconomic factors, including interest rate hikes, increase in fuel and energy costs, credit availability, unemployment levels, high household debt levels and tariffs, which may negatively impact their discretionary spending, and in turn the company's growth and profitability. Any unfavorable changes in trade policy may result in higher prices for customers and may negatively impact their budgets, consequently their discretionary spending. Moreover, any cut in Supplemental Nutrition Assistance Program, which is expected to lower the purchasing power of low-income consumers, may also impact sales of Big Lots.
- ▼ **Cost-Reduction Initiatives:** Big Lots is on track with its three-year cost reduction program. Evidently, management expects to significantly surpass its initial cost-reduction target of \$100 million. In order to contain costs, the company is focused on areas such as organization size and structure, store payroll, indirect costs, supply chain and cost of goods sold. The company is enhancing in-store labor model by simplifying the management structure, which should improve shopping experience through better utilization of resources to serve customers.

Big Lots' selling and administrative costs grew 14.8% in second-quarter fiscal 2020. It anticipates continued pandemic-related incremental expenses in the second half of fiscal.

Big Lots posted an impressive second-quarter fiscal 2020 results. Both top and bottom lines outpaced the Zacks Consensus Estimate and grew year over year. Impressively, comparable sales (comps) increased 31.3% in the reported quarter, on double-digit rise in store traffic, and solid growth in basket across the channels.

Following a robust second quarter, Big Lots' third quarter is off to a solid start. Its everyday essentials' assortment and stay-at-home products position the company well going ahead. The company is also on track with its pantry-optimization initiative.

Q2 in Detail

This Columbus, OH-based company reported adjusted earnings of \$2.75 per share, surpassing the Zacks Consensus Estimate of \$2.71. Moreover, the bottom line increased significantly from 53 cents earned in the prior-year quarter.

Net sales grew 31.3% to \$1,644.2 million and outshone the Zacks Consensus Estimate of \$1,620 million. The upside can be attributed to robust comps and higher sales growth from new and relocated non-comp stores, slightly offset by lower store count year over year.

Comps were up strongly in May, however the pace moderated in June and more so in July. Nevertheless, the company recorded a high single-digit comps growth in July. Management has been seeing an acceleration of comps from July into August.

Gross profit jumped 37.2% year over year to \$683.6 million and gross margin expanded 180 basis points (bps) to 41.6%. Gross margin was driven by robust sell-through in seasonal products, a positive overall shift in product mix toward higher-margin categories and lower markdowns, partly offset with higher shrink.

In the reported quarter, selling and administrative expenses came in at \$500 million, up 14.8% year over year. However, the metric (as a percentage of net sales) improved 440 bps from the prior-year quarter to 30.4%.

Furthermore, adjusted operating profit came in at \$149.5 million, up from adjusted operating profit of \$32.6 million recorded in the prior-year quarter. Moreover, adjusted operating margin came in at 9.1%, up 650 bps from the year-ago quarter's adjusted tally.

Other Financial Details

The company ended the quarter with cash and cash equivalents of \$898.6 million. Inventories decreased 18% to \$713.5 million, due to robust sales performance. Long-term debt totaled \$43.1 million compared with \$467.8 million in the prior-year quarter. Total shareholders' equity was \$1,328.2 million.

As of Aug 1, 2020, the company provided net cash of \$322.3 million from operating activities. Capital expenditures were \$40.5 million in the reported quarter.

Concurrently, the company's board has authorized repurchasing of nearly \$500 million outstanding shares. The authorization is effective Sep 1. Also, management announced a third-quarter cash dividend of 30 cents a share. The company will pay dividends of roughly \$12 million on Sep 25, 2020, to shareholders of record as on Sep 11.

In the reported quarter, Big Lots opened and shuttered five stores each, with the total store count remaining 1,404. For fiscal 2020, management projects store count to remain flat versus the prior year including 25 store openings and 25 closings.

Outlook

On Mar 30, 2020, management withdrew fiscal 2020 view. It expects to issue business updates at the end of September with greater visibility. However, the company projects less gross-margin rate benefit from seasonal and mix in fiscal third quarter. As a result, gross margin is expected to remain similar year over year. Moreover, management anticipates continued pandemic-related incremental expense in the second half of the fiscal, however, lower than that experienced in the first and second quarters. Consequently, the overall SG&A growth is likely to moderate in the third and fourth quarters than in fiscal second quarter. Further, the year-over-year inventory decline is expected to moderate during fiscal third quarter. For fiscal 2020, management now estimates capital expenditures of about \$150 million.

Big Lots Issues Q3 Outlook – Sep 29, 2020

Big Lots has provided a business update for third-quarter fiscal 2020. Management cited that it has been witnessing robust sales, which is likely to help deliver a sturdy quarterly performance. Encouragingly, this also poises the company well ahead of the holiday season, the most crucial part of the year. In addition, the company's growth strategies, including Operation North Star and its strong assortment and early encouraging signs before Christmas, have been tailwinds.

Comparable sales are likely to grow mid-teens for fiscal third quarter against a dip of 0.1% in the year-ago period. Further, third-quarter earnings per share are now envisioned in the bracket of 50-70 cents per share against a loss of 18 cents reported in the same quarter a year earlier. Further, the outlook incorporates estimated share-repurchase activity for the quarter.

Valuation

Big Lots shares are up 80.7% in the year-to-date period and 137.3% over the trailing 12-month period. Stocks in the Zacks sub-industry and Zacks Retail-Wholesale sector are up 15% and 38.7%, respectively, in the year-to-date period. Over the past year, the sub-industry and the sector are up 16.5% and 43.3%, respectively.

The S&P 500 index is up 11.2% in the year-to-date period and 16.5% in the past year.

The stock is currently trading at 7.88X forward 12-month earnings, which compares to 26.85X for the Zacks sub-industry, 32.13X for the Zacks sector and 21.89X for the S&P 500 index.

Over the past five years, the stock has traded as high as 15.1X and as low as 3.32X, with a 5-year median of 10.2X. Our Neutral recommendation indicates that the stock will perform in line with the market. Our \$53 price target reflects 8.35X forward 12-month earnings.

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. We also produce the VGM Score (V for Value, G for Growth and M for Momentum), which combines the weighted average of the individual Style Scores into one score. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
