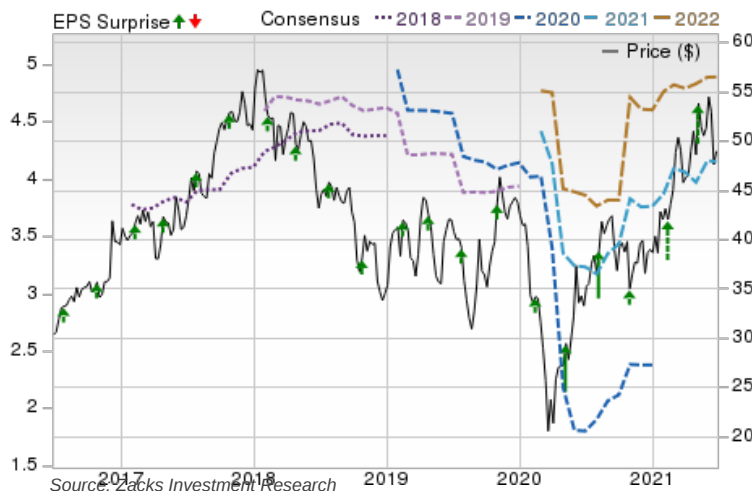

Summary

BorgWarner's buyout of Delphi Technologies has strengthened its electric propulsion leadership, with expanded capabilities and scale. Acquisition of AKASOL is set to further expand its commercial vehicle electrification capabilities. The company's new project Charging Forward is expected to deliver over 25% of its revenue from electric vehicles by 2025 and 45% by 2030. Upbeat 2021 guidance sparks optimism. However, high research and development costs are likely to limit the firm's margins in 2021. Also, while Delphi buyout boosts BorgWarner prospects, it has elevated the firm's debt levels. Also, on a pure standalone basis, the margin performance of Delphi is not likely to return to pre-COVID levels until 2022. Also, the global semiconductor supply shortage acts as a headwind. Thus, BorgWarner warrants a cautious stance.

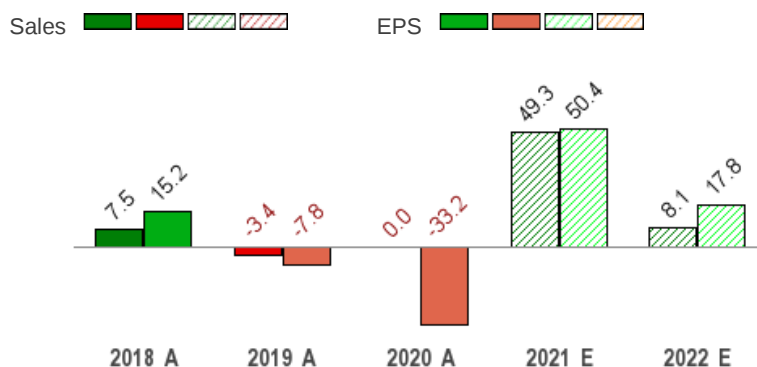
Price, Consensus & Surprise

Overview

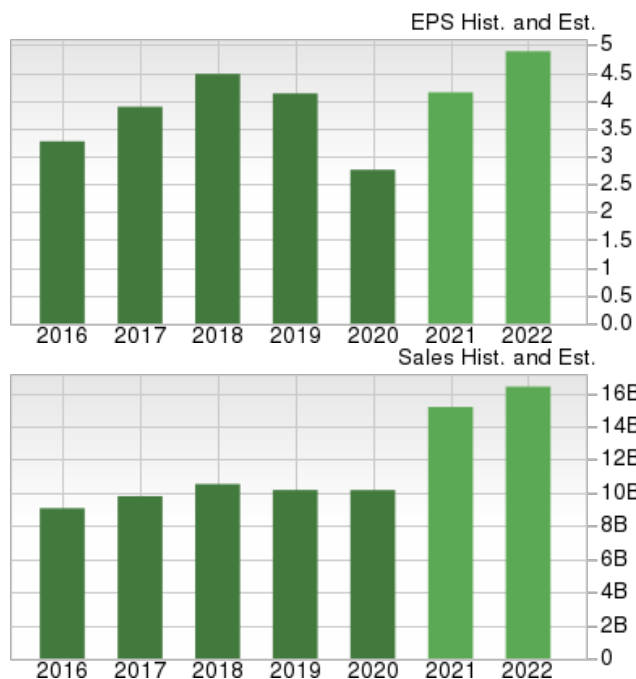
Michigan-based BorgWarner, Inc. is a global leader in clean and efficient technology solutions required for combustion, hybrid and electric vehicles. Its products include four-wheel-drive and all-wheel-drive transfer cases (primarily for light trucks and sport utility vehicles or SUVs), as well as automatic transmission and timing chain systems. These products are aimed at to improve vehicle performance, propulsion efficiency, stability and air quality. These products are produced and sold worldwide, primarily to OEMs of passenger cars, SUVs, trucks and commercial transportation products.

BorgWarner's largest customers include Volkswagen and Ford. The company operates manufacturing facilities catering to the customers in Europe, the Americas and Asia and is an original equipment supplier to every major automotive OEM in the world. The company's production and technical facilities are spread over 64 locations in 17 countries.

Post the acquisition of Delphi Technologies, BorgWarner reorganized its management reporting structure into four segments — Air Management, e-Propulsion & Drivetrain, Fuel Injection and Aftermarket. BorgWarner's Engine and Drivetrain segments have been integrated with the acquired business, and are now termed as Air Management and ePropulsion & Drivetrain, respectively. While Delphi's Powertrain Products segment has been consolidated into the Air Management unit, Electronics & Electrification segment has been integrated into the e-Propulsion & Drivetrain segment. Additionally, two new segments — namely Fuel Injection and Aftermarkets — have been formed as a result of the Delphi acquisition.

Products in the firm's Air Managemnt unit include turbochargers, chains as well as emission and thermal systems. The segment also produces fluid pumps, including engine hydraulic pumps for variable cam timing and engine lubrication.

Products in the firm's ePropulsion & Drivetrain unit include friction plates, one-way clutches, transmission bands, torque converters and lock-up clutches for automatic transmission. The segment also offers polymer fans for engine cooling systems and sells products to OEMs of commercial trucks, buses as well as agricultural and off-highway vehicles, primarily in North America, South America, Europe and Asia.

Reasons To Buy:

- ▲ BorgWarner's buyout of Delphi Technologies has strengthened its electric propulsion leadership, with expanded capabilities and scale. Along with boosting the company's prospects, the buyout will also lead to realization of operational and cost synergies. BorgWarner will achieve cost synergies of approximately \$125 million by 2023, with around \$70-\$80 million of incremental benefit in 2021. Acquisition of AKASOL is set to expand its commercial vehicle electrification capabilities. Also, BorgWarner's Integrated Drive Module (IDM) was recently selected by a major non-Chinese Asian original equipment manufacturer (OEM) for its upcoming global S segment electric vehicle (EV) production planned to start in mid-2023. This represents BorgWarner's first IDM win that combines both Delphi and BorgWarner technologies and bodes well for its future prospects.
- ▲ BorgWarner is likely to benefit from accelerating vehicle electrification and expects hybrid and electric technologies to be its major revenue drivers. From 2022 through 2024, net new backlog is expected to be at least \$2.8 billion, with around 45% of the backlog driven by e-products. The company's new project Charging Forward is expected to deliver over 25% of its revenue from EV by 2025 and approximately 45% by 2030. Project charging forward has three primary pillars: one, to profitably scale electric light vehicles (ELVs) through continued integration of Delphi and BorgWarner's ability to capture synergies, two, to expand more aggressively into electric commercial vehicles (ECVs), and three, to optimize the company's combustion portfolio by disposing non-performing parts of the portfolio. This project bodes well for the company's long-term growth.
- ▲ BorgWarner expects its blended light-vehicle and commercial vehicle markets to rise in the range of approximately 9-12% year over year in 2021. The firm expects production in Europe and North America to grow around 9-12% and 17-20% respectively, on a year-over-year basis. Upbeat guidance is set to fuel investors' confidence. For full-year 2021, the company anticipates net sales within \$14.8-\$15.4 billion, slightly up from the previous guidance of \$14.7-\$15.3 billion and indicating an increase from 2020 pro-forma combined sales of \$12.8 billion. Adjusted operating margin is forecast to be in the range of 10.1%-10.5% compared to a pro forma 2020 adjusted operating margin of 8.3%.
- ▲ The company fares well in the cash flow parameter. Despite coronavirus woes, BorgWarner's 2020 FCF totaled \$ 743 million, up from \$699 million recorded in 2019. Further, the metric is envisioned to lie between \$800 million and \$900 million in 2021. BorgWarner's investor friendly moves also boost investors' confidence. In 2020, the firm approved the implementation of a share-repurchase program of up to \$1 billion over the next three years.

BorgWarner's buyout of Delphi Technologies and upbeat 2021 guidance sparks optimism.

Reasons To Sell:

- ▼ Due to the ongoing impact of the global semiconductor shortage on industry production, BorgWarner expects global weighted light vehicle and commercial vehicle markets to increase in the range of 9%-12%, down from its previous assumption of an 11%-14% increase. Also, the company forecasts the largest incremental impact of the semiconductor shortage to be in North America where expectations are down approximately 500 basis points. Also, with the economy in unhealthy state and new Covid-19 strains prolonging infections, automotive components supplier, BorgWarner, is likely to feel the heat of the COVID-19 pandemic.
- ▼ While the company expects North American and European light vehicle and commercial markets to witness a year over year uptick in 2021, it anticipates the overall market in China to be roughly flat year-over-year, which is set to limit revenues. Precisely, BorgWarner expects growth in light vehicle production to be offset by declines in the commercial vehicle market.
- ▼ Indeed, Delphi Technologies is set to buoy long-term growth, the acquisition has also come with its fair share of headwinds. Firstly, on a pure standalone basis, the margin performance of Delphi is not likely to return to pre-COVID levels until 2022. Also, the buyout has elevated BorgWarner's debt levels. As of Mar 31, 2021, long-term debt was \$3,708 million, up from \$1,664 million recorded in the prior-year period.
- ▼ The automotive industry is undergoing a significant level of technology change, which will indeed create new opportunities for the firm but at the same time is likely to strain near term margins. The technology change will require BorgWarner to make substantial amounts of investment and capital spending in order to evolve its business profile towards new products. High research and development costs associated with electrification-related programs are likely to limit its margins in 2021.

Huge debt pile thanks to Delphi buyout and semiconductor supply shortage remain major headwinds.

Last Earnings Report

BorgWarner's Q1 Earnings & Sales Beat Estimates

BorgWarner reported adjusted earnings of \$1.21 per share in first-quarter 2021, beating the Zacks Consensus Estimate of 92 cents. Higher-than-anticipated contributions from the Air Management and e-Propulsion & Drivetrain segments resulted in this outperformance.

Moreover, the bottom line compares favorably with the year-ago quarter's profit of 77 cents per share.

This automotive equipment supplier reported net sales of \$4,009 million, outpacing the Zacks Consensus Estimate of \$3,587 million. Moreover, the top-line figure comes in a whopping 76% higher than the year-ago quarter's \$2,279 million.

Segmental Performance

Air Management: Net sales totaled \$2,011 million for the reported quarter compared with the \$1,434 million registered during the first quarter 2020. The sales figure also topped the Zacks Consensus Estimate of \$1,716 million. Excluding the impact of foreign-currency translations but including the estimated growth in Delphi Technologies-related revenues, sales from the segment went up 14% year over year. Adjusted EBIT of \$322 million compares favorably with the year-ago period's \$208 million. The reported EBIT also surpassed the consensus mark of \$233 million.

e-Propulsion & Drivetrain: Sales from the segment came in at \$1,466 million compared with the \$860 million seen during the first quarter 2020. The sales figure also exceeded the Zacks Consensus Estimate of \$1,209 million. Excluding the impact of foreign currency translations but including the estimated growth in Delphi Technologies-related revenues, sales from the segment climbed 36% year on year. The segment generated adjusted EBIT of \$137 million for first-quarter 2021, higher than the \$63 million recorded in the corresponding period of 2020, beating the consensus mark of \$111 million.

Fuel Injection: Sales and adjusted EBIT from the segment totaled \$475 million and \$33 million, respectively. The sales figure topped the Zacks Consensus Estimate of \$461 million. Adjusted EBIT margin for the quarter was 6.9%.

Aftermarket: Sales and adjusted EBIT from the segment totaled \$197 million and \$21 million, respectively. The sales figure missed the Zacks Consensus Estimate of \$209 million. Adjusted EBIT margin for the quarter came in at 10.7%.

Financial Position

As of Mar 31, 2021, BorgWarner had \$1,755 million in cash compared with \$901 million as of Mar 31, 2020. In the March-end quarter, long-term debt was \$3,708 million, up from the \$1,664 million recorded in the prior-year period.

Net cash provided by operating activities was \$342 million during the first quarter compared with the \$263 million witnessed in the year-ago period. Investment in capital expenditure, including tooling outlays, was \$195 million in the March-end quarter compared with the year-ago quarter's \$117 million.

Outlook

For full-year 2021, the company anticipates net sales within \$14.8-\$15.4 billion, slightly up from the previous guidance of \$14.7-\$15.3 billion. Adjusted operating margin and net earnings are expected in the band of 10.1-10.5% and \$3.42-\$3.92 per share, respectively, higher than the earlier guidance of 10-10.5% and \$3.23-\$3.77 per share, respectively. Free cash flow is projected between \$800 million and \$900 million.

Recent News

BorgWarner Boosts Electrification Portfolio on AKASOL Takeover

On **Jun 5**, BorgWarner announced the completion of the tender offer for shares of AKASOL AG, making the company the owner of 89.08% of AKASOL's outstanding shares. It is projected that AKASOL will be integrated into BorgWarner's Air Management reporting segment. The company has paid roughly 648 million euros to settle the arrangement, with the purchase price being 120 euro per tendered AKASOL share. The acquisition enhanced BorgWarner's commercial vehicle and industrial electrification portfolio, enabling the company to capitalize on the evolving battery pack market.

Valuation

BorgWarner's shares are up 25.2% and 37% year to date and in the trailing 12-month period, respectively. Year to date, stocks in the Zacks Automotive - Original Equipment industry and the Zacks Auto sector are down 12.4% and up 4.9%, respectively. Over the past year, the Zacks sub industry and sector are up 17.4% and 77.9%, respectively. The S&P 500 index is up 15% and 39.9% year to date and in the past year, respectively.

The stock is currently trading at 10.71X forward 12-month earnings, which compares to 19.4X for the Zacks sub-industry, 21.95X for the Zacks sector and 21.85X for the S&P 500 index.

Over the past five years, the stock has traded as high as 15.62X and as low as 4.86X, with a 5-year median of 10.69X. Our Neutral recommendation indicates that the stock will perform in line with the market. Our \$51 price target reflects 11.3X forward 12-month earnings per share.

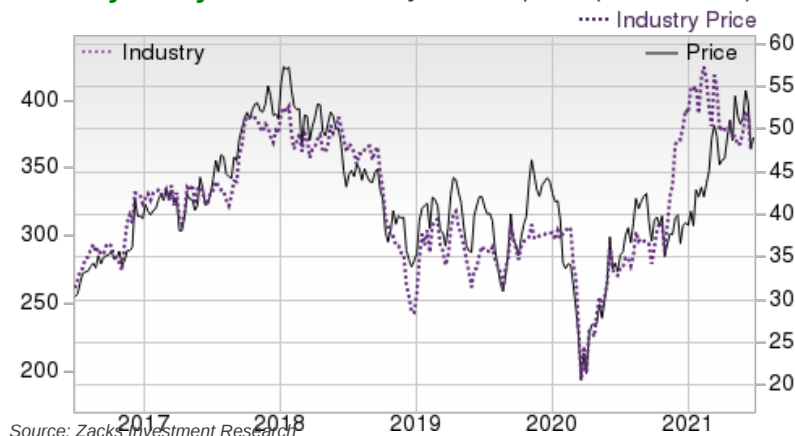

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is

proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-

term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital

intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
