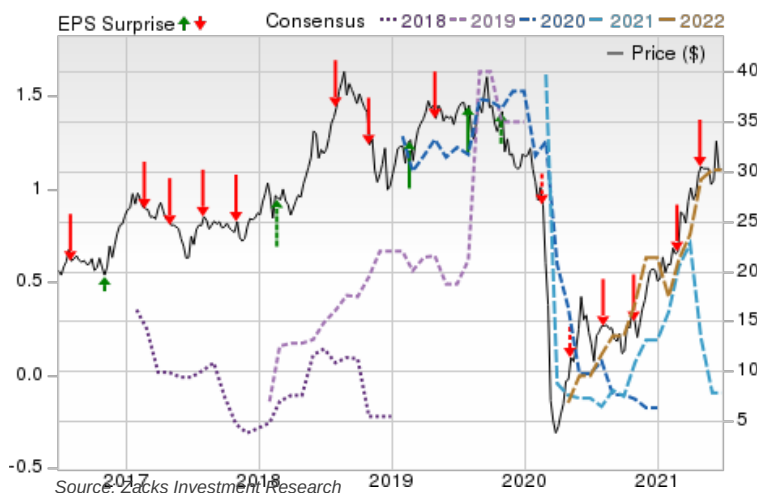

Summary

Crestwood's extensive network of pipelines is utilized for natural gas gathering and processing, which will be substantially employed as the drive toward low-emission energy deepens. Moreover, its daily 150,000 barrels of crude gathering capacity will help the partnership generate incremental cash flows. Its presence in major U.S. shale plays like the Bakken Shale, Delaware Basin, Powder River Basin, Marcellus Shale and others are promising. Notably, the partnership estimates 2021 free cash flow after paying distributions within \$130-\$180 million. However, Crestwood's huge debt burden can affect financial flexibility. Moreover, decreased COLT Hub rail loading volumes are affecting Crestwood's bottom line. Also, lower gathering, processing and compression volumes are affecting profit levels. As such, the stock warrants a cautious stance.

Overview

Headquartered in Houston, TX, Crestwood is a master limited partnership (MLP) engaged in providing a wide range of fee-based infrastructure solutions in major U.S. shale plays like the Bakken Shale, Delaware Basin, Powder River Basin, Marcellus Shale and others. The partnership was formed in 2001.

Crestwood creates long-term value for unitholders through natural gas gathering, processing, compression, storage, transportation and other businesses. Moreover, it provides terminalling and marketing for crude oil. Also, it deals with natural gas liquids and gathering and disposing of produced water. Management has significantly reduced the 2021 estimated capital budget from 2020 levels to boost efficiency and free cash flow.

The partnership operates through three segments — Gathering and Processing, Storage and Transportation, and Marketing, Supply and Logistics.

Gathering and Processing: This segment generated 28% of overall revenues in 2020. The business provides services like gathering, processing, treatment and compression in Bakken, Powder River, Marcellus, Barnett and Delaware Basin. It has seven processing plants in several states like North Dakota, Wyoming, Texas and New Mexico. The segment has 2.9 billion cubic feet of natural gas per day (Bcf/d) of gathering and 1.2 Bcf/d of processing capacity.

Storage and Transportation: The unit contributed 0.6% of total revenues last year. It incorporates the COLT Hub, a massive crude-by-rail terminal that connects with Bakken. It also has a storage capacity of 76 Bcf of natural gas, 1.6 million barrels (MMBbls) of crude oil and 1.6 MMBbls of NGLs. Furthermore, it has 180 MBbls/d of rail loading capacity. Its 1.8 Bcf/d gas transportation capacity generates stable revenues.

Marketing, Supply and Logistics: It generated 70.1% of total revenues. This segment includes crude, gas and NGLs marketing and logistics operations. The partnership employs its truck and rail fleet along with the storage, processing, terminalling facilities to create an integrated supply solution for producers, refining businesses, and others. It has 10 MMBbls of NGLs storage along with a 1.6 MMBbls/d NGL pipeline and transportation capacity.



Reasons To Buy:

- ▲ Crestwood is least exposed to commodity price fluctuations since the partnership generates stable fee-based revenues from diverse midstream energy assets via long-term contracts. It has an extensive network of pipelines that spreads across 1,948 miles, which is used for gathering and processing purposes. Importantly, its 2.9 Bcf/d of gathering and 1.2 Bcf/d of processing capacity will be extensively used as the drive toward low-emission energy deepens. Moreover, its 150 thousand barrels of crude oil per day (MMbbls/d) gathering capacity will help the partnership generate incremental cash flows. Of the 2021 estimated cash flow, 72% is expected to come from gathering and processing activities.
- ▲ Markedly, the partnership estimates free cash flow after paying distributions within \$130-\$180 million. This amount will be used for reducing the debt burden. Crestwood expects to generate 58% of cash flow from natural gas-related activities, while crude oil and natural gas liquids (NGLs) will yield 22% and 20%, respectively. The firm favorably renegotiated its midstream contracts as the overall energy environment outlook is encouraging.
- ▲ The partnership's massive storage capacity of 76 Bcf of natural gas, 1.6 million barrels (MMBbls) of crude oil and 1.6 MMBbls of NGLs are appreciable as U.S. upstream activities are expected to increase. Its footprint in Barnett Shale, Bakken Shale, Delaware Basin, Marcellus Shale and other regions will ensure high utilization of the storage capacity. Importantly, the storage and transportation business is expected to significantly boost overall 2021 adjusted EBITDA to the \$575-\$625 million level, the mid-point of which is greater than the 2020 figure of \$580.3 million.
- ▲ With encouraging energy and economic outlook, the partnership has allotted \$35-\$45 million capital for growth purposes. The majority of the capital will be allotted to the Arrow crude, natural gas and water gathering systems. Moreover, Delaware and Powder River Basins will receive significant capital spending. Notably, it expects maintenance capital in the range of \$20-\$25 million for 2021 to keep asset integrity intact. Furthermore, the Board of Directors authorized a \$175 million common and preferred units buyback program, through Dec 31, 2022.

Crestwood's massive storage capacity and diversified portfolio of infrastructure assets are commendable.

Reasons To Sell:

- ▼ As of Mar 31, 2021, the partnership had only \$16.3 million in cash and total debt of \$2,588.4 million. It had long-term debt to capitalization of 60.3%, significantly higher than the industry average. The huge debt burden can affect its financial flexibility. Notably, interest expense for 2021 is expected to rise to \$135-\$140 million from the 2020 level of \$129.9 million.
- ▼ The partnership recently boosted the guidance for 2021 distributable cash flow available for common unitholders to the range of \$335-\$385 million, the midpoint of which is still below the 2020 realized level of \$361.2 million. While the overall energy environment in the United States is expected to significantly recover this year, Crestwood generating low distributable cash flow can be concerning.
- ▼ Through 2020, the partnership's operating expenses significantly jumped affecting its bottom line. The metric rose to \$567 million from the year-ago level of \$234.8 million. Even though the metric decreased year over year in the first-quarter, rising activities in U.S. shale plays are expected to further increase operating expenses putting pressure on profits.
- ▼ Crestwood's cash generation from operations declined to \$408.1 million in 2020 from the year-ago level of \$420.4 million. It is to be seen whether the predicted economic recovery from the pandemic ultimately boosts operating cash flow in the coming days. Otherwise, lower cash-generating abilities can indicate weakness in the partnership's operations.

The partnership's huge debt burden is concerning.

Last Earnings Report

Crestwood Misses Q1 Earnings Estimates, Revenues Beat

Crestwood reported first-quarter 2021 adjusted loss per unit of 86 cents versus the Zacks Consensus Estimate of earnings of 37 cents. The bottom line also deteriorated from the year-ago loss of 66 cents per unit.

However, revenues surged to \$1,032.7 million from \$727.9 million in the prior-year quarter. Moreover, the top line beat the consensus mark of \$956 million.

The weak first-quarter earnings were caused by lower gathering, processing and compression volumes. Moreover, decreased COLT Hub rail loading volumes added to the negatives. The negatives were partially offset by increased natural gas liquids (NGL) volumes sold or processed.

Segmental Performance

Gathering and Processing: The segment generated earnings before interest, taxes, depreciation and amortization (EBITDA) of \$119.5 million, up from \$39.1 million in the year-ago quarter. Operating and maintenance expenses decreased to \$21.4 million from the year-ago level of \$27 million.

Total gas gathering volumes for the quarter were 833.4 million cubic feet per day (MMcf/d), down from 1,029.6 MMcf/d a year ago. Gathering volumes declined in Marcellus, Barnett, Delaware and Powder River Basin. Total processing volumes decreased to 357 MMcf/d from the year-ago level of 408.3 MMcf/d. Moreover, compression volumes declined to 278.3 MMcf/d from 377.1 MMcf/d in the year-ago period.

Storage and Transportation: The unit generated operating loss of \$99.5 million against profit of \$9.2 million in the year-ago quarter. Operating and maintenance expenses decreased to \$0.6 million from the year-ago level of \$1.4 million.

Interruptible services in the Gulf Coast storage declined to 49.9 MMcf/d from 76.3 MMcf/d in the prior-year quarter. Also, rail loading at the COLT hub declined to 51.5 thousand barrels per day (MBbls/d) from 61 MBbls/d a year ago.

Marketing, Supply and Logistics: It generated EBITDA of \$61 million, up from \$31.8 million in the year-ago quarter. Operating and maintenance expenses increased to \$10.8 million from the year-ago level of \$9.2 million.

NGL volumes sold or processed in the first quarter came in at 151.5 MBbls/d, up from 105.8 MBbls/d in the year-ago period.

Expenses

Total operating expenses and others decreased to \$112.1 million from \$189.9 million in the year-ago period.

Operations and maintenance costs decreased to \$32.8 million from \$37.6 million a year ago. General and administrative expenses, however, rose to \$18.7 million for the March quarter from \$14.9 million in first-quarter 2020.

Cash Flow

Distributable cash flow for the first quarter was recorded at \$108.4 million, up from \$94 million in the year-ago period.

Free cash flow after distributions was recorded at \$63.6 million for the March quarter versus an outflow of \$28.7 million in the year-ago period.

Balance Sheet

As of Mar 31, 2021, the partnership had \$16.3 million in cash, up from \$14 million at fourth quarter-end. Total debt of \$2,588.4 million at first quarter-end increased from \$2,484 million at fourth quarter-end. The partnership has a long-term debt to capitalization of 60.3%.

Guidance

Following several strategic transactions in the first quarter, the partnership revised 2021 adjusted EBITDA expectation to the \$575-\$625 million range, higher than the previous guidance of \$550-\$610 million. Net income is now expected within \$100-\$150 million. Markedly, the partnership now estimates free cash flow after paying distributions within \$130-\$180 million, higher than the previous projection of \$90-\$160 million. Furthermore, the board of directors authorized a \$175-million common and preferred unit buyback program through Dec 31, 2022.

Recent News

Crestwood Keeps Distribution Intact for First Quarter – Apr 15, 2021

Crestwood Equity Partners announced first-quarter distribution payments. It has also scheduled first-quarter earnings release on Apr 27, before the market opens.

The partnership has kept first-quarter cash distribution payment unchanged at 62.50 cents per limited partner unit from the fourth-quarter 2020 level amid the current market volatility, while some companies — including Antero Midstream — have opted for dividend cuts and halts. The primary reason behind the move is that Crestwood is least exposed to commodity price fluctuations since the partnership generates stable fee-based revenues from diverse midstream energy assets via long-term contracts.

Its new annualized distribution amounted to \$2.50 per limited partner unit. Based on the closing price of \$27.91 per unit on Apr 15, the stock has a distribution yield of almost 9%. Moreover, it announced a Class A preferred equity unit cash distribution of 21.11 cents. Both the distributions are expected to be paid on May 14 to Crestwood's unitholders of record as of May 7.

Markedly, Crestwood announced several strategic transactions last month. Taking these into account, it estimates free cash flow after paying distributions within \$130-\$180 million, higher than the previous projection of \$90-\$160 million. This amount will likely be used for reducing the debt burden.

Valuation

Crestwood units are up 59.1% in the year-to-date period and 134% over the trailing 12-month period. Stocks in the Zacks sub-industry and the Zacks Oil-Energy sector are up 35.3% and 26.2%, in the year-to-date period, respectively. Over the past year, the Zacks sub-industry and sector are up 19.8% and 28.3%, respectively.

The S&P 500 index is up 14.8% in the year-to-date period and 42.4% in the past year.

The stock is currently trading at 0.55X forward 12-month sales, which compares to 0.82X for the Zacks sub-industry, 0.89X for the Zacks sector and 4.70X for the S&P 500 index.

Over the past five years, the stock has traded as high as 0.80X and as low as 0.08X, with a 5-year median of 0.57X. Our Neutral recommendation indicates that the stock will perform in-line with the market. Our \$32.00 price target reflects 0.58X F12M sales.

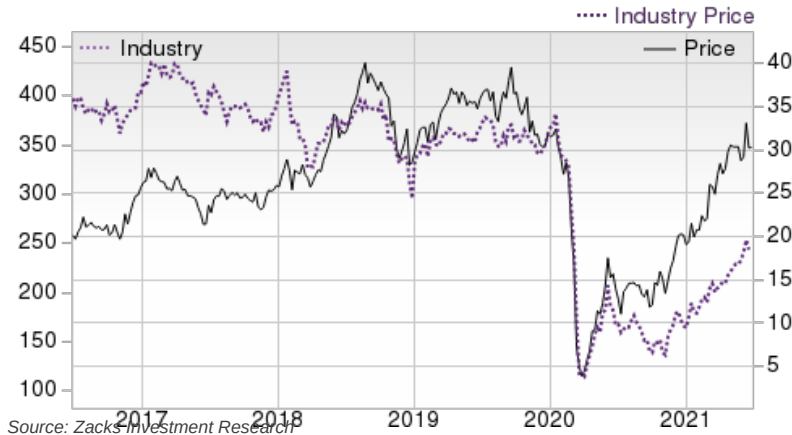

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is

proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-

term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital

intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
