Summary

Mack Cali disposed of interest in two residential properties and refinanced another earlier this month. The sale of two of the company's oldest properties enhances the portfolio's average revenue per home. However, its multifamily portfolio continues to witness a decline in leasing traffic and occupancy. This along with no near-term EBITDA benefit from development efforts limits the company's growth momentum. Also, Mack-Cali is making portfolio-repositioning efforts through non-core suburban office asset sales and is using proceeds for debt repayment. While such efforts will enhance its high-leveraged balance sheet, the earnings dilution from such sales cannot be avoided. Also, amid the pandemic, muted demand for office space is likely to affect leasing activity. Its shares have underperformed its industry in the past year.

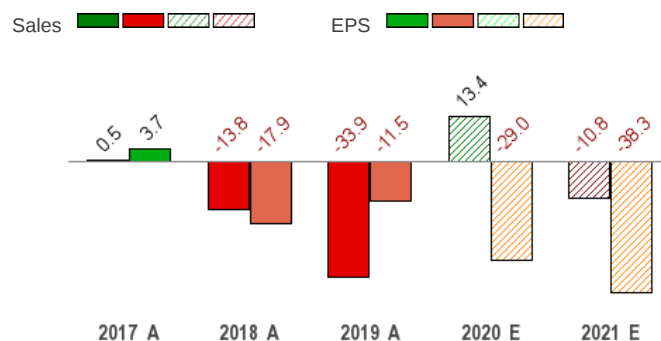

Overview

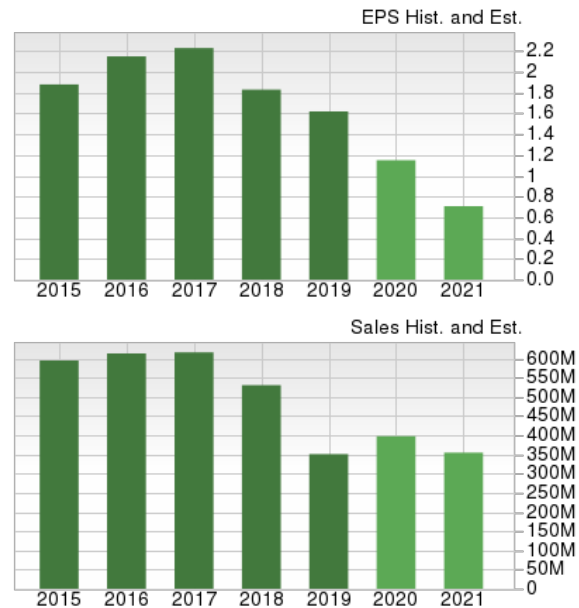
The Jersey City, NJ-based real estate investment trust (REIT) — Mack-Cali Realty Corporation — is engaged in providing management, leasing, development and other tenant-related services for office and multi-family real estate assets. Specifically, the company has dual platform operations of waterfront and transit-based office as well as luxury multi-family properties.

Operating in the Northeast United States for more than 60 years, Mack-Cali owned or had interests in 59 properties as of Sep 30, 2020. These properties include 29 office properties spanning 8.7 million square feet of space. The properties are leased to around 225 commercial tenants.

The company also has 22 multi-family assets, including 6,850 apartment units, four parking/retail properties, and three hotels and a land parcel leased to a third party. These properties are located in four states in the Northeast, and the District of Columbia.

Notably, the company operates multi-family residential real estate operations through its subsidiary Roseland Residential Trust.

As of Sep 30, 2020, Mack-Cali's consolidated core office properties were 78.2% leased. Further, the Class A suburban portfolio was leased 89%, while Suburban and Waterfront portfolios were leased 70% and 76.9%, respectively, as of the same date.

Reasons To Sell:

- ▼ The coronavirus pandemic and measures to curb its spread are leading to uncertainties and risk to the company. The adverse impact on financial condition of tenants is likely to affect rent collections in the near term. Moreover, demand for office space is likely to remain limited in the upcoming period, affecting leasing volumes. Also, costs associated with construction and delivery delays at the company's development and redevelopment projects amid this environment add to its woes.
- ▼ As part of a strategic shift in its operations, in December 2019, the company announced its plan to sell the entire suburban New Jersey office portfolio, spanning 6.6 million square feet. It intends to use sales proceeds to repay corporate-level, unsecured debt. Since late December 2019 through third-quarter 2020 end, Mack-Cali disposed of 16 of such suburban office properties, aggregating 2.6 million square feet, for net sales proceeds of \$294.8 million. As of the third-quarter end, the company had 21 office properties remaining in the Suburban Office Portfolio, totaling 4 million square feet. In November 2020, it announced the disposition of 7 Campus Drive, an office building situated in Parsippany, NJ, for \$12.75 million. Further, in December 2020, the company sold 581 Main Street in Woodbridge Township, NJ, for \$61 million. The sale of its remaining Suburban Office Portfolio properties is expected to close in early 2021. Although such non-core asset dispositions are a strategic fit for the long run, the dilutive impact on earnings in the near term cannot be bypassed.
- ▼ In addition, as part of its long-term strategy, Mack-Cali continues to pursue multi-family residential investment in development projects. While this strategy will enable the company to capitalize on value creation and is encouraging from the long-term perspective, it involves significant capital investments. Moreover, this multifamily portfolio continues to witness a decline in leasing traffic and occupancy due to the coronavirus pandemic. Hence, with no near-term EBITDA benefit and the pandemic-borne occupancy pressures, the move limits the company's growth momentum in the near term.
- ▼ Mack-Cali has a high financial leverage. Particularly, net debt to adjusted EBITDA for third-quarter 2020 was 12.1X, up from 11.4X for the prior-year quarter. Further, total debt/total market capitalization ratio has been deteriorating over the past three quarters. Additionally, in the past years, the company's senior unsecured debt current ratings have been downgraded to B1 and BB- by Moody's and S&P, respectively. Such downgrades increase the interest rate on outstanding borrowings under its current \$600-million unsecured revolving credit facility.
- ▼ Also, the company has a concentration of assets in the Northeastern market. This raises its risks because any adverse economic and geo-political situations in the region can produce a significant negative impact on its operations and financial condition.
- ▼ Shares of the company have depreciated 43.8% compared with the industry's decline of 7.6% over the past year. Further, the trend in estimate revisions for 2021 FFO per share does not indicate a favorable outlook for the company as it has been unrevised over the past month. Therefore, given the above-mentioned concerns and lack of positive estimate revisions, the stock is unlikely to perform well in the near term.

A disrupted rent-collection environment, high financial leverage and apprehensions associated with closing of planned dispositions on expected terms or timelines are pressing concerns for Mack-Cali.

Risks

- Mack-Cali, with around 225 commercial tenants from diverse industries, enjoys a dominant presence in high barrier-to-entry markets in the United States, especially in the Northeast region. A diversified tenant base helps the company enjoy a steady revenue stream and avoid shortcomings related to any particular sector. In fact, as of the third-quarter end, office portfolio collections were 96.9% and residential receipts were 99.5%. Moreover, as of Nov 7, 2020, the company collected 96.5% of office rents and 99.5% of multifamily rents for October.
 - Mack-Cali has made concerted efforts in recent years to transform from a sub-urban office REIT to a residential and geographically-focused office REIT. The company's transformational plan entailed emphasis on New Jersey Hudson River waterfront and transit-oriented office properties as well as a regional owner of luxury multi-family residential properties. The company's Harborside portfolio-repositioning strategy is focused on capturing the attention of people who prefer to live, work and play in the same area — a trend that drove development in several other cities in the United States. This group also gives much importance to transit options, and hence focusing on such areas remains a strategic choice for the company. Hence, the company's Harborside Class A office campus on the waterfront in Jersey City, spanning more than 4.3 million square feet, is likely to witness strong demand for space, given its strategic location and diverse offerings.
 - Much of the leasing proportion shifted from new to renewal-oriented deals due to the pandemic. During the third quarter, Mack-Cali executed 10 lease deals, spanning 153,827 square feet, in the company's core office portfolio. All these leases were renewals and other tenant-retention transactions. Going forward, the next cycle of office-space demand will likely be driven by de-densification to allow higher square footage per office worker and the need for better-amenitized office properties to focus on health & wellness amid social-distancing requirements. Hence, with significant presence in the high barrier-to-entry Hudson River waterfront region and the growing demand for business districts outside Manhattan, Mack-Cali is well-positioned to benefit from the emerging trend.
 - Mack-Cali's focus on multi-family assets is a strategic fit. This asset class is comparatively stable and is likely to contribute more toward the company's cash flows in the upcoming period. In fact, its \$1-billion waterfront residential development pipeline is well-positioned to deliver 1,942 residential units over the next two years, with no remaining equity funding. This enhances growth prospects for the company. Although new leasing activity is likely to remain choppy amid the current environment, high renewal activities and tenant retention are likely to support the performance of this asset category in the meantime.
 - Mack-Cali enjoys debt-free ownership for the part of its portfolio. As of Sep 30, 2020, the company had 22 unencumbered properties, with a carrying value of \$1.3 billion. This denoted 46.8% of the company's total consolidated property count.

Last Earnings Report

Mack-Cali Q3 FFO Surpasses, Revenues Miss Estimates

Mack-Cali's third-quarter 2020 core FFO per share of 30 cents outpaced the Zacks Consensus Estimate of 29 cents. However, the figure compares unfavorably with the year-ago quarter's 38 cents.

Results reflect increase in same-store cash net operating income (NOI) for the office portfolio. However, leasing activity shrunk in the company's office and multi-family portfolios. Moreover, same-store NOI decreased year over year in the multi-family portfolio.

Quarterly revenues of \$77.7 million missed the Zacks Consensus Estimate of \$118.3 million. The revenue figure also comes in 11.1% lower than the prior-year quarter's \$87.4 million.

During the third quarter, the company collected office rents of 96.9% and residential rents of 99.5%.

Quarter in Detail

As of Sep 30, 2020, Mack-Cali's consolidated core office properties were 78.2% leased, reflecting a decrease from 80.3% as of Jun 30, 2020. Notably, the Class A suburban portfolio was leased 89%, while Suburban and Waterfront portfolios were leased 70% and 76.9%, respectively, as of the same date.

Same-store cash revenues for the office portfolio climbed 8.4% and the same-store cash NOI was up 15.4%, year over year.

During the reported quarter, Mack-Cali executed 10 lease deals, spanning 153,827 square feet, in the company's core office portfolio. All these leases were lease renewals and other tenant-retention transactions.

In addition, for the core portfolio, the rental rate roll up for third-quarter 2020 transactions was 12.3% on a cash basis.

Further, Roseland, the company's subsidiary engaged in multi-family residential operations, reported that its overall operating portfolio was 89.5% leased at the end of the quarter, contracting 310 basis points (bps) from the prior quarter's end. The same-store multi-family portfolio, which comprised 4,838 units, witnessed a same-store NOI decline of 17.4% from the prior-year quarter.

Portfolio Activity

During the third quarter, the company concluded the Phase 1 sale of its Parsippany and Giralda Farms portfolio for a total price of \$167.6 million. The portfolio comprises 11 office buildings and spans an area of 1.6 million square feet. Also, the company completed the sale of 9 Campus Drive, the first asset of its Phase 2 sales tranche in the same portfolio for \$21 million. The office property spans an area of 156,495 square feet.

Additionally, the company completed the sale of 325 Columbia Turnpike for \$25.8 million. The office property is located in Florham Park, NJ, and spans an area of 168,144 square foot.

Balance Sheet Position

The company exited third-quarter 2020 with \$22.9 million in cash, down from \$25.6 million as of Dec 31, 2019.

Mack-Cali's net debt to adjusted EBITDA was 12.1X for the reported quarter compared with the prior-year quarter's 11.4X.

Dividend Update

On Sep 30, the company announced the suspension of its dividend payments for the third and fourth quarters of 2020. The move has been taken to support its financial flexibility amid the uncertainties due to the pandemic.

Notably, the dividend suspension will enhance Mack-Cali's financial flexibility during the pandemic. It will also help preserve the incremental capital required to support leasing initiatives at the company's Harborside commercial office properties on the Jersey City waterfront.

Since Mack-Cali has satisfied the dividend obligation on taxable income expected for 2020, the move does not affect the company's REIT status.

Recent News

Mack-Cali Sells Two Residential Assets, Refinances Another – Jan 6, 2021

Mack-Cali announced multiple transactions across its residential portfolio. These include the sale of interest in two properties and the refinance of another.

Specifically, the company sold its joint-venture stake in Crystal House Apartments for \$377 million. The property in Arlington, VA, is situated in the vicinity of Amazon's proposed HQ2. The 825-unit operating property was sold for \$337 million, while the land held for future development was sold for \$40 million.

Further, the company disposed of Riverwatch Commons for \$47 million. The asset consisted of 200 residential units across New Brunswick, NJ, 5 Dennis Street, 10 Dennis Street, and 100 Hiram Square. These properties are strategically located near Rutgers University and Robert Wood Johnson University Hospital.

Ultimately, with the two properties being the oldest ones in the company's portfolio, the disposal reduces the average age of the company's assets to seven years and enhances the portfolio's average revenue per home to more than \$3,100.

The dispositions aside, Mack-Cali has also taken out a construction refinance loan for The Emery at Overlook Ridge in Malden, MA. Specifically, it refinanced the existing \$60-million construction loan with a \$72-million mortgage from New York Community Bank.

Per management, "securing permanent financing of The Emery, a building that has nearly stabilized since its 1Q 2020 opening, provides the company with excess financing proceeds."

The property comprises 326 luxury rental apartment units across three elevator-serviced, five-storied buildings. Apartment unit format consists of a mix of studio, one- and two-bedroom units, with varied sizes, spanning from 529 square feet of space for studios to 1,342 square feet of space for larger two-bedroom units.

Notably, despite the pandemic-borne challenges, the property is witnessing strong demand since leasing activities commenced last February. In fact, it is currently 93% leased. Also, these efforts are in line with its focus on becoming a regional owner of waterfront luxury multi-family residential properties.

Mack-Cali Continues Suburban Office Asset Disposition – Dec 3, 2020

Mack-Cali announced the disposition of 581 Main Street in Woodbridge Township, NJ. The office building spans an area of 203,335 square feet of space. The building was purchased by 581 Main Street, LLC, a subsidiary of the Plymouth Rock Group of Companies for \$61 million.

Mack-Cali's YTD Suburban Office Disposals Reach \$270.35M – Nov 23, 2020

Mack-Cali is making solid strides with its suburban New Jersey office portfolio sale. The company announced the disposition of 7 Campus Drive, an office building situated in Parsippany, NJ, to Birch Group for \$12.75 million.

The office building spans 154,820 square feet of space and the sale brings the company's year-to-date suburban office dispositions to \$270.35 million.

Mack-Cali Terminates Dividend Distribution for 2H20 – Sep 30, 2020

Mack-Cali announced the suspension of common dividend distribution for the third and fourth quarters of 2020 in efforts to strengthen its balance sheet. Moreover, the company used total proceeds of \$213.3 million from the sale of sub-urban office assets to repay the outstanding balance on its corporate line of credit.

Notably, the suspension of dividend will enhance Mack-Cali's financial flexibility during the pandemic. It will also help preserve incremental capital that will be needed to support leasing initiatives at the company's Harborside campus on the Jersey City waterfront.

Since Mack-Cali has satisfied the dividend obligation on taxable income expected for 2020, the move does not affect the company's REIT status. Nonetheless, its board will likely reconsider the resumption of the quarterly dividend in first-quarter 2021.

Notably, on Jul 1, Mack-Cali announced second-quarter cash dividend of 20 cents per share on its common stock. This dividend was paid on Jul 24, to shareholders of record as of Jul 31, 2020.

Valuation

Mack-Cali's shares have been down 43.8% in the trailing 12 months. Stocks in the Zacks sub-industry have declined 7.6%, while the Zacks

Finance sector has gained 0.7%, over the past year.

The S&P 500 Index is up 14.9% in the past year.

The stock is currently trading at 18.55X forward 12-month FFO, which compares to 19.13X for the Zacks sub-industry, 17.20X for the Zacks sector and 22.86X for the S&P 500 Index.

Over the past five years, the stock has traded as high as 18.55X and as low as 7.95X, with a 5-year median of 11.97X. Our Underperform recommendation indicates that the stock will perform worse than the market. Our \$11 price target reflects 15.40X FFO.

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
