Summary

Canadian Solar's products and services witnessed some negative impacts of the coronavirus pandemic during the third quarter. Interestingly, courtesy of the coronavirus outbreak, the company has been witnessing significant logistic costs, mostly shipping expenses. This might weigh on its earnings performance in the coming days. Moreover, some projects are expected to move into the next year, which will hurt its operational results for 2020. Its shares underperformed the industry in the past year. Drastic solar subsidy cut decided by the Chinese government may also hurt the stock's prospects. Escalated trade dispute between China and the United States in the recent past may also impact this stock's international operations. Yet, it has one of the world's largest utility-scale solar project development platforms

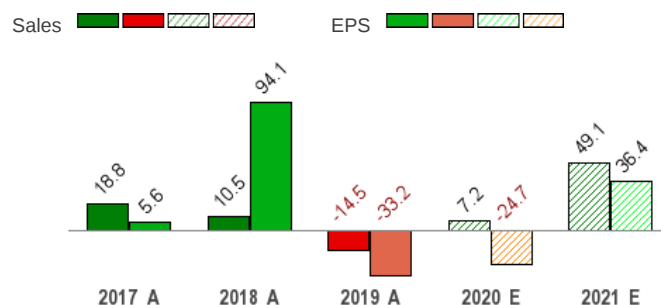

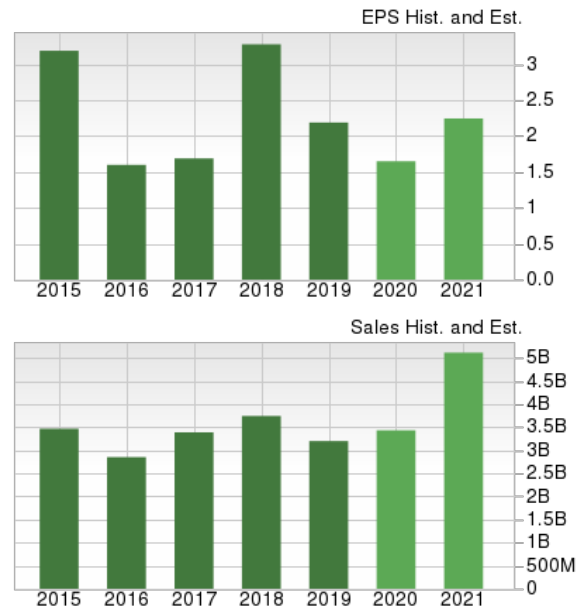

Overview

Ontario, Canada-based Canadian Solar Inc. (CSIQ) is a vertically integrated manufacturer of silicon ingots, wafers, cells, solar modules (panels) and custom-designed solar power applications. The company designs, manufactures and delivers solar products and solar system solutions for both on-grid and off-grid use to customers worldwide. The company was incorporated in Canada in 2001. Subsequently, in Nov 2006, the company came out with its maiden public offering.

Canadian Solar's production facilities in Canada, China, Indonesia, Vietnam and Brazil are structured for the manufacturing of ingots, wafers, solar cells, solar PV modules, solar power systems and specialized solar products. A huge number of the company's manufacturing facilities are located in Canada and China. The company's products include a range of solar modules built to general specifications for use in a wide range of residential, commercial and industrial solar power generation systems. Specialty solar products consist of customized solar modules that its customers incorporate into their own products and complete specialty products, such as portable solar home systems.

Canadian Solar operates through eight wholly-owned manufacturing subsidiaries. The company sells its products to customers worldwide, with operations spread across Australia, Brazil, China, Germany, Japan, South Korea, South Africa, Spain, Singapore, Turkey, the United Arab Emirates and the United States. The company has active solar projects in the states of California, North Carolina and Massachusetts. The company also implements solar power development projects, primarily in conjunction with government organizations, to provide solar power generation in rural areas of China. Over the past 19 years, Canadian Solar has successfully delivered over 43 GW of premium quality modules to customers in over 150 countries around the world

Reasons To Sell:

- ▼ In November 2019, it was announced that China will cut its renewable power subsidy to \$806.50 million in 2020, down approximately 42% from 2019's subsidy. In particular, subsidies for solar will be reduced by 12.3%. While the Chinese government justified the subsidy cut down by pointing out that the cost of generation has been declining over the years for solar and wind, analysts across the globe expressed their skepticism regarding the latest policy changes through reduction in expectations for the nation's solar projects. To this end, Bloomberg expected China's annual installed capacity for solar to plunge from 41GW in 2018 to just 25GW in 2019 due to the steep subsidy cuts to large-scale solar projects.

Unfavorable policy makeover by the Chinese government and COVID-19's impact on the stock remains cause of concern

However, in reality this anticipated decline was somewhat mitigated considering the fact that the actual solar PV capacity of the nation at the end of 2019 was 31 GW. Still it reflected a decline of 24.4%. This policy change is anticipated to be detrimental for international solar stocks like Canadian Solar as it has increased commitments to ship modules and construct new projects in China.

- ▼ Although Canadian Solar's products and services witnessed limited impact of the coronavirus pandemic till the second quarter, the company did witness some impacts in the third quarter. During the September-end quarter, the company incurred significant logistic costs, mostly shipping expenses. This might weigh on its earnings performance in the coming days. From the viewpoint of the company's energy business, the exact timing and recognition of certain project sales remain uncertain. In terms of volume, the company expects to recognize a large part of this year's project sales in the fourth quarter, with some projects potentially moving into the next year, mainly due to delays and impact of the pandemic. Moreover, the impact of COVID-19 led to a weak market earlier this year, which was then followed by a massive surge in demand. This created an acute but temporary shortage of all basic materials, including aluminum, copper, glass. This might hamper the production activity of the company in the near future.

Since the duration and severity of the coronavirus outbreak still remain unclear, analysts anticipate global demand for solar equipment to decline for the first time in 20 years in 2020. This comes as a disappointing news for module manufacturers like Canadian Solar. Supply side capacity is expected to grow, which will lead to additional average selling price pressure, which in turn might impact this stock's operating results. This might have hurt investors' confidence for this stock. Evidently, shares of the company have gained 143.1%, underperforming the industry's 250.5% growth, in the past year.

- ▼ The decision of the former U.S. President Donald Trump to impose punitive tariffs on goods imported from China have been weighing heavily on prominent solar players like Canadian Solar. Both China and the United States have been engaged in a trade dispute for over a year, imposing duties on billions of dollars' worth of goods from one another. Tensions, however, escalated after the Trump administration implemented 10% tariffs on \$300 billion worth of Chinese imports starting Sep 1, 2019. If trade tensions continue to increase between the United States and China, two heavyweight nations in the solar industry, it may have a material adverse effect on Canadian Solar's international operations.

Risks

- Canadian Solar caters to a geographically-diverse customer base spread across key markets in the United States, China, Japan, the U.K. and Canada as well as emerging markets in Brazil, India, Mexico, Italy, Germany, South Africa and the Middle East. Of late, the company has further expanded its global late-stage project pipeline into nations like Argentina, Australia and South Korea, considering these as the markets where the next phase of industrial growth is expected. Canadian Solar has one of the world's largest utility-scale solar project development platforms, with a track record of bringing into commercial operation more than 5.6 GWp of solar power plants across six continents, as of Sep 30, 2020. Impressively, during the third quarter, the company shipped around 3,169 MW of solar modules globally, which increased 33% on a year-over-year basis. This surely reflects the expanding global footprint of the company. Notably, revenues earned from solar module shipments enable the company to further recycle capital into attractive project opportunities.
- Canadian Solar's cash and cash equivalents were \$1,568 million at the end of third- quarter 2020, up from \$984 million at the end of the second quarter. Its long-term debt was \$846 million as of Sep 30, 2020, much less than the company's cash reserve. This reflects a strong solvency position on the company's part, which is further evident from the sequential improvement in its financial ratios. Notably, the company's current ratio of 1.24 as of the end of third-quarter 2020, being more than 1, reflects that the company holds sufficient cash in hand to meet its obligations. Also, this ratio improved when compared to the prior quarter level of 1.15 and came in highest in the trailing four quarters.

Such stellar financial ratios of Canadian Solar make us optimistic about the company's ability to duly pay off its debt obligations. This also comes as good news from the stock's viability as a lucrative investment opportunity, since investors have been preferring solvent stocks amid the pandemic-induced economic crisis.

Last Earnings Report

Canadian Solar Q3 Earnings & Revenues Beat Estimates

Canadian Solar reported third-quarter 2020 earnings of 15 cents per share in contrast to the Zacks Consensus Estimate of a loss of 4 cents. However, the reported earnings figure deteriorated 84.4% from the year-ago quarter's earnings of 96 cents per share.

The year-over-year deterioration can be attributed to higher cost of revenues that the company incurred in the reported quarter.

Total Revenues

Canadian Solar's total revenues of \$914.4 million outpaced the Zacks Consensus Estimate of \$861 million by 6.3%. Net revenues in the reported quarter also comfortably exceeded the company's guidance of \$840-\$860 million.

Moreover, the top line improved 20.3% from \$759.9 million reported in third-quarter 2019. The year-over-year improvement is driven by higher module shipments and project sales.

Operational Update

Solar module shipments in the quarter totaled 3,169 megawatts (MW), up 33% on a year over year basis and grew 9% from 2,905 MW in the second quarter of 2020. Growth in shipments was driven by strong global demand growth. Shipments also exceeded the guidance range of 2.9-3.1 MW.

Gross profit amounted to \$178.4 million, down 12.3% from the year-ago quarter's \$198.9 million. Gross margin was 19.5% in the quarter, indicating a contraction of 670 basis points from the third quarter of 2019. However, it came above the guidance range of 14-16%.

Total operating expenses were \$119 million, up 0.5% year over year. Selling expenses totaled \$54 million, up 15% year over year. General and administrative expenses were \$56.2 million, down 8.6% year over year. Research and development expenses were \$14.1 million, up 22.3% from the year-ago period.

Income tax expenses in the third quarter of 2020 were \$24 million compared with \$10 million in the third quarter of 2019.

Interest expenses were \$17.9 million, down from \$19.2 million recorded in the year-ago period.

Financial Update

As of Sep 30, 2020, cash and cash equivalents totaled \$1,103 million, up from \$668.8 million as of Dec 31, 2019.

Long-term debt as of Sep 30, 2020 was \$623.6 million, up from \$619.5 million as of Dec 31, 2019.

Guidance

For fourth-quarter 2020, Canadian Solar expects shipments of 2.9-3.0 GW. This guidance includes approximately 350 MW of shipments to its utility-scale solar power projects that may not be recognized as revenues. Total revenues are projected within \$980-\$1,015 million, while gross margin is expected in the band of 8-10%.

The Zacks Consensus Estimate for the company's third-quarter revenues is pegged at \$1,140 million, higher than the guided range.

For 2020, Canadian Solar now expects total module shipments in the range of 11.2-11.3 GW, compared with the prior guidance of 11-12 GW.

Recent News

On **Jan 7, 2021**, Canadian Solar's subsidiary, Recurrent Energy, completed the sale of the 144 megawatts alternate current (MWac) Pflugerville Solar project to Duke Energy Renewables, a subsidiary of Duke Energy Corp. DUK. The project is under construction and expected to achieve commercial operation in mid-2021. The energy generated from the Pflugerville Solar project will be sold to Austin Energy under a 15-year power purchase agreement (PPA).

On **Jan 5, 2021**, Canadian Solar announced it has sold an ownership interest in its Hays and Jenner solar projects to BluEarth Renewables. BluEarth will also assume management responsibilities of the projects. Located in southeast Alberta, both projects are 31 MWp (23 MWAC) in size. The projects are co-owned by Conklin Métis Local 193, an indigenous community based in the rural hamlet of Conklin and part of the Athabasca Oil Sands region in eastern Alberta. Both projects are expected to start commercial operation in 2021.

On **Dec 16, 2020**, Canadian Solar completed the sale of a Japan-based solar project, Gunma Aramaki, for \$64 million. The solar plant, with generation capacity of 19 megawatt-peak (MWp), has been operational since December 2018 and is powered by Canadian Solar's high-efficiency solar modules.

On **Nov 23, 2020**, Canadian Solar announced that it has signed two power purchase agreements (PPAs) involving solar power projects in Brazil with a total generating capacity of 862 megawatt-peak (MWp). These enhanced the company's backlog of solar projects in Brazil with PPAs (or equivalent) to almost 2.2 gigawatt-peak (GWp).

Canadian Solar's latest, high power series 7 bifacial modules of up to 665 Wp will be installed in each of the aforementioned projects.

On **Oct 27, 2020**, Canadian Solar launched its Series 7 high-power, high-efficiency modules with power output of up to 665 W. The new generation modules are set to deliver one of the industry's most competitive levelized cost of electricity (LCOE) as it further reduces balance of system (BOS) and other costs for solar power plants.

The new monofacial HiKu7 and bifacial BiHiKu7 modules are optimized with leading tracker and inverter designs to support seamless installation of solar plants.

Valuation

Canadian Solar's shares are up 142.2% in the past six months period and 143.1% over the trailing 12-month period. Stocks in the Zacks sub-industry are up 163.2%, while stocks in the Zacks Oils-Energy sector are up 24.4% in the past six months period. Over the past year, the Zacks sub-industry is up 250.5% whereas the sector is down 24.2%.

The S&P 500 index is up 21.9% in the past six months period and 18.2% in the past year.

The stock is currently trading at 0.7X of forward 12-month sales, which compares to 6.1X for the Zacks sub-industry, 0.9X for the Zacks sector and 4.6X for the S&P 500 index.

Over the past five years, the stock has traded as high as 0.7X and as low as 0.2X, with a 5-year median of 0.3X. Our Underperform recommendation indicates that the stock will perform worse than the market. Our \$48 price target reflects 0.55X forward 12-month sales.

Zacks Rank

Zacks Style Scores

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
