Summary

Strong demand for profitable trucks and SUVs is aiding General Motors' revenues. The company's hot-selling brands in America like Chevrolet Silverado, Equinox and GMC Sierra are driving the top line. The firm is increasing capacity investment in emerging markets to enhance global sales, and is undertaking several initiatives to make its vehicles more advanced, safer and fuel efficient. However, high cost of raw materials amid tariff woes might put pressure on the firm's profitability. As it is, the firm's negative FCF and high debt are restricting the financial flexibility of the firm. Also, the six week long UAW-General Motors strike will act as a near-term headwind in the fourth quarter earnings of 2019. Hence, investors are recommended to wait for a better entry

Price, Consensus & Surprise



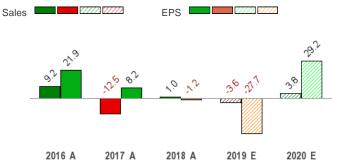

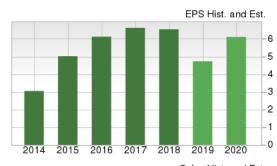
Overview

Detroit, MI-based General Motors Company, founded in 1908, is a leading global automotive company. The company is engaged in designing, building and selling cars, trucks, crossovers and automobile parts worldwide. The company is also expanding autonomous vehicle business. Moreover, the company offers automotive financing services through General Motors Financial Company, Inc.

Management of General Motors has taken the initiative to transform the company into the most valued automotive company of the world. Strategic plans aim at to redefine the future of personal mobility and advance its vision of zero crashes, zero emissions, zero congestion vehicles while also strengthening the core of its business.

The company filed voluntary petitions for relief under Chapter 11 of the U.S. Bankruptcy Code on Jun 1, 2009. Pursuant to this, the New GM was formed by acquiring most of the assets and assuming certain liabilities of the Old GM, and some of its direct and indirect subsidiaries.

GM received \$52 billion in U.S. Treasury loans by selling 61% ownership stake of the company and C\$1.5 billion (\$1.5 billion) in Export Development Canada loans during the bankruptcy protection. In Dec 2013, the U.S. Department of Treasury completed the divestment of its entire stake in General Motors.

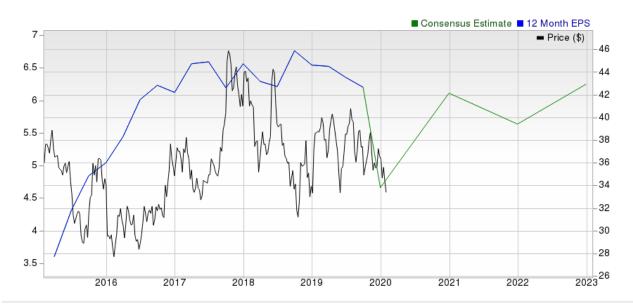




Nearly 73.4 million shares of GM, which were held by Canada GEN Investment Corporation, were sold to Goldman, Sachs & Co under an unregistered block trade in Apr 2015. With this, Canada GEN sold its entire stake in General Motors.

GM, along with its strategic partners, produces, sells and services cars, trucks and parts under four core brands – Chevrolet, Buick, GMC and Cadillac. GM assembles passenger cars, crossover vehicles, light trucks, sport utility vehicles (SUVs), vans and other vehicles.

GM has three operating segments, namely, General Motors North America ("GMNA"), General Motors International Operations ("GMIO") and GM Financial.



Reasons To Buy:

▲ Strong demand for profitable trucks and SUVs is aiding General Motors' revenues. The company's hot-selling brands in America like Chevrolet Silverado, Equinox and GMC Sierra are driving the top line. SUVS and crossover vehicles, which accounts for majority of the firm's sales volumes, are becoming popular on the back of low interest rates and gas prices. Notably, the demand for these brands is expected to grow further. General Motors revamped its crossover lineup and is launching all-new full-size pickups that will be followed by full-size SUVs.

Strong demand for profitable trucks and SUVs is aiding General Motors' revenues.

- ▲ General Motors' shareholder-friendly policy via dividends and stock buybacks further boosts investors' confidence. Its dividend yield of nearly 3.9% is more than the broader industry's yield of around 2.4%. The company's active share repurchase program of \$5 billion, out of which it has already bought back \$1.6 billion worth of shares, reflects cash generating ability.
- ▲ General Motors is increasing capacity investment in emerging markets to enhance global sales. The company expects half of the global sales growth by 2030 to come from emerging markets. It is trying to gain from growth of emerging countries via product launches and the new Wuling plant. The firm is undertaking several initiatives to make its vehicles more advanced, safer and fuel efficient. The automaker is presently focusing on electric and autonomous vehicle development to adapt to changing dynamics and customer preferences. All the above-mentioned initiatives are likely to bolster the company's prospects, going forward.

Reasons To Sell:

- ▼ Tariff woes in China are escalating the cost of raw materials and may eat into some of the profits of the firm. Going forward, the company is expected to face headwinds from challenging economic environment in China as well as rising commodity costs. Due to increased launch-related costs, the company expects pricing pressure to intensify. Further, the 6-week long UAW-General Motors strike is likely to adversely impact the firm's results in the fourth quarter of 2019.
- ▼ General Motors does not fare well on the free cash flow parameter, which is a key metric to gauge the financial health of a company. It recorded negative free cash flows of \$1.3 billion on a year-to-date basis. Further, elevated leverage of around 88% restricts its financial freedom.
- General Motors is expected to face headwinds from challenging economic environment in China as well as rising commodity costs.
- ▼ Frequent vehicle recalls by General Motors due to safety issues remain a headwind. In addition to elevating costs for repairing defects,
- frequent recalls and criminal investigation reduce consumers' confidence in a brand. Notably, unfavorable foreign exchange impact of the Argentine peso and Brazilian real adversely affected General Motors' business expectations.

Last Earnings Report

General Motors Q3 Earnings and Sales Top Estimates

General Motors delivered a comprehensive beat in the third quarter of 2019, with earnings and sales surpassing the Zacks Consensus Estimate. Better-than-expected performance from the North American market led to the outperformance.

General Motors reported adjusted earnings of \$1.72 per share in third-quarter 2019, topping the Zacks Consensus Estimate of \$1.18. However, the bottom line declined 8% from the year-ago figure. The top U.S. carmaker firm reported revenues of \$35,473 million, topping the Zacks Consensus Estimate of \$34,153 million. However, the top line decreased from the year-ago figure of \$35,791 million.

The automaker's global market share was 10.7% in the reported quarter, reflecting a marginal decline from 10.8% in the year-ago period.

Segment Results

GM North America (GMNA) generated net sales and revenues of \$27.9 billion in third-quarter 2019, up from \$27.6 billion recorded in the corresponding period of 2018. Revenues from the GMNA unit also outpaced the Zacks Consensus Estimate of \$25.7 billion. Profits from the segment recorded a year-over-year increase of 7% to \$3 billion in the quarter under review. Moreover, the figure surpassed the Zacks Consensus Estimate of \$2.5 billion. Robust sales of trucks and crossovers drove the results of the unit. Higher year-over-year pricing of all new pickups also aided the performance. Notably, vehicle sales in the United States came in at 739,000 units, reflecting a year-over-year increase of 6%. Deliveries increased across all its brands, with crossovers generating record sales in the quarter.

GMI International's net sales and revenues were \$3.8 billion, declining from \$4.6 billion in the year-ago quarter. Revenues from the GMI segment also lagged the Zacks Consensus Estimate of \$4.2 billion. The unit recorded an operating loss of \$65 million against income of \$139 million a year ago. The Zacks Consensus Estimate for segmental earnings was \$112 million. Sagging vehicle sales in China amid economic slowdown and trade tussle negatively impacted the segment.

GM Financial generated net sales and revenues of \$3.66 billion in the quarter under review, reflecting a rise from \$3.51 billion recorded in the year-ago period. The segment recorded operating profit of \$711 million, significantly beating the Zacks Consensus Estimate of \$469 million. The figure also increased 42.7% year over year.

Dividend & Financials

General Motors recently declared fourth-quarter dividend of 38 cents a share, payable on Dec 19 to its shareholders as of Dec 6, 2019.

General Motors had cash and cash equivalents of \$20.1 billion as of Sep 30, 2019 compared with \$20.8 billion on Dec 31, 2018. Long term automotive debt stands at \$13.1 billion.

Adjusted automotive free cash flow in the reported quarter was \$3.8 billion, representing a massive increase from \$396 million in the prior-year period.

Guidance

General Motors expects full-year capex to come in at \$7.5 billion, lower than the prior projection. Amid the impact of UAW strike, the company has revised its full-year view. It now forecasts adjusted EPS between \$4.50 and \$4.80 per share. The company expects adjusted automotive free cash flow within \$1 billion.

General Motors Declares Dividend for First-Quarter 2020

On **Feb 3**, General Motors declared dividend of 38 cents per outstanding share of common stock for first-quarter 2020. The dividend is payable Friday, March 20, 2020, to all common shareholders of record at the close of business on Friday, March 6, 2020.

General Motors Delivers 3.09M Vehicles in China in 2019

On **Jan 8**, General Motors announced that it delivered more than 3.09 million in China in 2019 compared to 3.64 million vehicles in 2018, amid a challenging environment with weakened consumer demand. The company continued the transformation of its portfolio, including luxury vehicles, large SUVs, and the ongoing development and rollout of its new energy vehicle (NEV) line-up.

General Motors Sells Over 1M Crossovers and Full-Size Trucks in 2019

On Jan 3, General Motors announced that it delivered 2,887,046 vehicles in 2019 in the United States. The total included more than 1 million crossovers for the second year in a row, an increase of 12.7 percent compared to 2018, and more than 1 million full-size pickup trucks and SUVs.

Valuation

General Motors' shares are down 7.8% in the year-to date period and down 10.6% in the trailing 12-month period. Stocks in the Zacks Automotive - Domestic industry and the Zacks Auto-Tires-Trucks sector are up 15.4% and 1.1% in the year-to-date period, respectively. Over the past year, the Zacks sub-industry and sector are up 36.2% and 10.5%, respectively.

The S&P 500 index is up 0.2% in the year-to-date period and 19.4% in the past year.

The stock is currently trading at 5.56X forward 12-month earnings, which compares to 14.07 for the Zacks sub-industry, 10.87X for the Zacks sector and 18.5X for the S&P 500 index

Over the past five years, the stock has traded as high as 8.35X and as low as 4.85X, with a 5-year median of 6.02X. Our Neutral recommendation indicates that the stock will perform in-line with the market. Our \$36 price target reflects 5.94X forward 12-month earnings per share.
