Summary

Shares of Huntington have underperformed the industry in the past year. Yet, the company has an impressive earnings surprise history, having surpassed the Zacks Consensus Estimate in three of the trailing four quarters. Efforts to expand footprint through strategic initiatives and continued rise in loans and deposits are likely to lend support to revenue growth. Recently, the company closed the merger with TCF Financial Corporation, facilitating its debut in markets of Minnesota and Colorado, and across new businesses, including inventory finance lending. Also, improving credit quality is a positive. However, shrinking margins due to low interest rates are likely to deter bottom-line growth. Significant exposure to commercial loans amid uncertain markets is concerning. Further, unsustainable capital deployment activities remain concerning.

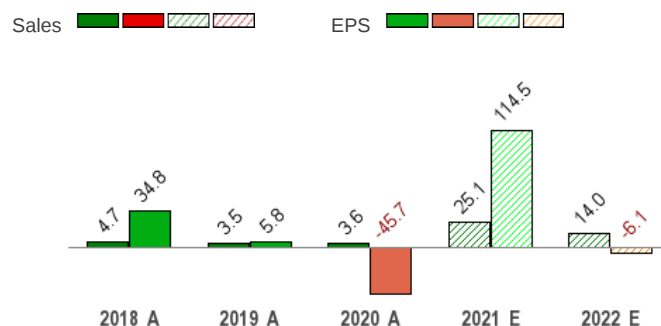
Price, Consensus & Surprise

Overview

Headquartered in Columbus, OH, Huntington Bancshares Incorporated is a multi-state diversified regional bank holding company. Through its subsidiaries, including its banking subsidiary Huntington National Bank, the company provides full-service commercial and consumer banking services, mortgage banking services, equipment leasing, investment management, trust and brokerage services, and other financial products and services.

It operates through four major segments. Firstly, Consumer and Business Banking segment includes Home Lending which provides a wide array of financial products and services to consumer and small business customers. Business Banking serves companies with revenues up to \$20 million. Under Home Lending, it originates and services consumer loans and mortgages for customers mainly located in primary banking markets.

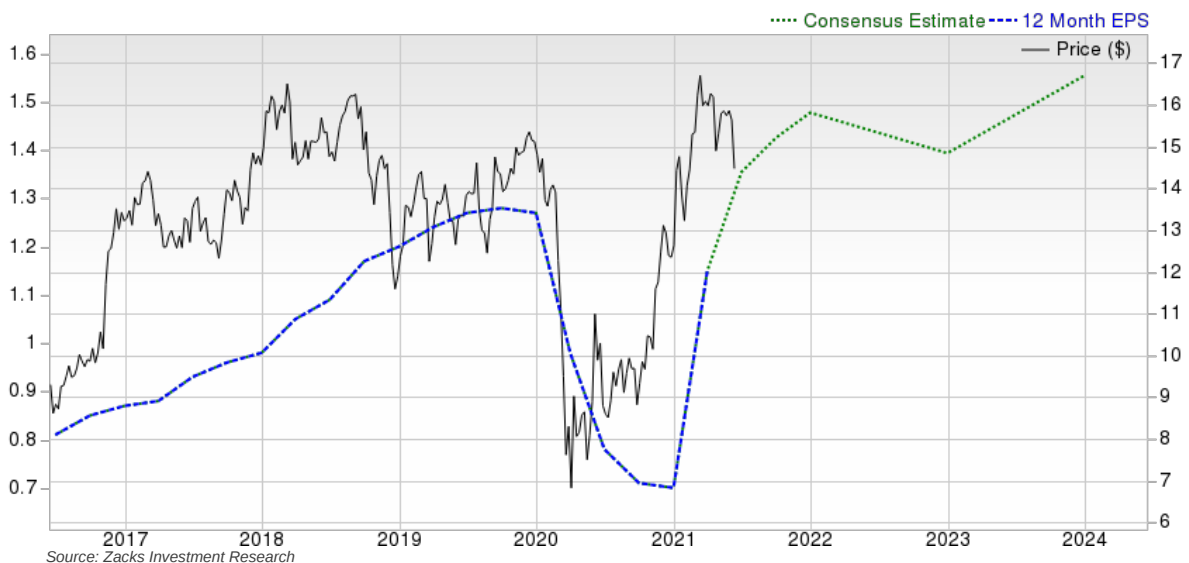
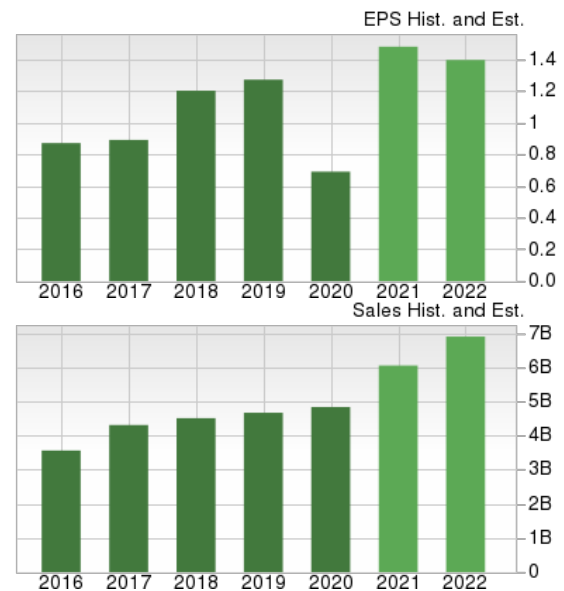
Further, Commercial Banking provides a variety of products and services to the middle market, large corporate client base, real estate and government public sector customers. The segment is divided into six business units: Middle Market, Specialty Banking, Asset Finance, Capital Markets/Institutional Corporate Banking, Commercial Real Estate and Treasury Management.

Vehicle Finance provides lending and other banking products and services to customers for the purchase of vehicles and also to franchised dealerships for the acquisition of new and used inventory.

Regional Banking and The Huntington Private Client Group (RBHPCG) core business is The Huntington Private Bank, which consists of Private Banking, Wealth & Investment Management, and Retirement plan services.

Additionally, the Treasury/Other Group includes revenues and expenses related to assets, liabilities, and equity not directly allocated to any segment. Assets include investment securities and bank-owned life insurance.

In 2016, Huntington acquired FirstMerit Corporation. In 2018, the company acquired Hutchinson, Shockey, Erley & Co., a Chicago-based public finance investment bank and broker-dealer.



Reasons To Buy:

- ▲ Given its robust liquidity position, Huntington is well positioned to expand via acquisitions. Over the past few years, the company has expanded its footprint with a number of acquisitions. In 2018, Huntington completed its acquisition of Hutchinson, Shockey, Erley & Co., a leading public finance investment bank and broker-dealer, which resulted in a larger market presence. Notably, recently, the company closed the merger with TCF Financial Corporation to form one of the top 25 U.S. bank holding companies. Therefore, we believe such efforts will help the company gain significant market share and thereby, enhance its profitability over the long run.
- ▲ We are impressed with the faster-than-expected improvement in the company's credit quality. Despite the macro pressure, Huntington's credit quality continues to normalize. Credit metrics have been gradually improving since the last quarter of 2009, except for the third quarter of 2012, as a result of the new regulatory guidance. Though in 2020, credit quality deteriorated due to the impacts of the coronavirus mayhem, the same improved in the first three months of 2021 on improving economic environment. Nevertheless, Huntington's credit quality is likely to witness improvement in the quarters ahead on the back of economic recovery.
- ▲ As of Mar 31, 2021, the company held debt worth \$7.4 billion, which declined in the past few quarters. Also, debt-to-capital ratio of 0.35 has been improving. Also, cash and due from banks, as of same date, were \$1.1 billion. Therefore, we believe Huntington carries lower likelihood of default of interest and debt repayments if the economic situation worsens.
- ▲ The company is focused on acquiring the industry's best deposit franchise. Huntington's total deposits recorded a three-year compounded annual growth rate (CAGR) of 8% in 2020. Moreover, driven by strong performance of the commercial and consumer portfolio, total loan balance recorded a three-year CAGR of 4.4% in 2020. Both the metrics continued to increase in the first quarter of 2021. We believe that both loan and deposit balances are poised to grow in an improving economy.
- ▲ Shares of Huntington have underperformed the industry over the past year. Despite the unfavorable trend, the company's second-quarter earnings estimates have been revised marginally upward over the past 30 days. Therefore, given the solid fundamentals and positive estimates revision, the stock has decent upside potential.

Huntington's strategic initiatives, including expansion moves should bolster revenue growth. Moreover, growth in loans and deposits balance is expected to drive long-term growth of the company.

Reasons To Sell:

- ▼ With support from higher interest rates, margin pressure for Huntington eased in the three years (ended 2018), after witnessing a declining trend for years. However, net interest margin (NIM) declined in 2019 and 2020 on account of a decline in interest rates. In first-quarter 2021, NIM expanded on lower debt costs along with mark-to-market gains. Nevertheless, the Federal Reserve's accommodative monetary policy stance and lower yields, we expect the bank's key metric to remain under pressure in the quarters ahead.
- ▼ Huntington's rising cost base keeps us apprehensive. Non-interest expenses saw a CAGR of 7.7% over the last five years (ended 2020), with the trend continuing in the first three months of 2021. Notably, the company intends to make investments in digital, data and technology enhancements, product differentiation and other initiatives, which will likely bolster its existing capabilities and infrastructure. Therefore, a rising expense base is expected to impede bottom-line growth of the company.
- ▼ Majority of Huntington's loan portfolio – nearly 52% as of Mar 31, 2021 – comprises total commercial loans (commercial and business lending as well as commercial real estate lending). Such high exposure to commercial loans depicts lack of diversification which can be risky for the company amid challenging economy and competitive markets.
- ▼ Though Huntington's involvement in steady capital deployment activities is encouraging, its unfavorable liquidity position keeps us apprehensive. The company had increased its quarterly dividend by 7% in July 2019. Also, it had a share repurchase program in place, that was suspended mid-March following the coronavirus crisis. Further, the company's debt/equity ratio does not compare favorably with the broader industry. Thus, these capital deployment activities might not be sustainable in the long-term.

Huntington's bottom line growth remains affected due to the pressure on margins from lower interest rates. Further, lack of diversification in loan portfolio remains a headwind for the company.

Last Earnings Report

Huntington Q1 Earnings Beat Estimates as Revenues Rise

Huntington's first-quarter 2021 earnings per share of 48 cents surpassed the Zacks Consensus Estimate of 33 cents. Also, the bottom line increased substantially from 3 cents reported in the prior-year quarter.

Increase in revenues aided by high net interest and non-interest income supported the results. Rise in mortgage banking revenues and increase in average earnings assets acted as driving factors. Improvement in deposits and negative credit provisions were other positives. However, results were adversely impacted by lower loans balance and elevated expenses.

The company reported net income of \$532 million in the quarter compared with \$48 million in the year-ago quarter.

Revenues Up, Expenses Escalate

Total revenues climbed 19% year over year to \$1.37 billion in the first quarter. Also, the top line surpassed the consensus estimate of \$1.23 billion.

Net interest income (FTE basis) was \$978 million, up 23% from the prior-year quarter. The upside resulted from an increase in average earnings assets (12%) and a higher NIM, which expanded 34 basis points (bps) to 3.48%.

Non-interest income climbed 9% year over year to \$395 million. This upside mainly stemmed from an increase in mortgage banking income, card and payment processing, insurance income along with trust and investment management services income.

Non-interest expenses rose 22% on a year-over-year basis to \$756 million. This was chiefly due to higher professional services costs, outside data processing and other service costs, occupancy and equipment expenses, and marketing expenses. On an adjusted basis, costs increased 18%.

Efficiency ratio was 57%, up from the prior-year quarter's 55.4%. A rise in ratio indicates a fall in profitability.

As of Mar 31, 2021, average loans and leases at Huntington decreased 1% on a sequential basis to \$80.3 billion. However, average total deposits increased 3% from the prior quarter to \$99.3 billion.

Credit Quality: A Mixed Bag

Net charge-offs were \$64 million or an annualized 0.32% of average total loans in the reported quarter, down from the \$117 million or an annualized 0.62% recorded in the prior year. Furthermore, the quarter-end allowance for credit losses rose 8.6% to \$1.74 billion.

In the first quarter, the company reported negative credit provisioning on improving economic conditions of \$60 million against provision expenses of \$441 million. In addition, total non-performing assets totaled \$544 million as of Mar 31, 2021, down 7.2%.

Capital Ratios

Common equity tier 1 risk-based capital ratio and regulatory Tier 1 risk-based capital ratio were 10.33% and 13.32%, respectively, compared with the 9.47% and 10.81% reported in the year-ago quarter. Tangible common equity to tangible assets ratio was 7.11%, down from 7.52% as of Mar 31, 2020.

Return on average assets and average common equity was 1.76% and 18.7%, respectively, compared with 0.17% and 1.1% recorded in the prior-year quarter.

Outlook for 2021

The company has raised guidance for full-year 2021.

Revenues are expected to increase 3-5% from 2020 compared with 1-3% projected previously. The company expects NII growth to be in the mid-single digits while non-interest income is expected to be modestly lower for the full year.

NIM is expected to be in mid-2.80% in second quarter of 2021, reflecting benefits from new stimulus, full-year NIM is expected to be 2.90% or better.

Non-interest expenses are likely to be up 7-9% year over year compared with 3-5% projected before. Adjusted costs are expected to increase between 6% and 8%. The increase in expectations is driven by the foundation donation in the first quarter and increases in compensation expenses related to the higher revenue expectation for the year. The large majority of the underlying expense growth continues to be driven by investments in strategic growth initiatives. While expense growth is expected to outstrip revenue growth over the near term, the company seeks to achieve positive operating leverage over the long term. Moreover, Huntington plans to bring the expense growth rate back to more normalized levels during the second half of 2021.

Management expects average loans and leases to climb 1-3%, down from 2% to 4% expected previously. Reduced expectations are on account of the elevated level of paydowns and a delayed recovery of commercial and vehicle floor plan line utilization. Also, it reflects flat to modestly higher commercial loans inclusive of PPP and low single-digit growth in consumer loans. Excluding PPP, the company expects to see low single-digit growth in both.

Average total deposits are expected to jump 9-11%, up from 5-7% guided earlier, given stronger-than-anticipated deposit inflows in the first quarter and the overall elevated levels of core deposits, which are expected to persist for several more quarters.

Asset quality is anticipated to remain strong. Net charge-offs are expected to be 30-40 bps compared with 35-55 bps expected earlier, reflecting improving economic conditions and stable charge-offs in both commercial and consumer portfolios.

The effective tax rate for 2021 is expected, as before, to be in the range of 16% to 17%.

Recent News

Huntington Closes TCF Financial Merger, Expands Footprint – Jun 9, 2021

Huntington wound up its merger with TCF Financial Corporation to form one of the top 25 U.S. bank holding companies.

The deal received the regulatory nod by the Federal Reserve and the Office of the Comptroller of the Currency, with input from the United States Department of Justice's Antitrust Division on May 25, 2021.

Specifically, each share of TCF common stock was converted into the right to receive 3.0028 Huntington shares of common stock. Also, TCF shareholders will receive cash instead of fractional shares, per the merger agreement. Moreover, customer accounts at TCF will be converted to Huntington's systems in fourth-quarter 2021.

Markedly, the merger, which was announced last December, facilitated Huntington's debut in markets of Minnesota and Colorado, and across new businesses, including inventory finance lending. With this, Huntington now operates more than 1,100 total branches, excluding the previously announced sale of 14 Michigan branches and the consolidation of 189 branches in Michigan and Ohio.

This positions Huntington well to capture market opportunities and boost the client base. Moreover, the company's expanded scale, technological advancement and increased product offerings will help capitalize on its market share. Hence, the merger is a strategic fit.

Stephen D. Steinour, chairman, president and CEO of Huntington, noted "This is a significant step forward for Huntington in our vision to build the leading People-First, Digitally Powered bank in the nation."

Also, the combined company has around \$175 billion in assets, \$142 billion in deposits, and \$116 billion in loans according to balances as of Mar 31, 2021. Accordingly, the combination offers scope for enhanced profitability and scale, top-line growth, and notable cost synergies.

Dividend Update

On Apr 22, Huntington's board of directors announced a quarterly cash dividend of 15 cents per share. The dividend will be paid out on Jul 1 to its shareholders on record as of Jun 17.

Valuation

Huntington's shares are up 14.5% so far this year and 42.9% over the trailing 12-month period. Stocks in the Zacks sub-industry and the Zacks Finance sector are up 21.2% and 19.9% in the year-to-date period, respectively. Over the past year, the Zacks sub-industry and sector are up 48.2% and 45.6%, respectively.

The S&P 500 Index is up 13.8% and 40.6% in the year-to-date period and trailing 12-month period, respectively.

The stock is currently trading at 10.05X forward 12 months earnings, which compares to 12.48X for the Zacks sub-industry, 16.60X for the Zacks sector and 21.86X for the S&P 500 index.

Over the past five years, the stock has traded as high as 17.87X and as low as 5.60X, with a 5-year median of 11.58X. Our Neutral recommendation indicates that the stock will perform in line with the market. Our \$15.50 price target reflects 10.77X forward earnings.

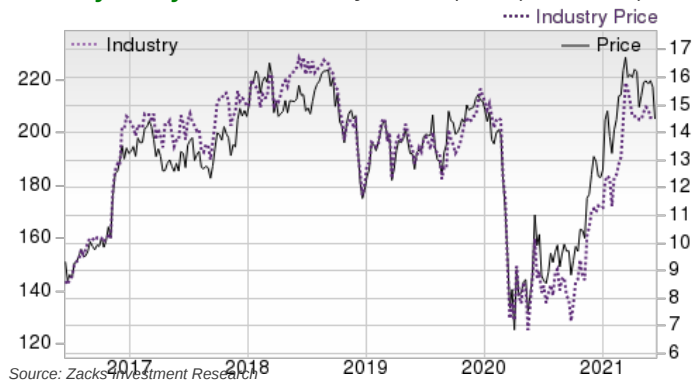

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
