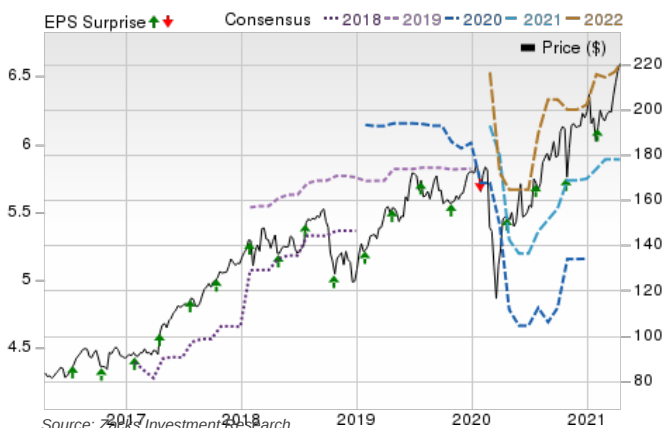

Summary

IDEX is poised to gain from a diversified business structure, solid product portfolio and execution abilities in the quarters ahead. Further, synergistic gains from buyouts might benefit. For 2021, the company's end-market conditions are expected to improve. Organic sales are predicted to increase 6-8%, with revenues rising 8-10%. Moreover, earnings are expected to be \$5.65-\$5.95, up from \$5.19 in 2019. In addition, its shareholder friendly policies will work in its favor. However, the company's earnings face headwinds from growth investments, variable compensation and higher taxes in 2021. Also, weakness in energy market will likely hurt Fluid & Metering Technologies' performance in the year. In the past three months, the company's shares have underperformed the industry and are also comparatively overvalued.

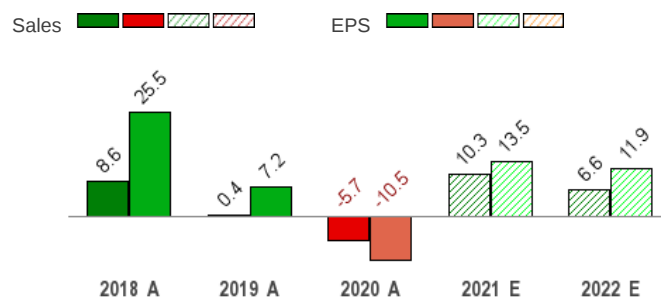
Price, Consensus & Surprise

Overview

Headquartered in Lake Forest, IL, IDEX Corporation is an applied solutions company that specializes in a diverse range of applications such as fluid and metering technologies; health and science technologies; and fire, safety and other products built to customer specifications.

Serving high-growth niche markets, the company operates under three business segments, namely Fluid & Metering Technologies, Health & Science Technologies and Fire & Safety/Diversified Products. IDEX sells its products to original equipment manufacturers (OEMs), as well as to direct end-use customers across the globe.

Fluid & Metering Technologies ("FMT"): The segment produces displacement pumps, injectors, flow meters and related controls for the movement of liquids and gases in various end markets, ranging from food, general industrial, chemical, agricultural, water & wastewater, and energy industries.

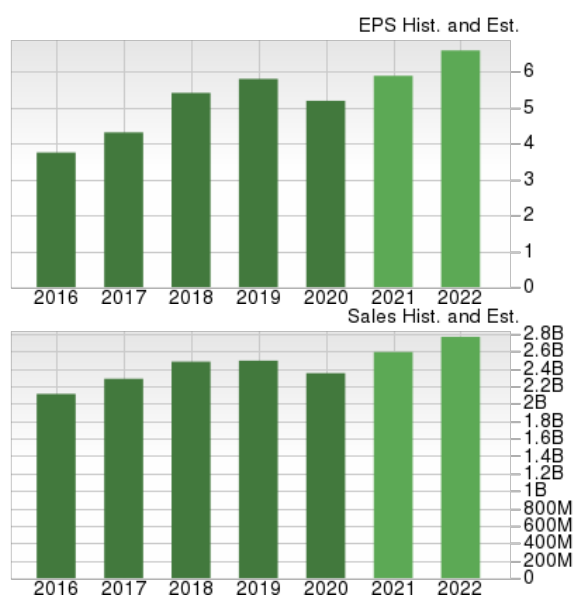
The segment operates in five platforms namely Energy, Water, Valves, Pumps and Agriculture (comprised of Banjo business).

Health & Science Technologies ("HST"): The segment provides various precision fluidics solutions, including degassing equipment, pumps, corrective tubing, valves, fittings and complex manifolds as well as specialty medical equipment and devices used in life science applications.

This segment operates in five platforms — including Gast, Material Processing Technologies ("MPT"), Scientific Fluidics & Optics, Micropump, and Sealing Solutions.

Fire & Safety/Diversified Products ("FSD"): The segment produces fire fighting pumps, rescue tools, lifting bags, and other components and systems for the fire and rescue industry, as well as engineered stainless steel banding and clamping devices for industrial and commercial applications.

This segment operates in three platforms — including Dispensing, Band-It, and Fire & Safety.



Reasons To Buy:

- ▲ In fourth-quarter 2020, IDEX's earnings and sales surpassed estimates by 3.8% and 2.1%, respectively. Also, the bottom line expanded 3% from the year-ago quarter on the back of sales growth and an improvement in the operating margin. In the quarters ahead, the company is poised to gain from a diversified business structure, solid product portfolio, execution abilities and growth investments. For 2021, it expects conditions to improve in end-markets (explained below). Organic sales are anticipated to increase 6-8% year over year, with 2-4% growth expected for the first quarter. Revenues for the year are expected to be \$2,550-\$2,597 million, suggesting an increase of 8-10% from the previous year. Earnings are predicted to be \$1.38-\$1.42 for the first quarter and \$5.65-\$5.95 for 2021. The yearly projection is better than \$5.19 recorded in 2020.
- ▲ IDEX serves customers in various markets, including life science, fire and rescue, water & wastewater, chemical, agricultural, food, general industrial, and energy industries. Gains in one or more markets will help in offsetting weakness in other markets. For 2021, the company anticipates witnessing positive momentum in water and agriculture markets to benefit the Fluid & Metering Technologies segment, while improvements in dispensing and automotive markets will aid the Fire & Safety/Diversified Products segment. For the Health & Science Technologies segment, solid business in food/pharma, automotive and semiconductor markets will be boons. In addition, the company solidified its product portfolio and leveraged business opportunities through the addition of assets. In February 2020, it acquired Flow Management Devices. The buyout strengthened the company's product offerings to chemical manufacturers, refineries and pipeline operators. Further, the company purchased Abel Pumps L.P. — a manufacturer of displacement pumps — in March. The buyout is predicted to boost IDEX's pump platform within the Fluid & Metering Technologies segment. Notably, acquired assets boosted the company's sales by 1% in the fourth quarter of 2020.
- ▲ IDEX believes in rewarding shareholders handsomely through dividend payments and share buybacks. In 2020, the company repurchased shares worth \$110.3 million and distributed dividends totaling \$151.8 million, reflecting a year-over-year increase of 101.8% and 3.1%, respectively. Notably, the quarterly dividend rate currently stands at 50 cents per share (a hike of 16% was announced in May 2019). Share count, exiting the fourth quarter, was 76 million. Impressive cash positions will aid the company to continue rewarding shareholders in the quarters ahead. Notably, the company's net cash from operating activities grew 7.8% year over year to \$569.3 million, while its free cash flow expanded 8.5% to \$517.7 million. Also, the company's cash and cash equivalents at \$1,025.9 million at the end of fourth-quarter 2020 reflected growth of 16.9% from the previous quarter. The company expects free cash flow of 115-120% of net income in 2021.

Strength in end markets served, solid product offerings and gains from acquired assets might be beneficial for IDEX. Additionally, the company's commitment of rewarding shareholders is expected to aid.

Reasons To Sell:

- ▼ In the past three months, IDEX's shares have gained 13.2% compared with the industry's growth of 90.7%. Also, the company's stock currently looks overvalued compared with the industry on a Price (P)/Earnings (E) (trailing 12 months - TTM) basis, with respective tallies of 42.78X and 35.93X. Also, the company's multiple is higher than the industry's three-month highest level of 35.93X. This makes us cautious on the stock.
- ▼ For 2021, IDEX expects earnings to be adversely impacted by growth investments or discretionary costs of 19-26 cents per share. Also, the bottom line will likely be pressured by 8-11 cents from variable compensation. Further, the impacts of acquisitions/divestitures are expected to hurt its earnings by 3 cents, while higher tax rates are expected to lower earnings by 18 cents.
- ▼ IDEX's international operations have exposed it to the adverse impacts of macroeconomic cycles in the United States and international markets. Additionally, it faces headwinds from unfavorable movements in foreign currencies. In addition, the company's presence in multiple end markets might be troubling. For 2021, it expects weakness in the energy end market to adversely impact the performance of its Fluid & Metering Technology segment.

Growth investments, variable compensation and higher taxes are concerning for earnings in 2021. Also, the company's Fluid & Metering Technology segment is expected to be hurt from weakness in the energy market.

Last Earnings Report

IDEX Q4 Earnings Beat Estimates, 2021 View Impressive

IDEX reported impressive results for the fourth quarter of 2020 with earnings surpassing estimates by 3.8%. This was the fourth consecutive quarter of better-than-expected results. Also, the period's sales beat the Zacks Consensus Estimate by 2.1%.

The company's adjusted earnings in the reported quarter were \$1.37 per share, surpassing the consensus estimate of \$1.32. Also, the bottom line grew 3% from the year-ago figure of \$1.33 on the back of sales growth and an improvement in the operating margin.

In 2020, the company's adjusted earnings were \$5.19, decreasing 10.5% from the previous year. However, the bottom line exceeded the consensus estimate of \$5.15.

Revenue Details

In the quarter under review, IDEX's net sales were \$614.8 million, reflecting year-over-year growth of 1.5%. The top line benefited from a 1% gain from acquired assets and a 2% contribution from foreign currency translation, partially offset by a 1% decline in organic sales.

Also, the company's revenues surpassed the Zacks Consensus Estimate of \$602 million.

Orders in the quarter totaled \$678.6 million, reflecting year-over-year growth of 10%. Organically, orders increased 7% while acquired assets and foreign currency translation positively impacted orders by 1% and 2%, respectively.

The company currently reports under three business segments, results of which are discussed below:

Revenues from **Fluid & Metering Technologies** totaled \$229.6 million, increasing 0.9% year over year. Organic sales were down 4% while acquisitions and foreign currency translation added 3% and 2%, respectively.

Revenues from **Health & Science Technologies** totaled \$235.9 million, reflecting year-over-year growth of 3.8%. Organic sales in the quarter inched up 2% year over year and foreign currency translation left a positive impact of 2%.

Revenues from **Fire & Safety/Diversified Products** totaled \$150.6 million, declining 1% year over year. The results were adversely impacted by a 3% decline in organic sales, partially offset by a 2% gain from foreign currency translation.

In 2020, the company's net sales were \$2.35 billion, down 5.7% from the previous year. However, the top line surpassed the Zacks Consensus Estimate of \$2.34 billion.

Margin Profile

In the quarter under review, IDEX's cost of sales increased 1.9% year over year to \$345.7 million. Adjusted gross profit was \$269.2 million, up 0.9% year over year while adjusted gross margin decreased 20 basis points (bps) to 43.8%. The gross margin suffered unfavorable impacts of business mix and lower volumes, partially offset by pricing.

Selling, general and administrative expenses decreased 0.4% year over year to \$125.2 million. It represented 20.4% of revenues. Adjusted earnings before interest, tax, depreciation and amortization (EBITDA) in the quarter under review increased 4.8% year over year to \$167.2 million. Also, adjusted EBITDA margin grew 90 bps year over year to 27.2%.

Adjusted operating income came in at \$144 million, up 2% year over year while margin was at 23.4%, up 10 bps. Interest expenses in the quarter dipped 2.6% year over year to \$10.8 million.

Balance Sheet and Cash Flow

Exiting the fourth quarter, IDEX's cash and cash equivalents increased 16.9% sequentially to \$1,025.9 million. Further, long-term debt of \$1,044.4 million was flat on a sequential basis.

Notably, the company used \$300 million for the redemption of 4.5% senior notes while it raised \$499.1 million proceeds from the issuance of 3% senior notes in 2020.

IDEX generated net cash of \$569.3 million from operating activities in 2020, increasing 7.8% from the previous year. Capital used for purchasing property, plant and equipment was \$51.6 million, reflecting year-over-year growth of 1.2%. Free cash flow was \$517.7 million, up 8.5% year over year.

The company paid out dividends totaling \$151.8 million and repurchased shares worth \$110.3 million in 2020, reflecting a year-over-year increase of 3.1% and 101.8%, respectively.

Outlook

IDEX anticipates end-market conditions to improve in 2021. The company anticipates a 2-4% year-over-year improvement in organic sales in the first quarter of 2021 and a 6-8% in the full year.

Earnings are predicted to be \$1.38-\$1.42 in the first quarter and \$5.65-\$5.95 in 2021. The yearly projection is better than \$5.19 recorded in 2020.

Recent News

Acquisition

On **Mar 11, 2021**, IDEX completed the acquisition of Abel Pumps L.P for \$103.5 million in cash. The other party to the transaction was Hillenbrand, Inc. Notably, Abel Pumps is a specialist in manufacturing displacement pumps, which are mainly used in wastewater, marine, mining, mining and other end markets.

The buyout is predicted to boost its pump platform, which comes under the ambit of the Fluid & Metering Technologies segment.

Dividend

On **Jan 29, 2021**, IDEX paid out a quarterly cash dividend of 50 cents per share to shareholders of record as of Jan 14, 2021.

Valuation

IDEX shares are up 11.7% in the year-to-date period and increased 46.7% in the trailing 12-month period. Stocks in the Zacks sub-industry are up 92.6% in the year-to-date period, while the Zacks Industrial Products sector is up 32.7%. Over the past year, the Zacks sub-industry increased 198.1% and the sector grew 111%.

The S&P 500 Index has moved up 32.8% in the year-to-date period and 50.7% in the past year.

The stock is currently trading at 36.46x forward 12-month earnings per share, which compares to 23.94x for the Zacks sub-industry, 22.63x for the Zacks sector and 22.91x for the S&P 500 index.

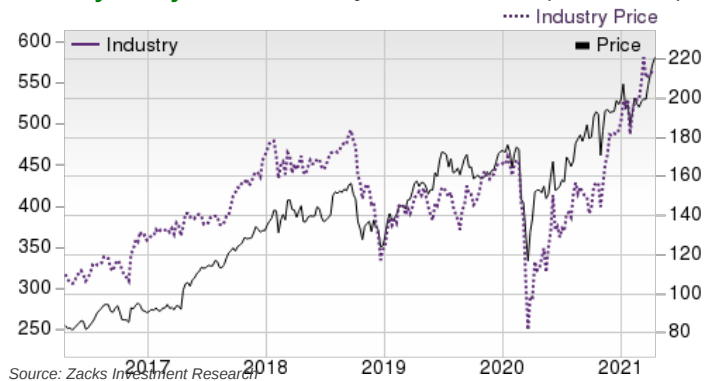
Over the past five years, the stock has traded as high as 36.46x and as low as 19.65x, with a 5-year median of 26.68x. Our Neutral recommendation indicates that the stock will perform in line with the market. Our price target of \$234 reflects 38.35x forward 12-month earnings per share.

Zacks Recommendation

The Zacks Recommendation aims to predict performance over the next 6 to 12 months. The Zacks Recommendation is broken down into 3 Levels; Outperform, Neutral and Underperform. Unlike many Wall Street firms, we maintain a balance between the number of Outperform and Neutral recommendations. Zacks Rank

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
