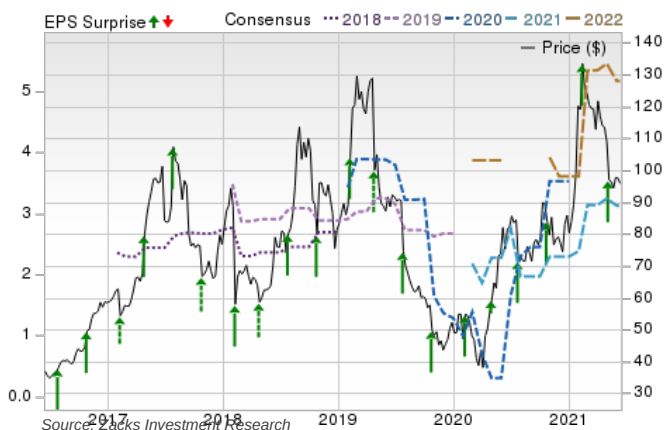

Summary

iRobot is poised to gain from its solid product offerings, manufacturing diversification and a surge in business through the online platforms in the quarters ahead. For 2021, the company increased revenue projection to \$1.67-\$1.71 billion from \$1.635-\$1.675 billion mentioned earlier. Investments in building brand awareness might play a significant role in boosting the demand for its products as well as inflate costs in the quarters ahead. Also, high costs related to raw materials, air freights, tariffs and promotional activities are concerning in the quarters ahead. Tighter availability of semiconductors too might ail in the near term. The company predicts non-GAAP gross profit of \$645-\$675 million in 2021, down from \$665-\$695 million stated previously. In the past three months, iRobot's shares have underperformed the industry.

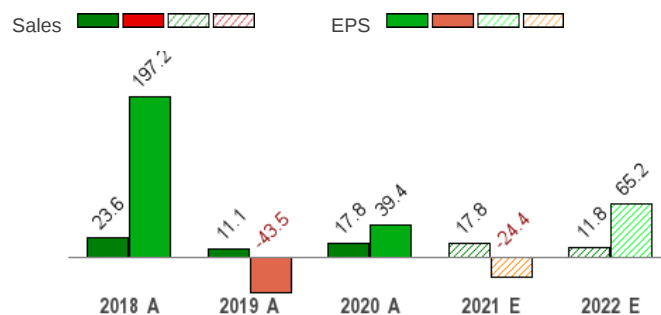
Price, Consensus & Surprise

Overview

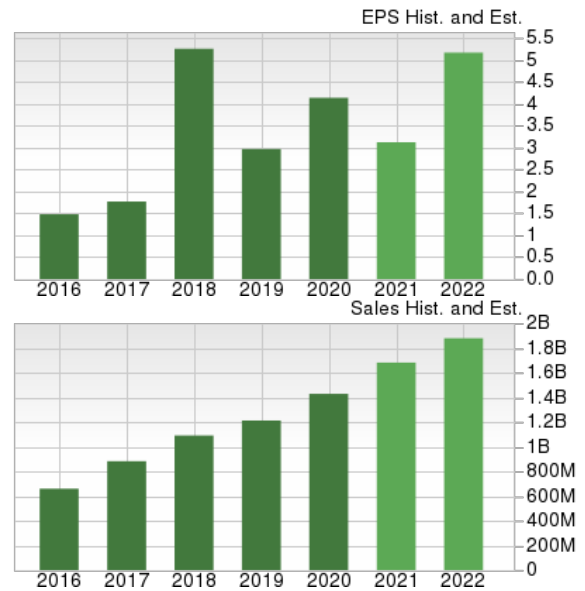
iRobot Corporation is one of the leading manufacturers of robots worldwide. The company is a leader not only in the domestic arena but also excels in the field of commercial usage. Notably, the company was founded in 1990 and is headquartered in Bedford, MA. In 2020, it generated around \$1.4 billion in revenues.

In second-quarter 2016, iRobot divested its Defense & Security business. Thereafter, it started generating the majority of revenues from the Consumer business. The company further strengthened its businesses through acquisitions of two distributors — Japan-based Sales On Demand Corporation and Europe-based Robopolis SAS — in 2017. These buyouts fortified iRobot presence in Spain, Germany, Belgium, Portugal, Austria, France, Japan and the Netherlands.

It is worth mentioning here that iRobot's Consumer business is related to the manufacturing of mobile robots. The company owns premium robotic brands such as Roomba, Braava, Mirra and Looj.

The above-mentioned robots feature proprietary technologies and help in domestic chores like vacuuming, floor scrubbing and mopping, pool cleaning, and gutter cleaning. The products are primarily sold via several distribution channels, which include chain stores, national retailers and online through iRobot's website as well as value-added distributors and resellers.

In addition to vacuuming and mopping products, the company entered the lawn care market as it unveiled Terra — a robot mower — in January 2019. Terra features state-of-the-art mapping and navigation technologies, high-quality mowing, and easy installation capabilities.



Reasons To Buy:

- ▲ In first-quarter 2021, iRobot's earnings and sales surpassed estimates by 583.33% and 15.94%, respectively. On a year-over-year basis, the quarterly bottom line improved from the year-ago quarter's loss of 32 cents. The results were driven by healthy product demand and improvement in margins. For 2021, the company anticipates revenues of \$1.67-\$1.71 billion, reflecting an increase from \$1.635-\$1.675 billion mentioned earlier. Further, the company is optimistic that solid product offerings and healthy demand will help it revenues grow in mid-to-high teens in 2022. Overall performance will benefit from lower tariff exposure, manufacturing in Malaysia, healthy supply chain and expanding direct-to-consumer sales.
- ▲ iRobot's diversified product portfolio has been benefiting it over time. The company noted that revenue generation was solid from its mid-tier robots — products having price of \$300-\$499 — in the first quarter. Also, its innovation capabilities have been proving beneficial. Notably, the company experienced healthy response to the Roomba i3 and i3+ as well as the Genius Home Intelligence platform (all launched in the third quarter of 2020). An upgraded version of the Genius Home Intelligence platform was launched in the first quarter of 2021. In April, the company unveiled iRobot H1 handheld vacuum. The product helps in cleaning stairs, couches and curtains comfortably. In the quarters ahead, its investments in software related to machine vision technologies, artificial intelligence and home understanding will also aid.
- ▲ iRobot is focused on expanding its recurring revenue sources, direct-to-consumer sales channel and business from the online platform. Notably, revenues generated from the online platform — including Home App, online source of retailers, e-commerce sites and the company's website — were roughly 56% of iRobot's first-quarter revenues and represented growth of 90% from the year-ago quarter. Revenues from direct sales to consumers increased 146% year over year in the first quarter and accounted for 11.5% of the quarter's top line. In addition, investments in building brand awareness — via campaigning through traditional retail partners in its app and website, and online retailers — might play a significant role in boosting the demand for products in the quarters ahead.

The robust demand for existing Roomba and Braava products, focus on product innovation and a spur in the e-commerce business are likely to aid iRobot's performance in the quarters ahead.

Reasons To Sell:

- ▼ In first-quarter 2021, iRobot's gross margin decreased 20 basis point (bps) year over year. High costs of components and air freights adversely impacted margin. Also, tariff costs related to Section 301 of \$3.4 million lowered gross margin by 1.1 percentage points. For 2021, the company predicts non-GAAP gross profit of \$645-\$675 million, down from \$665-\$695 million stated previously. Higher air freight, raw material and transportation costs in the year will likely play spoilsports. Also, costs related to the tighter availability of semiconductors will add to the concerns. For 2021, the company expects gross margin of 39%. Tariffs on import of Roomba products from China are expected to inflate costs by \$43-\$45 million, higher than \$41-\$43 million mentioned previously. Also, expenses related to manufacturing in Malaysia as well as spending on promotional and pricing activities will likely hurt the gross margin.
- ▼ iRobot conducts business in a highly competitive market, and hence to stay in business, it has to invest in development and marketing of products. These expenses, if uncontrolled, can be a serious threat to the company's margin profile. Its operating expenses increased 18.8% year over year in the first quarter of 2021. For 2021, the company predicts operating costs of \$535-\$555 million (or mirroring 32% of the year's sales). Operating income is predicted to be \$110-\$120 million and operating margin is likely to be 7% in 2021. Notably, the company reported total operating expenses (non-GAAP) of \$487.5 million and adjusted operating margin of 10.5% in 2020. For the second quarter of 2021, it predicts a sequential increase in general and administrative as well as research and development expenses. Sales and marketing expenses will likely increase too. Operating margin is expected to decline compared with the previous quarter.
- ▼ Despite healthy top-line expectations, weakness in margins (as discussed above) is concerning for iRobot's bottom-line performance in 2021. The company expects adjusted earnings per share of \$3.00-\$3.25 for 2021, suggesting a decline from \$4.14 generated in 2020. In the past three months, the company's shares have decreased 24.5% compared with the industry's growth of 4.3%.

High costs related to tariffs, raw material, transportation fees and air freights are concerning for iRobot's margin profile. Also, difficulty in the procurement of semiconductors is expected to ail in the near term.

Last Earnings Report

iRobot Beats on Q1 Earnings, Ups Revenue Projection

iRobot reported better-than-expected results for first-quarter 2021. Its earnings surpassed estimates by 583.33%, whereas sales beat the same by 15.94%.

Its adjusted earnings were 41 cents per share in the quarter, surpassing the Zacks Consensus Estimate of 6 cents. Also, the bottom line improved from a loss of 32 cents recorded in the year-ago quarter on the back of healthy sales generation and improvement in operating margin.

Revenue Details

The company generated revenues of \$303.3 million in the quarter, surpassing the Zacks Consensus Estimate of \$262 million. On a year-over-year basis, quarterly revenues increased 57.5%, driven by healthy demand for products.

Sales generated from the e-commerce platform (representing 56% of the quarter's revenues) increased 90% year over year. Notably, the e-commerce platform includes online sources of retailers, the company's app and website, and e-commerce websites. In addition, direct sales to consumers expanded 146% year over year to \$35 million and represented 11.5% of the quarter's revenues.

Total product units of 1,088 thousand shipped in the quarter reflected a year-over-year increase of 50.9%, while average selling prices grew 1.3%. For vacuum products, revenues of \$270 million reflected growth of 58.8% from the year-ago quarter. Units shipped were 971 thousand, up 55.4% from the year-ago quarter. Further, revenues from mopping products increased 43.5% to \$33 million. Units shipped were 117 thousand, up from 96 thousand recorded in the first quarter of 2020.

On a geographical basis, the company sourced 37.8% of revenues from domestic operations, the rest came from the international arena. Domestic revenues totaled \$114.8 million, reflecting a 40% increase from the year-ago quarter. International revenues grew 70.5% to \$188.5 million. International operations gained from a 53% revenue increase in Japan and a 74% rise in EMEA sales.

Margin Profile

In the quarter under review, iRobot's non-GAAP costs of revenues increased 58% year over year to \$179.7 million, representing 59.3% of revenues compared with 59.1% in the year-ago quarter. Non-GAAP gross profit in the quarter grew 56.8% year over year to \$123.5 million, while adjusted gross margin decreased 20 basis points to 40.7%.

Research and development expenses were \$41.9 million, up 14% year over year. This accounted for 13.8% of revenues compared with 19.1% in the year-ago quarter. Selling and marketing expenses increased 39.3% to \$51 million. As a percentage of revenues, it reflected 16.8% in the quarter compared with 19% in the prior-year quarter. General and administrative expenses were \$23.4 million, down 4.6% year over year. The figure mirrored 7.7% of the total revenue base compared with 12.8% in the year-earlier quarter.

In the quarter, the company recorded adjusted operating earnings of \$15 million as compared with an operating loss of \$14.4 million in the year-ago quarter. Adjusted operating margin was 4.6%, higher than (7.5%) in the year-ago quarter.

Notably, tariff costs related to Section 301 totaled \$3.4 million in the quarter, down from \$6.6 million in the year-ago quarter. Its impact on gross and operating gross margin was an adverse 1.1% versus 3.4% in the year-ago quarter.

Balance Sheet and Cash Flow

Exiting first-quarter 2021, iRobot had cash and cash equivalents of \$500.8 million, increasing 15.7% from \$432.6 million recorded at the end of first-quarter 2020. Total long-term liabilities were \$70 million, down 9.9% sequentially.

In the reported quarter, the company generated net cash of \$28.7 million from its operating activities, down 29.6% from the year-ago quarter. Capital used for purchasing property and equipment totaled \$11.3 million, increasing 54.2% year over year.

In the quarter under review, the company refrained from repurchasing its shares.

Outlook

For 2021, iRobot increased its revenues expectation to \$1.67-\$1.71 billion from \$1.635-\$1.675 billion mentioned earlier.

Non-GAAP gross profit is expected to be \$645-\$675 million (versus \$665-\$695 million stated previously) and non-GAAP operating income is expected to be \$110-\$120 million (maintained). The company expects freight, raw material and transportation costs to inflate in the year. Costs related to the tighter availability of semiconductors will also add to the concerns.

The company reiterated its non-GAAP earnings projection at \$3.00-\$3.25 per share.

Valuation

iRobot's shares are up 19.9% and 14.3% in the year-to-date period and over the trailing 12-month period, respectively. Stocks in the Zacks sub-industry and the Zacks Industrial Products sector are up 12.5% and 12.7% in the year-to-date period, respectively. Over the past year, the Zacks sub-industry and the sector increased 30.6% and 49.7%, respectively.

The S&P 500 Index has moved up 14.1% in the year-to-date period and 38.8% in the past year.

The stock is currently trading at 23.7x forward 12-month earnings per share, which compares to 27.25x for the Zacks sub-industry, 21.67x for the Zacks sector and 21.88x for the S&P 500 index.

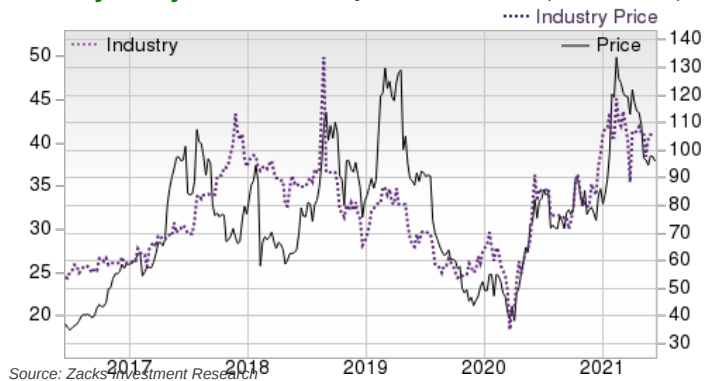

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
