Summary

Shares of Kimberly-Clark have underperformed the industry in the past three months. The company's K-C Professional segment is seeing softness due to declines in away-from-home demand and tough business conditions amid the pandemic. During the first quarter of 2021, segment sales declined 11% year over year. Additionally, Kimberly-Clark is incurring high pandemic-induced costs and commodity inflation. In first-quarter, sales and earnings fell year over year and missed the consensus mark. Moreover, management lowered its 2021 view to reflect more challenging conditions in the short term. Nevertheless, the company intends to remain committed to its K-C Strategy 2022 and anticipates strengthening its market position. Also, savings from the 2018 Global Restructuring and Focus on Reducing Costs Everywhere programs have been offering respite.

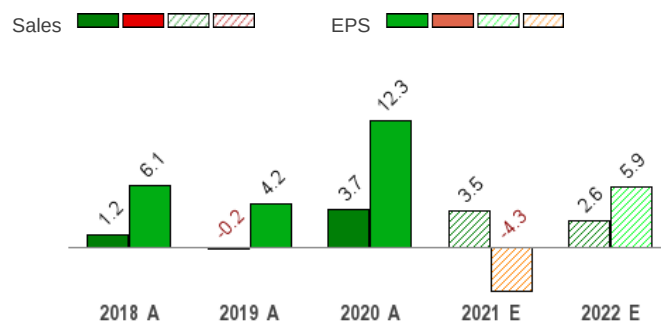

Overview

Incorporated in Delaware in 1928, Kimberly-Clark Corporation is principally engaged in the manufacture and marketing of a wide range of consumer products around the world. The company sells its products to supermarkets; mass merchandisers; drugstores; warehouse clubs; variety and department stores; retail outlets; manufacturing, lodging, office building, food service, and health care establishments; and high volume public facilities.

Based on product grouping, the company conducts its operations in three business segments namely Personal Care, Consumer Tissue, and K-C Professional.

The Personal Care segment includes products like disposable diapers, training and youth pants, swimpants, baby wipes, feminine and incontinence care products, and other related products. Products in this segment are sold under the Huggies, Pull-Ups, Little Swimmers, GoodNites, DryNites, Kotex, U by Kotex, Intimus, Depend, Plenitud, Poise and other brand names. Sales from this segment constituted 49% of the top line in full-year 2020.

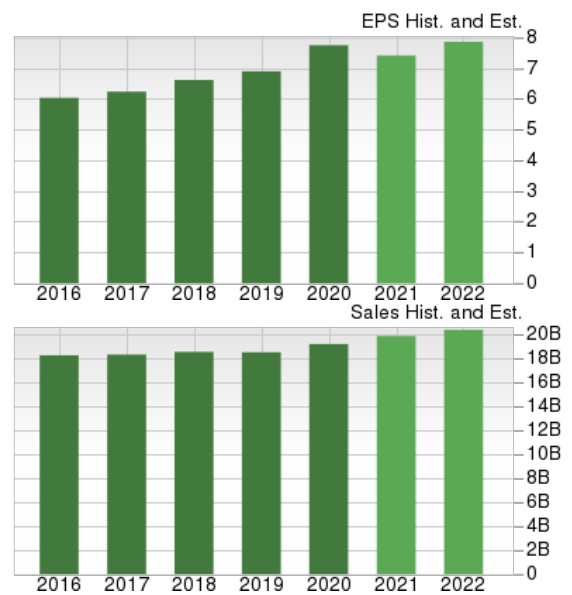
The Consumer Tissue segment includes facial and bathroom tissue, paper towels, napkins and related products, which are sold under the Kleenex, Scott, Cottonelle, Viva, Andrex, Scottex, Neve and other brand names. Sales from this segment constituted about 35% of the top line in full-year 2020.

The K-C Professional segment consists of apparel, wipers, soaps, sanitizers, tissue and towels. Key brands in this segment include Kleenex, Scott, WypAll, Kimtech and Jackson Safety. Sales from this segment formed approximately 15.7% of the top line in full-year 2020.

The Corporate and Other segment contributed 0.3% of full-year 2020 sales.

The company's health care business was spun-off on Oct 31, 2014.

Notably, Kimberly-Clark's net sales to Walmart constituted around 19% of its consolidated sales in 2019, 2018 as well as 2017.



Reasons To Sell:

- ▼ **Soft Q1 Results, 2021 Outlook Lowered:** Shares of Kimberly-Clark have declined 2% in the past three months against the industry's growth of 1.9%. The company reported dismal first-quarter 2021 results, with the top and the bottom line declining year over year and missing the Zacks Consensus Estimate. Unfavorable year-over-year comparisons owing to pandemic-led stock piling during the prior-year quarter, declines in consumer tissue category as well as commodity inflation affected the quarterly results. Also, some temporary supply chain disruptions were deterrents.

The company is encountering high manufacturing costs, including coronavirus-related expenses. Also, input cost inflation is a concern.

Notably, adjusted earnings came in at \$1.80 per share, which declined from \$2.13 per share in the year-ago quarter. Quarterly sales declined 5% while organic sales fell 8%. Further, volumes were down 10%, while the metric had increased more than 8% in the year-ago quarter. First-quarter volumes were compared against increased shipments owing to stock-piling amid the coronavirus outbreak during the year-ago quarter. During 2021, volumes in North American consumer products were adversely affected due to supply chain disruptions thanks to severe weather conditions in the southern part of the United States through February.

On its last earnings call, management updated its 2021 outlook to account for more challenging and volatile conditions in the short term. The company now expects 2021 net sales to grow 3-5% year over year. Earlier, management had anticipated the metric to increase 4-6%. Organic sales are now likely to remain flat to up 1% in 2021. Prior to this, the company had guided an increase of 1-2% of organic sales. Further, management now expects adjusted operating profit to decline in the range of 3-6%. Earlier, the metric was anticipated to range from flat to a 2% increase. Finally, the company now envisions 2021 adjusted earnings per share of \$7.30-\$7.55, down from the previous outlook of \$7.75-\$8. Notably, the metric came in at \$7.74 in 2020. The company's updated 2021 earnings guidance reflects increased input cost inflation and reduced sales volumes, somewhat offset by increase in net selling prices and greater cost savings.

- ▼ **Softness in K-C Professional Unit:** The company's K-C Professional segment sales have been declining year over year for a while now due to hurdles related to coronavirus. In the first quarter of 2021, segment sales fell 11% to \$752 million. Volumes were down 21% due to reduced away-from-home demand and tough business conditions. Sales fell 8% in North America and 18% in developing and emerging markets across the segment. The metric dropped 14% in developed markets outside North America. Further, operating profit in the segment came in at \$126 million, down 30% thanks to reduced volumes as well as escalated input and other manufacturing costs. Clearly, sluggishness in the K-C Professional segment is a threat to the company's performance.
- ▼ **Escalated Cost Concerns:** The company has been encountering high input costs and escalated other manufacturing expenses, including coronavirus-related costs, for the past few quarters. In the first quarter, adjusted operating profit came in at \$804 million, down from \$997 million in the year-ago quarter, thanks to a rise in input costs (to the tune of \$135 million) as well as reduced sales volumes. Higher pulp, other materials and distribution costs led to rise in input costs. Also, rise in other manufacturing costs like costs related to COVID-19 and inefficiencies from lower production volumes coupled with unfavorable foreign currency rates caused the downside. For 2021, management expects commodity inflation in the range of \$900-\$1,050 million. The projection is likely to be driven by polymer-based materials and pulp.
- ▼ **Competitive Pressure:** Kimberly-Clark operates in an intensely competitive market, both domestically and internationally. The company faces competition from renowned branded products as well as private-label or cheaper alternatives. The company's diaper business particularly faces significant competitive activity, which puts the company's market share at risk.

Risks

- **2018 Global Restructuring & FORCE Programs Drive Savings:** Kimberly-Clark has been taking robust steps to lower costs. This is highlighted by the 2018 Global Restructuring Program as well as the Focus on Reducing Costs Everywhere or FORCE Program. The 2018 Global Restructuring Program marks the company's biggest restructuring in a long time now. The program is focused on lowering the company's structural costs and improving financial flexibility. As part of this initiative, the company plans to sell or exit some low-margin businesses that deliver about 1% of net sales. Notably, Kimberly-Clark generated cumulative savings of \$465 million from this program, until the first quarter of 2021. Management anticipates annual pre-tax cost savings of \$540-\$560 million from the program by 2021-end.

Moreover, Kimberly-Clark is aggressively cutting costs and enhancing supply-chain productivity through its FORCE Program. The program is generating solid cost savings for a while which are in turn driving its performance. During the first quarter, the company generated cost savings of \$65 million and \$40 million from the FORCE Program and the 2018 Global Restructuring Program, respectively.

- **3 Growth Pillars:** Kimberly-Clark remains committed toward its three key strategic growth pillars. These include focus on improving its core business in the developed markets; speed up growth of Personal Care segment in developing and emerging markets and enhance digital and e-commerce capacities. The company expects to meet these objectives through product development across different categories and leveraging capabilities in marketing and sales. The company has been progressing well with these objectives, which have been aiding portfolio and expanding global business. Notably, Kimberly-Clark recently completed the acquisition of Softex Indonesia — a leading player in the Indonesian personal care market. The buyout is aimed at augmenting the company's market share in the personal care category in the Southeast Asia region. In fact, Kimberly-Clark's first-quarter sales received a 2% contribution from the buyout. Sales in the Personal Care segment were aided by 4% from Softex Indonesia during the quarter. Moreover, management expects Softex Indonesia acquisition to increase overall sales by 2% in 2021.
 - **K-C Strategy to Boost Growth:** Kimberly-Clark has been on track with its K-C Strategy 2022, which was introduced in January 2019. The strategy is focused on generating balanced and sustainable growth to return value to shareholders in a tough environment. The program also concentrates on strengthening the company's brand portfolio, undertaking efficient capital allocation and executing robust cost discipline. In extension, the strategy is aimed toward successfully meeting the aforementioned goals pertaining to FORCE and Global Restructuring as well as the company's three main strategic pillars. On its first-quarter earnings call, management stated that it intends to remain committed to its K-C Strategy 2022 and anticipates strengthening its market position.
 - **Financial Analysis:** Kimberly-Clark generated cash from operating activities of \$321 million during the first quarter of 2021. Further, the company repurchased 1.3 million shares for \$175 million in the quarter under review. Incidentally, its first quarter dividends and share repurchases amounted to \$535 million. The company expects the figure to amount to at least \$2.15 billion during 2021. Certainly, these aspects reflect Kimberly-Clark's commitment to return shareholder's wealth. The company has a dividend payout of 61.5%, a dividend yield of 3.5% and a free cash flow yield of 5%. With an annual free cash flow return on investment of 31.6%, ahead of the industry's 20.4%, the dividend payment is likely to be sustainable. Additionally, Kimberly-Clark posted long-term debt of \$7,548 million as of first-quarter 2021 (Mar 31, 2021) down from \$7,878 million reported in the preceding quarter.

Last Earnings Report

Kimberly-Clark Q1 Earnings Miss Estimates, Decline Y/Y

Kimberly-Clark reported dismal first-quarter 2021 results, with the top and the bottom line missing the Zacks Consensus Estimate as well as declining year over year.

Quarter in Detail

Adjusted earnings came in at \$1.80 per share, which missed the Zacks Consensus Estimate of \$1.90. Moreover, the bottom line declined from \$2.13 per share in the year-ago quarter.

Kimberly-Clark's sales came in at \$4,743 million, which missed the Zacks Consensus Estimate of \$4,941.2 and declined 5% year over year. Favorable currency movements lifted sales slightly, while the Softex Indonesia buyout boosted the metric by 2%. Organic sales fell 8% year over year. Volumes fell 10%, while the metric increased more than 8% in the year-ago quarter. Net selling prices and product mix both inched up 1% each.

First-quarter volumes are compared against increased shipments owing to stock-piling amid the coronavirus outbreak during the year-ago quarter. During 2021, volumes in North American consumer products were adversely affected due to supply chain disruptions thanks to severe weather conditions in the southern part of the United States through February.

In North America, organic sales in consumer products fell 10%, while it declined 8% in the K-C Professional segment. Internationally, organic sales fell 14% across developed markets and 1% in developing and emerging (D&E) markets.

Adjusted operating profit came in at \$804 million, down from \$997 million in the year-ago quarter, thanks to a rise in input costs (to the tune of \$135 million) as well as reduced sales volumes. Increased pulp, other materials and distribution costs led to rise in input costs. Also, rise in other manufacturing costs like costs related to COVID-19 and inefficiencies from lower production volumes coupled with unfavorable foreign currency rates caused the downside. Nevertheless, these were somewhat offset by increased net selling prices and cost savings of \$65 million and \$40 million from the FORCE (Focused On Reducing Costs Everywhere) program and the 2018 Global Restructuring Program, respectively.

Segment Details

Personal Care: Sales of \$2,462 million increased 2% year over year. Volumes fell nearly 3%, while product mix inched up 1%. Further, the Softex Indonesia buyout aided sales by 4%. However, unfavorable currency rates hurt sales by nearly 1%. Sales declined 7% in North America. Sales in D&E markets rose 12%. The metric rose 5% across developed markets outside North America.

Consumer Tissue: Segment sales of \$1,510 million fell 12% year over year including nearly 1% positive impact from currency rates. Volumes fell nearly 14% reflecting comparison with higher shipments during the last-year's quarter. Also, softness in the category during 2021 led to decline in volumes. Sales fell 14% in North America and 11% in D&E markets. The metric declined 10% in developed markets outside North America.

K-C Professional (KCP): Segment sales fell 11% to \$752 million. Volumes were down 21% due to reduced away-from-home demand and tough business conditions. Net selling prices and product mix rose 7% and 2%, respectively. Also, favorable currency rates contributed 1% to sales. Sales fell 8% in North America and 18% in D&E markets. The metric dropped 14% in developed markets outside North America.

Other Financial Updates

The company ended the quarter with cash and cash equivalents of \$320 million, long-term debt of \$7,548 million and stockholders' equity of \$746 million. Further, Kimberly-Clark generated cash from operating activities of \$321 million during the quarter under review. Management incurred capital expenditures of \$298 million. Kimberly-Clark repurchased 1.3 million shares for \$175 million in the first quarter.

The company is on track with the 2018 Global Restructuring Program, which is focused on lowering its structural costs and improving financial flexibility. As part of this initiative, the company plans to sell or exit some low-margin businesses that deliver about 1% of net sales. Notably, Kimberly-Clark generated cumulative savings of \$465 million from this program, until the first quarter of 2021. Management anticipates annual pre-tax cost savings of \$540-\$560 million from this program by 2021-end.

Recent News

Kimberly-Clark Hikes Product Price to Fight Cost Inflation – Mar 31, 2021

Kimberly-Clark said that it is notifying U.S. and Canada customers about plans to increase net selling prices for most of its North America consumer products business. Increasing commodity costs is exerting pressure on the company, leading to hike product prices. We note that percentage increase in prices will be in mid-to-high single digits. Almost all price hikes are expected to come into effect by the end of June. The hike will be carried out via changes in list prices. Incidentally, Kimberly-Clark's baby and child care, adult care and Scott bathroom tissue businesses will be affected by this move.

Valuation

Kimberly-Clark shares are down 4% in the year-to-date period and 6.9% over the trailing 12-month period. Stocks in the Zacks sub-industry are up 7.9% in the year-to-date period, while the Zacks Consumer Staples sector has gained 3.7%. Over the past year, the Zacks sub-industry is down 4.9%, while the sector gained 21.5%.

The S&P 500 index is up 12.4% in the year-to-date period and 45.3% in the past year.

The stock is currently trading at 16.89X forward 12-month earnings, which compares to 24.6X for the Zacks sub-industry, 20.62X for the Zacks sector and 22.98X for the S&P 500 index.

Over the past five years, the stock has traded as high as 21.81X and as low as 13.93X, with a 5-year median of 18.43X. Our Underperform recommendation indicates that the stock will perform worse than the market. Our \$111 price target reflects 14.4X forward 12-month earnings.

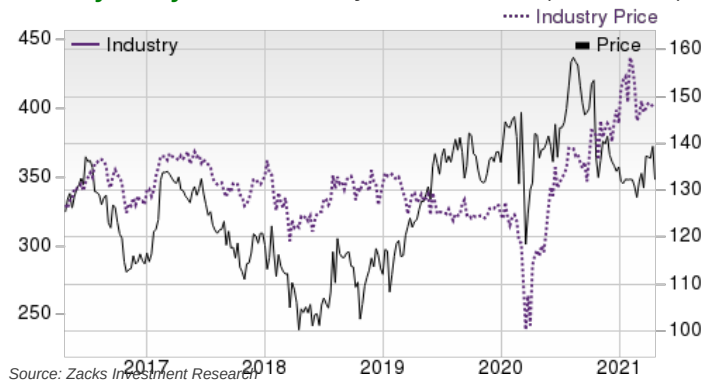

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
