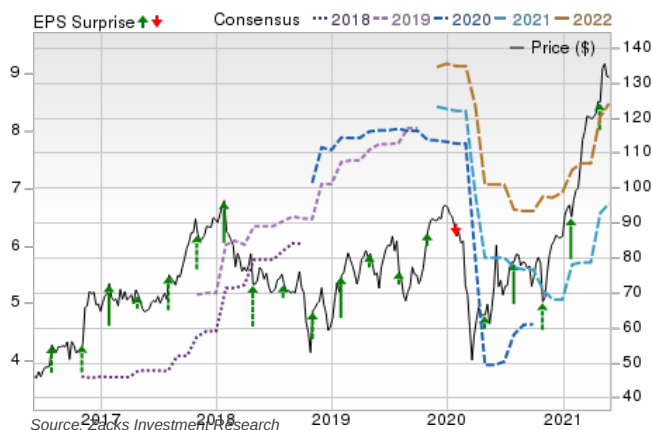

Summary

Shares of Oshkosh have outperformed the industry over the past year. Acquisition of Pratt Miller will help Oshkosh navigate to the untapped market of uncrewed ground vehicles, thereby fueling its prospects. Also, the 10-year contract from the United States Postal Service positions the company well for growth. Solid backlogs across Defense and Fire & Emergency segments provide enough visibility into 2021 and beyond. Upbeat guidance for fiscal 2021 sparks optimism. Fiscal 2021 revenues are forecast in the range of \$7.75-\$7.95 billion, higher than \$6.8 billion generated in fiscal 2020. Healthy balance sheet and investor friendly moves of the firm boost investor confidence. Collaboration with Microvast is likely to strengthen Oshkosh's electrification capabilities. Amid the tailwinds, the stock warrants a bullish stance at the moment.

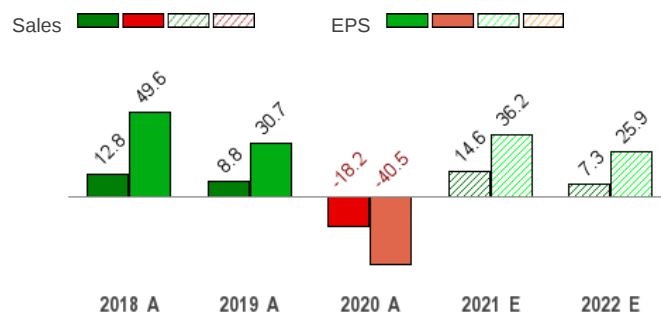
Price, Consensus & Surprise

Overview

Established in 1917, WI-based Oshkosh Corporation is a designer, manufacturer and seller of a varied range of vehicle bodies and specialty vehicles. The primary markets, which the company caters to, consist of defense, concrete placement, refuse hauling, access equipment, and fire and emergency. A few of the major brands that it offers include ??? Oshkosh, JLG, Pierce, McNeilus, IMT, Frontline, Jerr-Dan, CON-E-CO and London. Oshkosh has manufacturing operations in Australia, Canada, China, France, Mexico, Romania and the United Kingdom, apart from the seven states of the United States.

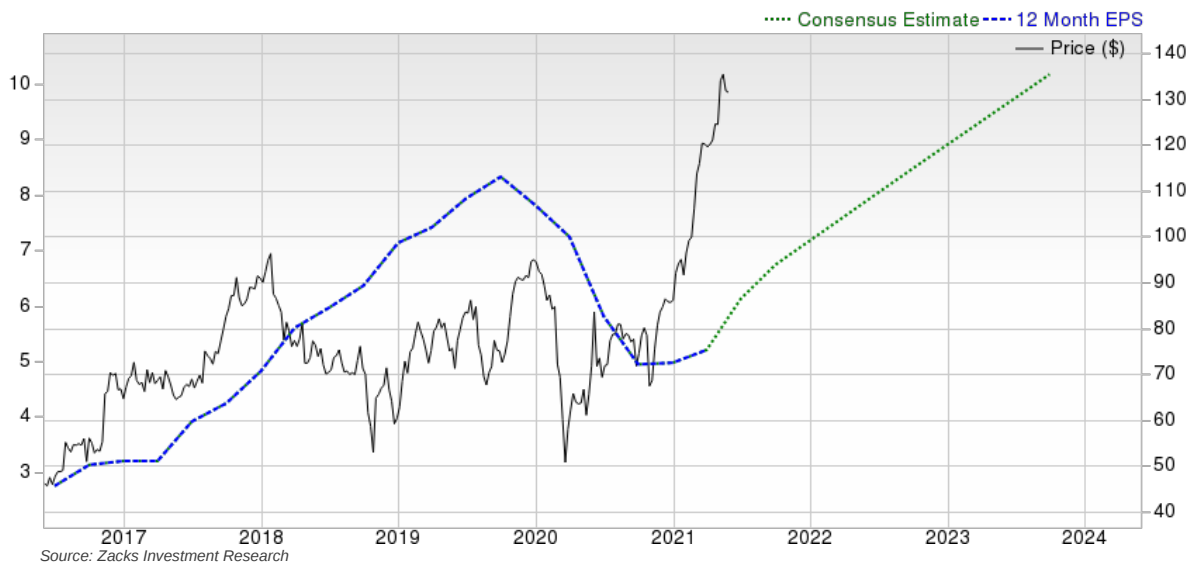
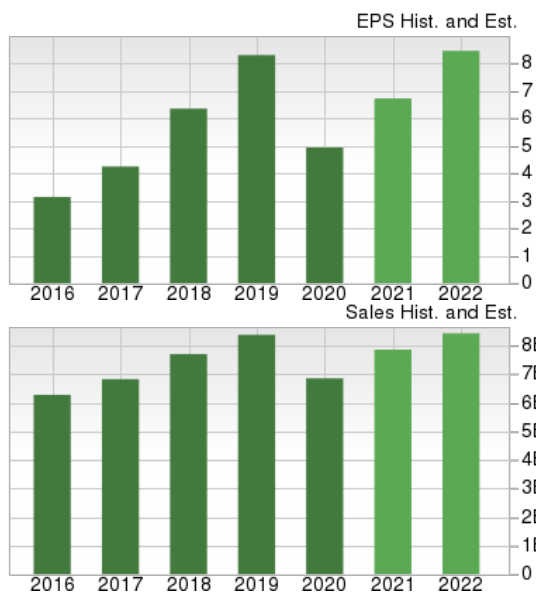
The four reportable segments of Oshkosh are-

Access Equipment (contributed 34.5% in consolidated net sales in fiscal 2020) - The segment operates under JLG and Jerr-Dan brands. JLG engages in the designing and manufacturing of aerial work platforms and telehandlers that are used for construction, industrial, institutional and general maintenance applications. JLG???'s customer base consists of equipment rental companies, construction contractors, manufacturing companies and home improvement centers. Further, Jerr-Dan offers tow trucks (wreckers) and roll-back vehicle carriers that cater towing companies in the United States and abroad.

Defense (33.9%) unit designs, manufactures and markets military tactical wheeled vehicles. Oshkosh Defense offers a wide range of products, which include severe-duty, heavy- and medium-payload tactical trucks, hauling tanks, missile systems, ammunition, fuel, troops, and cargo for combat units.

The Fire & Emergency (17.7%) unit manufactures custom and commercial firefighting vehicles and equipment, simulators, and firefighting (ARFF) vehicles. Its products are sold to fire departments, airports and other governmental units in the United States and abroad.

The Commercial (13.9%) segment produces concrete mixers, refuse collection vehicles, and portable and stationary concrete batch plants for commercial and municipal waste haulers across the globe. Additionally, it manufactures field service vehicles and truck-mounted cranes that caters mining and construction.



Reasons To Buy:

- ▲ Acquisition of Pratt Miller , which closed in January 2021, will help Oshkosh navigate to the untapped market of uncrewed ground vehicles and establish a robust foothold there, enhancing its offerings. Moreover, the combination of Pratt Miller's engineering specialty with Oshkosh's innovation and operational efficiency will enable the latter to better serve customers and fuel its long-term growth.
- ▲ Solid backlogs across the Defense, and Fire & Emergency segments bode well for Oshkosh, providing enough visibility for growth into 2021 and beyond. At the end of the second quarter fiscal 2021, backlog for the Fire & Emergency unit totaled \$1.3 billion. Backlog for the Defense segment stood at \$3.5 billion, providing solid visibility into 2022. Massive JLTV order worth \$911 million, clinched on December 2020, provides a robust base for its Defense segment, in turn, brightening the prospects.
- ▲ Upbeat guidance for fiscal 2021 sparks optimism. Revenues are forecast in the range of \$7.75-\$7.95 billion, higher than \$6.8 billion generated in fiscal 2020. Oshkosh estimates year-over-year sales increase across every segment except Commercial unit. Adjusted operating income for fiscal 2021 is envisioned in the band of \$610-\$655 million, implying growth from \$496 million recorded in fiscal 2020. Adjusted EPS projection of \$6.35-\$6.85 per share, implying a year over year uptick of 33.6% at the midpoint of the guided range.
- ▲ Collaboration with Microvast is likely to strengthen Oshkosh's electrification capabilities, buoying its future prospects. Also, the company's recent 10-year contract from the USPS to modernize the latter's fleet of postal delivery vehicles, positions the company well for growth. Encouragingly, construction of the firm's facility in Tianjin China is mostly completed with shipping expected to commence later this year. The expanded operations is set to drive the firm's profitability in China and other markets in Asia.
- ▲ Healthy balance sheet and investor friendly moves boost investor confidence. High liquidity and low leverage increase the financial flexibility of the firm. Its total debt-to-capital ratio stands at 0.21, lower than its industry's 0.4. Oshkosh engages in regular dividend payouts in almost every quarter, making it a safe stock for income investors. Its ROE of 12.18% compares favorably with the auto sector's 6.3%, reflecting management's effectiveness in returning shareholder value.

Solid backlogs across the Defense, and Fire & Emergency segments bode well. Further, healthy balance sheet increases financial flexibility.

Risks

- Oshkosh is facing a significant rise in raw material costs, especially steel. The firm expects higher steel cost to introduce additional headwinds for the latter half of 2021. Moreover, other material costs, freight rates and unstable foreign currency are increasing expenses, thereby limiting margins.
 - Lower year over year revenues and operating margin from Commercial segment are likely to dent overall results. The company expects fiscal 2021 sales and operating margin from the unit at \$925 million and 7%, respectively, reflecting a decline from \$957.8 million and 8.4%, respectively.
 - Supply chain issues arising from the global chip crunch is likely to play spoilsport. The company expects supply chain to pose concerns for Commercial and Access Equipment units. It anticipates uncertainty in the availability of third-party chassis from truck manufacturers as a result of semiconductor and other component shortages that could impact deliveries in the latter half of 2021.
 - The technology change will require Magna to make substantial amounts of investment and capital spending in order to evolve its business profile towards new products. Capex projection for fiscal 2021 stands at \$120 million, higher than year-ago levels. While investments in technology, including the development of battery electric products, will create opportunities for long term growth, it is likely to strain near-term margins.

Last Earnings Report

Oshkosh's Q2 Earnings Top Mark, Up Y/Y

Oshkosh reported second-quarter fiscal 2021 (ended Mar 31, 2021) adjusted earnings of \$1.48 per share, up from \$1.25 recorded in the year-ago period. Moreover, fiscal second-quarter earnings surpassed the Zacks Consensus Estimate of \$1.15. This outperformance primarily stemmed from higher-than-anticipated revenues and operating income from the Access Equipment and Fire & Emergency segments of the company.

For the reported quarter, consolidated net sales edged up 5.1% from the prior-year period to \$1,889 million. The top line also surpassed the Zacks Consensus Estimate of \$1,755 million.

For the fiscal second quarter, consolidated operating income rose 5.4%, year over year to \$140.8 million (accounting for 7.5% of sales).

Segmental Details

For the March-end quarter, net sales in Access Equipment grew 6.5% year over year to \$738.2 million on improved market demand in North America and Asia. The metric also topped the consensus estimate of \$639 million. Operating income surged 13.7% from the prior-year quarter to \$80.5 million (10.9% of sales) and surpassed the consensus mark of \$58 million. This upside primarily resulted from higher sales volumes and revenues, improved product mix as well as lower spending.

The Defense segment's net sales slipped 2.6% year on year to \$614.7 million for the fiscal second quarter owing to lower volumes. The sales figure, however, surpassed the consensus mark of \$600 million. Operating income dipped 40.5% from the prior-year figure to \$35.5 million (5.8% of sales). The decline chiefly resulted from a decrease in the cumulative catch-up adjustment on contract margins and higher new product development spending.

Net sales in the Fire & Emergency segment totaled \$312.5 million, outpacing the Zacks Consensus Estimate of \$275 million. The reported figure also increased 29% year over year. This uptrend resulted from higher aircraft rescue and firefighting vehicle volume as a series of multi-unit international awards were recognized in the reported quarter. In fact, higher sales volume and reduced spending as a result of the pandemic boosted the segment's operating income by 149.5% year on year to \$47.4 million (15.2% of sales). The metric also topped the consensus mark of \$30.98 million.

Net sales in the Commercial segment inched down 2.8% from the year-ago figure to \$230 million for the fiscal second quarter on lower refuse collection vehicle demand amid the coronavirus pandemic and negative impact of the sale of the concrete batch plant business in fourth-quarter fiscal 2020. The segment's operating income, however, jumped 132.1% from the prior-year period to \$18.8 million (8.2% of sales), chiefly due to lower warranty costs, reduced spending and low product liability costs.

Financials & Dividend

Oshkosh had cash and cash equivalents of \$1,093.2 million as of Mar 31, 2021. The company recorded a long-term debt of \$818.3 million as of Mar 31, 2021. Net cash provided by operating activities for the three-month period ended Mar 31, 2021 was \$326.8 million.

Oshkosh's board announced a quarterly cash dividend of 33 cents per share for shareholders. The dividend amount will be paid on May 28 to shareholders of record as of May 14, 2021.

FY21 View

The company expects fiscal 2021 adjusted EPS in the band of \$6.35-\$6.85 per share. Revenues are forecast in the range of \$7.75-\$7.95 billion. Adjusted operating income is envisioned between \$610 million and \$655 million.

Valuation

Oshkosh's shares are up 52.7% and 80.3% year to date and in the trailing 12-month period, respectively. Year to date, stocks in the Zacks Automotive - Original Equipment industry and the Zacks Automotive sector are down 9.1% and 1.4%, respectively. Over the past year, the Zacks sub industry and sector are up 21.7% and 79.6%, respectively.

The S&P 500 index is up 12.6% and 38.5% year to date and in the past year, respectively.

The stock is currently trading at 16.66X forward 12-month earnings, which compares to 19.4X for the Zacks sub-industry, 21.59X for the Zacks sector and 21.85X for the S&P 500 index.

Over the past five years, the stock has traded as high as 21.86X and as low as 6.38X, with a 5-year median of 14.07X. Our Outperform recommendation indicates that the stock will perform better than the market. Our \$151 price target reflects 19.16X forward 12-month earnings per share.

Zacks Recommendation

The Zacks Recommendation aims to predict performance over the next 6 to 12 months. The foundation for the quantitatively determined Zacks Recommendation is trends in the company's estimate revisions and earnings outlook. The Zacks Recommendation is broken down into 3 Levels; Outperform, Neutral and Underperform. Unlike many Wall Street firms, we maintain a balance between the number of Outperform and Neutral recommendations. Our team of 70 analysts are fully versed in the benefits of earnings estimate revisions and how that is harnessed through the Zacks quantitative rating system. But we have given our analysts the ability to override the Zacks Recommendation for the 1200 stocks that they follow. The reason for the analyst over-rides is that there are often factors such as valuation, industry conditions and management effectiveness that a trained investment professional can spot better than a quantitative model.

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
