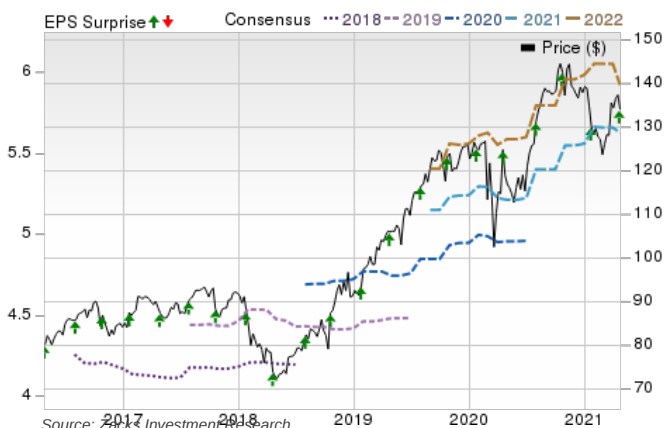

Summary

Shares of Procter & Gamble have outpaced the industry in a year on its robust earnings trend, which continued in third-quarter fiscal 2021. While it has reported earnings surprise for the past several quarters, revenues topped estimates for the fourth straight time in the fiscal third-quarter. Earnings were aided by robust top-line growth and improved margins. Productivity savings and higher pricing aided margins, while strength across all segments along with robust pricing and mix boosted sales. Adjusted free cash flow productivity was 106% in the fiscal third quarter. The company raised its free cash flow productivity target to more than 100% for fiscal 2021. However, SG&A deleverage partly hurt margins in the reported quarter. Also, currency headwinds and pandemic-related disruptions are likely to affect fiscal 2021 results to some extent.

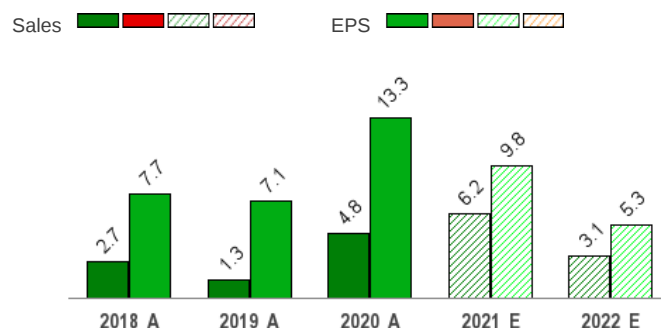
Price, Consensus & Surprise

Overview

Headquartered in Cincinnati, OH, The Procter & Gamble Company, also referred to as Procter & Gamble or P&G, is a branded consumer products company which markets its products in more than 180 countries primarily through mass merchandisers, grocery stores, membership club stores, drug stores, department stores, distributors, baby stores, specialty beauty stores, e-commerce, high frequency stores and pharmacies. It has operations in approximately 70 countries. The company has five reportable segments:

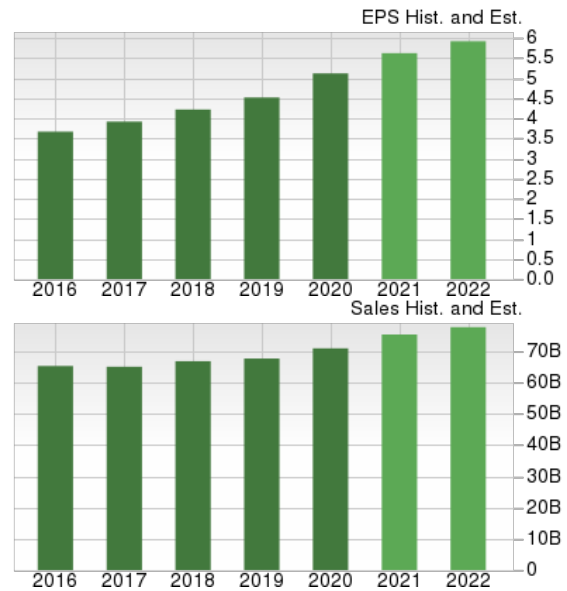
Beauty (18.8% of fiscal 2020 revenues): The segment includes hair care products (conditioner, shampoo, styling aids treatments) antiperspirants and deodorants as well as products for personal cleansing and skin care. Billion Dollar Brands include Head & Shoulders, Olay, Pantene, Old Spice, Safeguard, and SK-II. In Oct 2016, P&G completed its last major step in portfolio transformation with the Beauty Brands divestiture to Coty Inc.

Grooming (8.5%): The segment includes Shave Care products like female and male blades & razors and pre- and post-shave products as well as appliances. Billion Dollar Brands under this segment include Fusion, Gillette, Prestobarba and Mach3.

Health Care (12.7%): The segment includes gastrointestinal, rapid diagnostics, respiratory, vitamins/minerals/supplements and other personal health care product categories along with toothbrush, toothpaste and other oral care, product categories. Billion Dollar Brands include Crest, Oral-B and Vicks.

Fabric and Home Care (33.4%): The segment includes air care, dish care, fabric enhancers, laundry additives and detergents, P&G Professional and surface care product categories. Billion Dollar Brands under this segment are Ariel, Dawn, Downy, Febreze, Gain and Tide. P&G completed sale of its Duracell (Batteries) business to Berkshire Hathaway in exchange for Berkshire's equity stake in P&G in Feb 2016.

Baby, Feminine and Family Care (25.8%): The segment includes baby wipes, diapers and pants, paper towels, tissues, toilet paper, adult incontinence and feminine care products. Billion Dollar Brands include Always, Bounty, Charmin and Pampers.



Reasons To Buy:

▲ **Robust Earnings Trend:** Shares of Procter & Gamble have gained 12.3% in the past year compared with the industry's growth of 1.6%. The company's shares have been benefiting from its robust earnings and sales surprise trend, which continued in the third quarter of fiscal 2021. While the company has reported an earnings surprise for the more than three years, revenues topped estimates for the fourth straight time in third-quarter fiscal 2021. Further, the company's earnings and sales improved on a year over year basis in the fiscal third quarter. Earnings growth was driven by robust top-line growth as well as improved operating margin. Sales benefited from strength across all segments coupled with robust pricing and mix. Net sales for the Beauty and Fabric & Home Care segments rose 9% and 8%, respectively, and sales for the Health Care and Grooming segments grew 4% each. Meanwhile, sales for the Baby, Feminine and Family Care segment remained flat year over year. Productivity savings and higher pricing aided margins, which boosted the bottom line.

Procter & Gamble anticipates all-in and organic sales growth of 5-6% each, with earnings per share, on a reported basis, expected to increase 8-10% in fiscal 2021.

▲ **Upbeat View:** Driven by the robust year-to-date performance, Procter & Gamble retained its guidance for fiscal 2021. The company anticipates all-in and organic sales growth of 5-6% each. Earnings per share on a reported basis are expected to increase 8-10%, whereas it reported \$4.96 in fiscal 2020. The GAAP EPS guidance takes into account non-core charges of 16 cents per share for fiscal 2021 due to the early debt retirement. Core earnings per share for fiscal 2021 are projected to grow 8-10%, whereas it earned \$1.52 in fiscal 2020.

▲ **Strategies & Brand Strength Aid Organic Sales:** Procter & Gamble's products play a key role in meeting the daily health, hygiene and cleaning needs of consumers around the world. This led to increased consumer demand for its hand soaps, detergents and surface cleaning products during the pandemic. The company witnessed continued strong momentum in the fiscal second quarter as reflected by underlying strength in brands and appropriate strategies, which aided organic sales growth. On an organic basis (excluding the impact of acquisitions, divestitures and foreign exchange), revenues improved 4%, backed by two percentage points of gains each in pricing and mix. The company reported a positive mix, owing to uneven growth of premium Home Care, Oral Care and Appliances categories along with strength in North America and Greater China regions. Shipment volumes were flat year over year.

Notably, all of the company's business segments reported growth in organic sales, except for the Baby, Feminine and Family Care segment. Organic sales moved up 7% in Beauty, 4% in Grooming, 3% in Health Care, and 7% in Fabric & Home Care. However, organic sales declined 1% in Baby, Feminine and Family Care. Additionally, organic sales growth was mixed across markets, with strong growth reported in its two largest markets. Notably, organic sales were up 7% in the United States and 22% in Greater China. Overall organic sales in the focus markets improved 5%, while the enterprise markets were up 1%. Also, e-commerce sales increased nearly 50% for the first nine months of fiscal 2021. E-commerce sales represented 14% of global sales, reflecting aggregate market share growth of 40 bps in the fiscal third quarter.

▲ **Cost Savings and Productivity Program Aid Margins:** Procter & Gamble remains focused on productivity and cost-saving plans to boost margins. The company's continued investment in business alongside efforts to offset macro cost headwinds and balance top and bottom-line growth underscores its productivity efforts. The company is witnessing cost savings and efficiency improvements across all facets of business driven by its second five-year (fiscal 2017-2021) \$10 billion productivity program. The second five-year restructuring plan targets cutting costs in areas including supply chain and cost of goods sold (COGS), marketing and digitization and promotional spend effectiveness. This plan comprises \$7 billion in COGS savings (\$4.5 billion from raw and packaging materials, \$1.5 billion in manufacturing savings and \$1 billion from transportation/warehousing/other); \$2 billion of marketing cost reductions; \$1.5 billion of trade spending savings (10% efficiency); and \$1-\$2 billion of additional overhead reductions. This brings the total potential savings to \$12-\$13 billion. However, P&G adjusted the level down to up to \$10 billion to take into account the uncertainty associated with operations, especially when projecting out several years.

Notably, the company's core currency-neutral gross and operating margins reflected significant gains from productivity savings and pricing in third-quarter fiscal 2021. Core gross margin (on a currency-neutral basis) expanded 80 basis points (bps) owing to benefits from gross productivity savings and higher pricing. Core currency-neutral operating margin expanded 30 bps in the reported quarter, including 210 bps of total productivity cost savings.

▲ **Strong Free Cash Flows & Shareholder Returns:** Procter & Gamble generates strong free cash flow annually. Cash flow provides management the opportunity to invest in product innovations, acquisitions and brand development in addition to regularly paying dividends and repurchasing shares. Notably, the company generated operating cash flow of \$4.1 billion in the fiscal third quarter. Moreover, adjusted free cash flow productivity was 106%. Furthermore, the company returned \$5 billion of cash to its shareholders in the fiscal third quarter. This included \$2 billion of dividend payouts and \$3 billion of share buybacks. In April 2021, the company raised its quarterly dividend by 10%.

The company ended the fiscal third quarter with long-term debt of \$21,053 million, down 6.5% sequentially. Its debt to capitalization ratio stands at 0.39, reflecting a sequential decline from 0.43. Adjusted free cash flow productivity is now estimated to be more than 100% for fiscal 2021 compared with 95-100% mentioned earlier. In addition to this, the company now anticipates returning more than \$19 billion of cash to shareholders in fiscal 2021 compared with \$18 billion stated earlier. It plans to make dividend payments of more than \$8 billion in fiscal 2021. The company now expects a share repurchase of up to \$10-\$11 billion for fiscal 2021 compared with \$10 billion stated earlier.

Reasons To Sell:

- ▼ **Valuation Looks Stretched:** Considering price-to-earnings (P/E) ratio, Procter & Gamble looks overvalued when compared with the industry. The stock has a trailing 12-month P/E ratio of 23.07x, which is below the median level of 24.43x and the high level of 27.44x scaled in the past year. On the contrary, the trailing 12-month P/E ratio for the industry is 18.94x. Given these factors, we believe that the stock is stretched from the P/E aspect.
- ▼ **Higher Cost:** In third-quarter fiscal 2021, Procter & Gamble's selling, general and administrative expenses (SG&A), as a percentage of sales, rose 30 bps from the year-ago quarter's core SG&A expenses to 29.8%. The metric also increased 50 bps on a currency-neutral basis. This can be attributable to 150 bps of marketing reinvestments, and 110 bps of inflation and other costs, offset by a 120-bps gain from sales leverage, and 90 bps of productivity savings from lower overhead and marketing costs.

Although Procter & Gamble provided an encouraging view for fiscal 2021, core earnings per share guidance includes an impact of more than \$200 million from higher freight cost. Also, it now expects headwinds of \$125 million from commodity costs.

- ▼ **Currency Headwinds:** Procter & Gamble's significant international presence exposes it to foreign currency risks, which have been weighing on the company's performance. Apparently, gross margin, SG&A expense rate and operating margin reflected adverse impacts of 50 bps, 20 bps and 30 bps, respectively, from foreign currency in the fiscal third quarter. Currency movements are likely to remain neutral to sales growth in fiscal 2021. Also, the fiscal 2021 core earnings per share view takes into account an after-tax headwind of \$150 million due to currency woes.
- ▼ **COVID-19 Related Disruptions:** Procter & Gamble is not immune to the COVID related headwinds that are affecting companies worldwide. In the fiscal third quarter, the company witnessed headwinds like increased virus spread in some markets due to reopening, renewed lockdowns and severe economic impacts. Additionally, currency and commodity volatility, challenges related to the blockage of Suez Canal, transportation demand mismatched with supply, and very mild cough and cold season, were other headwinds that persisted in the quarter. Going forward, the company expects the headwinds related to the spike in cases in many countries to remain a headwind. Further, it expects high supply chain disruptions and channel closures to continue. These headwinds might impact the company's otherwise strong forecasts to some extent.
- ▼ **Competitive Pressure:** Procter & Gamble faces intense competition from other well-established players in the consumer products industry, such as Colgate-Palmolive, Clorox, and Church & Dwight on the basis of pricing, promotional activities and new product introductions. The failure to offer exclusive high-quality products at competitive prices may hamper the company's market share.

Procter & Gamble expects the headwinds related to the spike in cases in many countries to remain a headwind. Further, it expects high supply chain disruptions and channel closures to continue.

Last Earnings Report

Procter & Gamble Beats Q3 Earnings & Sales Estimates

Procter & Gamble has posted better-than-expected third-quarter fiscal 2021 results, wherein both earnings and sales improved year over year. Results have been driven by robust top-line growth as well as improved margins. Encouragingly, management has reiterated its outlook for fiscal 2021.

Procter & Gamble's earnings of \$1.26 per share rose 8% from core earnings of \$1.17 per share in the year-ago quarter. It also outpaced the Zacks Consensus Estimate of \$1.19 on the back of sturdy sales growth and improved operating margin. Meanwhile, currency-neutral core earnings per share (EPS) also increased 8%.

The company reported net sales of \$18,109 million, increasing 5% year over year and surpassing the Zacks Consensus Estimate of \$17,837 million. Sales growth was attributed to strength across all segments coupled with robust pricing and mix.

Net sales for the Beauty and Fabric & Home Care segments rose 9% and 8%, respectively, and sales for the Health Care and Grooming segments grew 4% each. Meanwhile, sales for the Baby, Feminine and Family Care segment remained flat year over year.

On an organic basis (excluding the impacts of acquisitions, divestitures and foreign exchange), revenues improved 4%, backed by two percentage points of gains each in pricing and mix. The company reported a positive mix, owing to uneven growth of premium Home Care, Oral Care and Appliances categories along with strength in North America and Greater China regions. Shipment volumes were flat year over year.

Moreover, all of the company's business segments reported growth in organic sales, except for the Baby, Feminine and Family Care segment. Organic sales moved up 7% in Beauty, 4% in Grooming, 3% in Health Care, and 7% in Fabric & Home Care. However, organic sales declined 1% in Baby, Feminine and Family Care.

Margins

In the reported quarter, gross margin expanded 30 basis points (bps) to 50.7% from the prior-year core gross margin. On a currency-neutral basis, gross margin expanded 80 bps from the prior-year core gross margin, owing to the benefits from productivity savings and higher pricing. This was partly offset by an increase in commodity costs, unfavorable product mix, product investments and other costs.

Selling, general and administrative expenses (SG&A), as a percentage of sales, rose 30 bps from the year-ago quarter's core SG&A expenses to 29.8%. Adverse currency negatively impacted SG&A expenses by 20 bps. The metric increased 50 bps on a currency-neutral basis. This can be attributable to 150 bps of marketing reinvestments, and 110 bps of inflation and other costs, offset by a 120-bps gain from sales leverage, and 90 bps of productivity savings from lower overhead and marketing costs.

Moreover, the operating margin was flat at 20.9% from the year-ago quarter's core operating margin. Unfavorable currency hurt operating margin by 30 bps. On a currency-neutral basis, the operating margin improved 30 bps, driven by 210 bps of total productivity cost savings.

Financials

Procter & Gamble ended the reported quarter with cash and cash equivalents of \$10,007 million, long-term debt of \$21,053 million, and total shareholders' equity of \$46,919 million.

The company generated operating cash flow of \$4.1 billion in third-quarter fiscal 2021. Moreover, free cash flow productivity was 106%.

Furthermore, the company returned \$5 billion of cash to its shareholders in the fiscal third quarter. This included \$2 billion of dividend payouts and \$3 billion of share buybacks. In April 2021, the company raised its quarterly dividend by 10%.

Fiscal 2021 Guidance

Management retained its guidance for fiscal 2021. The company anticipates all-in and organic sales growth of 5-6% each. Currency movements are likely to remain neutral to sales growth in fiscal 2021.

Further, EPS on a reported basis are expected to increase 8-10%, whereas it reported \$4.96 in fiscal 2020. The GAAP EPS guidance takes into account non-core charges of 16 cents per share for fiscal 2021 due to the early debt retirement.

Core EPS for fiscal 2021 are projected to grow 8-10%, whereas it earned \$1.52 in fiscal 2020. The view takes into account an after-tax headwind of \$150 million due to currency woes, and more than \$200 million from higher freight costs. For fiscal 2021, the company now expects headwinds of \$125 million from commodity costs.

Adjusted free cash flow productivity is now estimated to be more than 100% for fiscal 2021 compared with 95-100% mentioned earlier. In addition to this, the company now anticipates returning more than \$19 billion of cash to shareholders in fiscal 2021 compared with \$18 billion stated earlier. It plans to make dividend payments of more than \$8 billion in fiscal 2021. The company now expects a share repurchase of up to \$10-\$11 billion for fiscal 2021 compared with \$10 billion stated earlier.

Procter & Gamble Declares Dividend – Apr 13, 2021

Procter & Gamble increased its quarterly dividend on Series A and B shares by 10% to 86.98 cents per share. Earlier, it paid a dividend of 79.07 cents per share on its shares of Series A and B. The raised dividend is payable on or after May 17 to shareholders with record as on Apr 23.

Valuation

Procter & Gamble shares are down 5.6% in the year to date period but up nearly 12.3% over the trailing 12-month period. Stocks in the Zacks sub-industry are down 14.4% but the Zacks Consumer Staples sector is up 4.5% in the year to date period. Over the past year, the Zacks sub-industry and the sector are up 1.6% and 23.2%, respectively.

The S&P 500 index is up 12.2% in the year to date period and 49.1% in the past year.

The stock is currently trading at 22.37X forward 12-month earnings, which compares to 22.06X for the Zacks sub-industry, 20.79X for the Zacks sector and 22.99X for the S&P 500 index.

Over the past five years, the stock has traded as high as 26.16X and as low as 16.02X, with a 5-year median of 21.83X. Our Neutral recommendation indicates that the stock will perform in-line with the market. Our \$138 price target reflects 23.52X forward 12-month earnings.

The reason for the analyst over-rides is that there are often factors such as valuation, industry conditions and management effectiveness that a trained investment professional can spot better than a quantitative model.

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. We also produce the VGM Score (V for Value, G for Growth and M for Momentum), which combines the weighted average of the individual Style Scores into one score. This is perfectly suited for those who want their stocks to have the best scores across the board.

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
