Summary

Shares of Ross Stores outpaced the industry in the past three months on improved trends in third-quarter fiscal 2020. It reported better-than-expected top and bottom lines in the fiscal third quarter, marking the second straight beat. Also, earnings improved year over year, while sales declined. Despite the decline, the quarter reflected significant sequential improvement in sales on better merchandise assortments, a delayed back-to-school season, gains from larger markets and a return to normal store hours. Additionally, it undertook actions to reduce ongoing debt costs and reduce interest expense and cash outlays for long term debt. However, the company's results were impacted by deleverage from lower comps and COVID-related costs, which is likely to continue. Initial comps in November declined mid-single digits, reflecting a slow start to Q4.

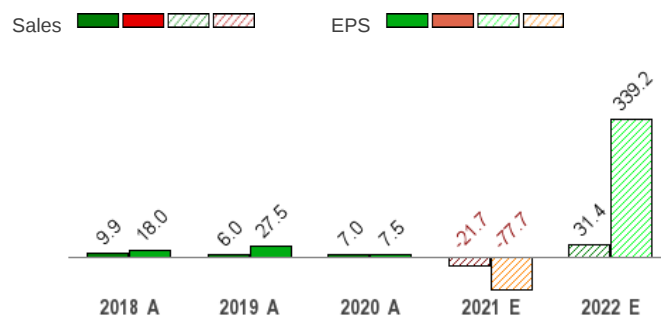

Overview

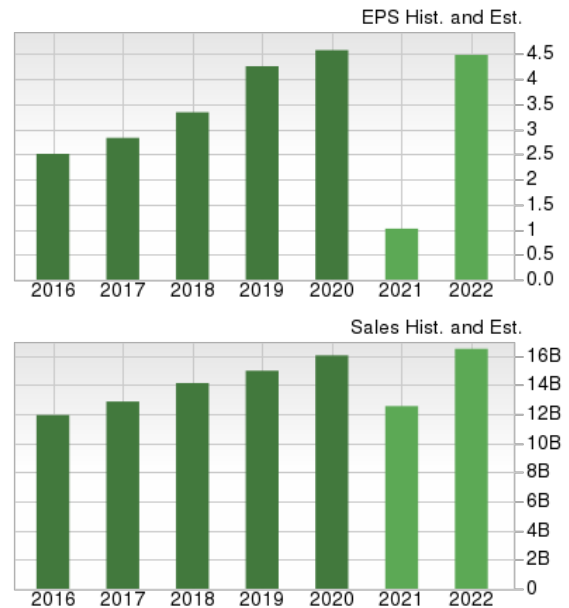
Based in Dublin, CA, Ross Stores Inc. operates as an off-price retailer of apparel and home accessories, primarily in the United States. The company operates its stores under the Ross Dress for Less (Ross) and dd's DISCOUNTS names. The company's stores are located mostly in community and neighborhood shopping centers in heavily populated urban and suburban areas.

Ross Stores primarily offers in-season, branded, and designer apparel, footwear, accessories and other home-related merchandise for everyone in the family. This format primarily targets middle-income households. Prices offered at Ross are generally 20% to 60% below the regular prices of most department and specialty stores.

dd's DISCOUNTS features more moderately-priced first-quality, in-season, name brand apparel, accessories, footwear, and home fashions for the entire family. These stores target moderate-income households. The dd's DISCOUNTS stores offer products at a 20% to 70% lesser price than the moderate department and discount stores.

Ross Stores remains focused with its store expansion initiatives over the years. Further, the company's efforts to expand base by making efforts to increase penetration in the existing as well as new markets. In this regard, it opened 26 stores across nine different states in February and March.

As of Oct 31, 2020, Ross Stores operated 1,869 outlets, including 1,594 Ross stores across 40 states, the District of Columbia and Guam, as well as 275 dd's DISCOUNTS stores in 21 states.

Reasons To Buy:

▲ **Robust Q3 Earnings & Improved Sales Trends:** Shares of Ross Stores gained 10% in the past three months compared with the industry's growth of 1.9%. Ross Stores reported improved trends in third-quarter fiscal 2020, resulting in better-than-expected top and bottom lines. This marks the second straight quarter of positive earnings and sales surprise. Moreover, the company's earnings improved year over year, while sales declined. Despite the adverse impacts of COVID-19, sales trends improved in the fiscal third quarter after a slow start in August. The accelerated trends were mainly attributed to better merchandise assortments, a late back-to-school season, robust performance in larger markets and the return of stores to more normal working hours. The significantly improved sales trends in the reported quarter reflected sequential improvements from the fiscal second quarter.

Ross Stores' witnessed accelerated sales trends in Q3 on better merchandise assortments, a late back-to-school season, robust performance in larger markets and the return to normal store hours.

▲ **Off-Price Model:** Ross operates a chain of off-price retail apparel and home accessories stores, which target value-conscious men and women, aged 25 to 54 in middle-to-upper middle-class households. The company has a proven business model as the competitive bargains it offers continue to make its stores attractive destinations for customers in all economic scenarios. Moreover, the off-price model offers strong value proposition and micro-merchandising that drive better product allocation and margins.

In the fiscal third quarter, the company witnessed the largest merchandise gains at Ross' home category. Meanwhile, the Midwest and Southeast were the best performing geographic regions. Moreover, it witnessed accelerated gains at dd's DISCOUNTS' value offerings during the reported quarter, owing to positive customer response. Overall, gains at the core business demonstrated consumers' continued focus on value and the company's ability to deliver the value bargains to customers. Additionally, the company is making progress on its distribution capabilities to support peak sales during the holiday selling season.

▲ **Store Expansion Plan:** Ross Stores has been consistent with the execution of its store expansion plans over the years. The company's store expansion efforts are focused on continually increasing penetration in the existing as well as new markets. During third-quarter fiscal 2020, the company opened 30 Ross and 9 dd's DISCOUNTS stores. This marked the completion of its expansion program, targeting the opening of 66 store in fiscal 2020. The company plans to close 10 existing stores in the fiscal fourth quarter. With this, it expects to end fiscal 2020 with 1,585 Ross and 274 dd's DISCOUNTS stores. This will result in a net increase of 54 stores in fiscal 2020. The company currently operates 1,594 Ross stores across 40 states, the District of Columbia and Guam, as well as 275 dd's DISCOUNTS stores in 21 states. Earlier, it projected to expand the Ross chain of stores to 2,400 locations alongside operating about 600 dd's DISCOUNTS stores over the long term.

▲ **Financial Flexibility:** Ross Stores' cash and cash equivalents at the end of third-quarter fiscal 2020 increased 16.4% sequentially to \$4,416.1 million. Moreover, the company had liquidity of more than \$5.2 billion at the end of the fiscal third quarter, which includes cash on hand and \$800 million available under its revolving credit facility. During the fiscal third quarter, the company refinanced a portion of its senior notes, which significantly lowered the annual interest expenses and total cash outlays for long-term debts. Additionally, it undertook actions to reduce ongoing debt costs through the repayment of the \$800-million revolving credit facility and terminating the undrawn \$500-million revolver. Although long-term debt of \$2,512 million increased 9.9% sequentially, its debt-to-capitalization ratio of 0.45 represents a sequential improvement from 0.52 as of Aug 1, 2020. The debt-to-capitalization ratio also compares favorably with the industry's ratio of 0.48. The company's times interest earned ratio of 21.9 versus the industry's 15.7 indicates that it is better positioned to meet its debt obligations, compared to its peers.

It is also poised to preserve liquidity as it earlier suspended the share repurchase program in light of the ongoing pandemic. The company does not intend to repurchase any shares for the rest of fiscal 2020.

Reasons To Sell:

- ▼ **Stock Appears Overvalued:** Considering price-to-earnings (P/E) ratio, Ross Stores looks pretty overvalued compared with the broader industry and the market at large. The stock has a trailing 12-month P/E ratio of 63.27x compared with 34.96x for the industry and 28.21x for the S&P 500. Its trailing 12-month P/E ratio is above the median level of 47.5x and below the high level of 65.32x.
- ▼ **Soft Q3 Comps & Outlook:** Although Ross Stores reported better-than-expected third-quarter fiscal 2020 results, comparable store sales (comps) declined 3% in the fiscal third quarter. The decline was attributed to decrease in the number of transactions, offset by higher average basket size.

Moreover, management noted that month-to-date comparable store sales in November declined in mid-single digits, reflecting a slow start to the fiscal fourth quarter. It also remains uncertain about the impacts of the upsurge of the pandemic on consumer demand during the highly competitive holiday shopping season. Driven by the lack of visibility and the pandemic-related disruptions, the company refrained from providing guidance for the fiscal fourth quarter.

- ▼ **Higher COVID-Related Costs:** Despite a strong fiscal third quarter, costs related to COVID-19 and lower packaway levels remained concerning for Ross Stores. During the quarter, the company incurred about \$25 million of net COVID-19-related expenses. It notes that the impacts of these expenses were slightly higher on cost of goods sold (COGS) than SG&A expenses. Meanwhile, packaway levels of 26% at the end of the fiscal third quarter were significantly below the prior-year quarter's 39%. Nonetheless, the company expects the COVID-19-related expense to be significantly higher in the fiscal fourth quarter compared with the third quarter. The increase is mainly attributed to expenses for managing the impacts of industry-wide capacity constraints and congestion as well as wage and incentive actions in supply chain and stores.
- ▼ **Elevated COGS & SG&A Expense Hurt Margins:** The increase in COVID-related costs and other expenses partly impacted bottom line growth and margins in the fiscal third quarter. Although COGS declined 2% year over year, as a percentage of sales, it increased 35 basis points (bps). The higher COGS rate was attributed to higher freight costs of 90 bps and distribution expenses of 70 bps. Higher costs more than offset the 190-bps increase in merchandise margin, owing to a favorable buying environment. Moreover, buying and occupancy costs increased 40 bps and 25 bps, respectively. SG&A expense rose 45.2% year over year, while SG&A expense rate increased 765 bps. SG&A expenses included a 640-bps impact of one-time debt refinancing charge. It also reflected deleveraging effects of lower comps and higher pandemic-related operating costs in fiscal 2020.

Backed by the higher costs, operating margin of 4.4% declined significantly from 12.4% in the year-ago quarter. The decline was mainly due to one-time debt refinancing charges, which pulled down the operating margin by 640 basis points (bps). Additionally, operating margin was hurt by higher pandemic-related operating costs in fiscal 2020 and deleveraging of expenses throughout the business, owing to lower comps.

Ross Stores expects significantly higher COVID-led expenses in Q4 on managing impacts of industry-wide capacity constraints and congestion, and wage and incentive actions in supply chain and stores.

Ross Stores reported improved trends in third-quarter fiscal 2020, resulting in better-than-expected top and bottom lines. Moreover, the company's earnings improved year over year, while sales declined. Despite the decline, the quarter reflected improved sales trends on better merchandise assortments, a delayed back-to-school season, gains from larger markets and a return to normal store hours. Backed by the improved trends, the company's sales reflected significant growth on a sequential basis.

Ross Stores reported adjusted earnings of \$1.02 per share, up nearly 1% from \$1.03 per share reported in the prior-year quarter. Moreover, earnings beat the Zacks Consensus Estimate of 63 cents. Adjusted earnings excluded a one-time charge of 65 cents per share related to the refinancing of \$775 million in senior notes to significantly reduce long-term debt costs.

Total sales declined 2.5% to \$3,754.5 million but surpassed the Zacks Consensus Estimate of \$3,464.5 million. Despite the adverse impacts of COVID-19, sales trends improved in the fiscal third quarter after a slow start in August. The accelerated trends were mainly attributed to better merchandise assortments, a late back-to-school season, robust performance in larger markets and the return of stores to more normal working hours. The significantly improved sales trends in the reported quarter reflected sequential improvements from the fiscal second quarter.

In the fiscal third quarter, the company witnessed the largest merchandise gains at Ross' home category. Meanwhile, the Midwest and Southeast were the best performing geographic regions. Moreover, it witnessed accelerated gains at dd's DISCOUNTS' value offerings during the reported quarter, owing to positive customer response. As a percentage of sales, COGS increased 35 basis points (bps) year over year, driven by higher freight costs of 90 bps and distribution expenses of 70 bps. With this, it expects to end fiscal 2020 with 1,585 Ross and 274 dd's DISCOUNTS stores. This will result in a net increase of 54 stores in fiscal 2020.

Financials

Ross Stores ended the quarter with cash and cash equivalents of \$4,416.1 million, long-term debt of \$2,512 million, and total shareholders' equity of \$3,019 million. Earlier, the company suspended the share repurchase program in light of the ongoing pandemic. Moving ahead, it does not intend to repurchase any shares for the rest of fiscal 2020.

Moreover, the company had liquidity of more than \$5.2 billion at the end of the fiscal third quarter, which includes cash on hand and \$800 million available under its revolving credit facility. During the fiscal third quarter, the company refinanced a portion of its senior notes, which significantly lowered the annual interest expenses and total cash outlays for long-term debts. Additionally, it undertook actions to reduce ongoing debt costs through the repayment of the \$800-million revolving credit facility and terminating the undrawn \$500-million revolver.

Valuation

Ross Stores shares are down 3.1% in the year to date period and nearly 2.2% for the trailing 12-month period. Stocks in the Zacks sub-industry are down 1.3% but the Zacks Retail-Wholesale sector is up 4.4% in the year-to-date period. Over the past year, the Zacks sub-industry and the sector are up 20.3% and 38.5%, respectively.

The S&P 500 index is up 4.5% in the year-to-date period and 23.2% in the past year.

The stock is currently trading at 26.3X forward 12-month earnings, which compares to 25.67X for the Zacks sub-industry, 31.4X for the Zacks sector and 22.67X for the S&P 500 index.

Over the past five years, the stock has traded as high as 79.52X and as low as 12.15X, with a 5-year median of 21.37X. Our Neutral recommendation indicates that the stock will perform in-line with the market. Our \$125 price target reflects 27.64X forward 12-month earnings.

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
