Summary

Raytheon Technologies is expected to benefit significantly from the technological upgrades in which both legacy Raytheon and United Technologies have been investing for long, post merger. Thanks to its wide range of combat-proven defense products, the company continues to receive ample orders from the Pentagon. Although its commercial business has taken a hit, due to the COVID-19 impact, in the military section the stock continues to see growth trends. However, due to continued air travel restrictions, operating results of its Aerospace businesses are being significantly impacted. It has been witnessing significant pre-tax charges on account of the COVID-19 impacts, which might hurt its earnings. Near-term outlook for commercial air traffic remains bleak that poses risk for this stock. It has underperformed its industry in the past six months.

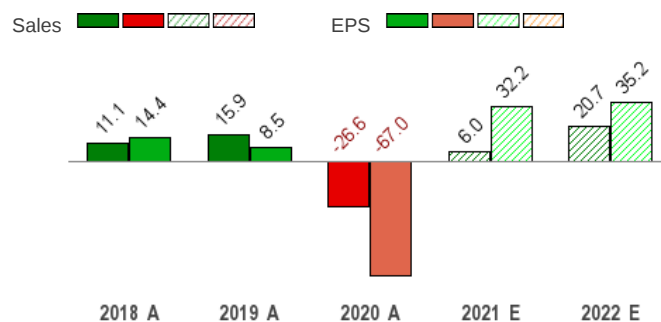
Price, Consensus & Surprise

Overview

On Apr 3, 2020, **Raytheon Technologies** was formed following the completion of merger between United Technologies and Raytheon Company. Based in Waltham, MA, Raytheon Technologies has emerged as an aerospace and defense company, with pro-forma combined annual revenues of \$74 billion as of the end of 2019, providing advanced systems and services for commercial, military and government customers worldwide. The company currently operates through the following four business segments:

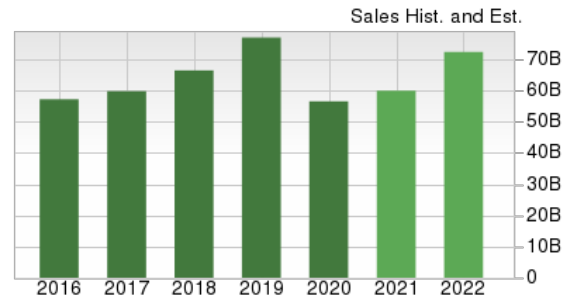
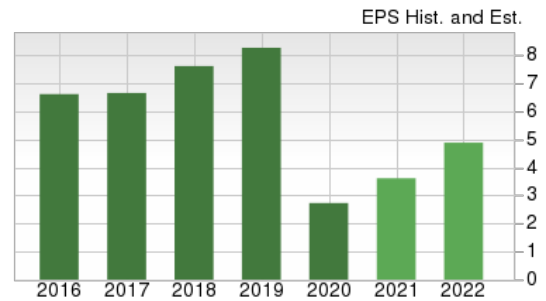
Collins Aerospace: It specializes in six strategic business units, namely, aerostructures, avionics, interiors, mechanical systems, mission systems, and power & control systems. It generated revenues worth \$19.29 billion in 2020, representing 32.9% of total revenues.

Pratt & Whitney: It designs, manufactures and services the world's most advanced aircraft engines and auxiliary power systems for commercial, military and business aircraft. It generated revenues worth \$16.80 billion in 2020, representing 28.7% of total revenues.

Raytheon Intelligence & Space (RIS): It develops advanced sensors and also offers training, and cyber and software solutions. It generated revenues worth \$11.07 billion in 2020, representing 18.9% of total revenues.

Raytheon Missiles and Defense (RMB): It manufactures a broad portfolio of advanced technologies, including air and missile defense systems, precision weapons, radars, and command and control systems. It generated revenues worth \$11.40 billion in 2020, representing 19.5% of total revenues.

Total revenues include \$1.97 billion of intersegmental eliminations.

Reasons To Buy:

- ▲ In late 2018, legacy United Technologies acquired Rockwell Collins. During 2020, the Collins Aerospace unit successfully captured positive synergies worth approximately \$240 million, thereby surpassing the year-end target of \$200 million. This segment remains on track to achieve a total synergy of \$600 million for Raytheon Technologies.

Merger related synergies and solid order growth to aid Raytheon Technologies

Following the latest merger that took place in April 2020, Raytheon Technologies is expected to benefit significantly from the technological upgrades in which both legacy Raytheon and United Technologies have been investing for long. Notably, at Pratt & Whitney, on the commercial aftermarket side, GTF overhaul activity continues as the company aims to upgrade engines to the latest configuration. This has been boosting growth in the GTF aftermarket volume. However, the commercial part of its businesses has taken a hit lately, courtesy of the COVID-19 impact. Looking ahead, the company remains on track to deliver more than \$1 billion in gross cost synergies from the latest merger.

- ▲ Thanks to its wide range of combat-proven defense products, Raytheon Technologies continues to receive ample orders from the Pentagon and its foreign allies. During the fourth quarter, the company won a handful of notable contracts like a \$947 million deal of classified bookings at its RIS segment, a \$305 million contract for F-119 spare parts and a few more. Consequently, it witnessed record bookings in the last reported quarter, which translated into a solid backlog of \$67.3 billion. Notably, offsetting the headwinds prevalent in commercial aerospace, the company's defense sales were up 1% on an adjusted basis and 7% organically driven by F-35, as well as growth in its avionics and actuation product lines, during the fourth quarter.

These impressive results make us optimistic of the revenue growth prospects of the company for its defense business, which, in turn, will boost its bottom line, over the long run. Looking ahead, long-term earnings growth rate of the company is currently projected at 12% compared with its industry's rate of 7.2%. In fact, Raytheon Technologies' management projects its defense program growth to remain robust, both domestically and internationally. The company also remains confident in its ability to grow its defense business even in a flat budgetary environment due to its strong international presence along with innovative technologies.

- ▲ Raytheon Technologies' cash and cash equivalents were \$8.8 billion as of Dec 31, 2020. Although its long-term debt of \$31.03 billion as of Dec 31, 2020 remained well above the cash balance, the current debt value of \$0.8 billion was much less than the cash reserve. This reflects a solid solvency position for the stock, amid the ongoing economic downturn caused by the COVID-19 pandemic, at least over the short term. Moreover, the company's current ratio came in at 1.21 at the end of the fourth quarter, which being more than 1 makes us optimistic about the company's ability to duly meet its debt obligations. Such favorable financial ratios should boost investor confidence in this stock.

Reasons To Sell:

- ▼ Raytheon Technologies has been suffering the adverse impacts of the coronavirus outbreak since the first quarter of 2020, in terms of facility closures, less than full staffing, and disruptions in supplier deliveries, most significantly in its Aerospace businesses. In particular, the unprecedented decrease in air travel resulting from the pandemic is affecting the company's airline and airframer customers, and their demand for the products and services of its Collins Aerospace and Pratt & Whitney businesses.

Consequently, during the fourth quarter, the company witnessed a 3% decline in adjusted sales for its Collins Aerospace unit, primarily due to the adverse impact of COVID-19 on the commercial aerospace industry. In 2020, this stock had to incur a total pre-tax charge of \$4.3 billion on account of the pandemic's impact. With the pandemic still looming large, continued disruption in air travel is going to keep the aforementioned businesses of Raytheon Technologies under pressure. This in turn will result in the company, particularly the Collins Aerospace unit, delivering poor performance in the near term.

- ▼ According to the International Air Transport Association's (IATA) revised outlook published in November 2020, air passenger numbers are expected to be 2.8 billion in 2021, which is significantly lower than the pre-COVID level of 4.5 billion at the end of 2019. Considering such dismal outlook, Raytheon Technologies' airline customers might not be very interested to significantly expand their fleet and may also defer new aircraft deliveries. Meanwhile, ever since the pandemic has hit global air traffic, airlines have shifted to cash conservation behaviors such as deferring engine maintenance due to lower flight hours and aircraft utilization, requesting extended payment terms, deferring delivery of new aircraft and spare engines and requesting discounts on engine maintenance. With the pandemic still continuing, the cash crunch is prevalent in the commercial aerospace, which in turn poses risk for the stock's growth in the near future.
- ▼ Further, the company is witnessing purchase order declines in line with publicly communicated aircraft production volumes as original equipment manufacturer (OEM) customers delay and cancel orders. Although Raytheon Technologies is optimistic about the long-term outlook for the aerospace industry, over the next few years, there is significant uncertainty with respect to when and if commercial air traffic levels will begin to recover substantially. To this end, the company expects commercial air traffic to return to pre-COVID levels in 2023 or 2024. So, no rebound is expected in the near term. Such estimates cast a shadow of uncertainty over Raytheon Technologies' future operating results, particularly those of its Aerospace businesses, which in turn must have caused investors to lose confidence in this stock. In the past six months, shares of Raytheon have gained 12.6% compared to the industry's 19.1% increase.

Increasing tariff on imports of steel and aluminum, impact of coronavirus pandemic on commercial aerospace and delayed delivery remain concerns for this stock

Last Earnings Report

Raytheon Technologies Beats on Q4 Earnings & Sales

Raytheon Technologies fourth-quarter 2020 adjusted earnings per share (EPS) of 74 cents outpaced the Zacks Consensus Estimate of 71 cents by 4.2%. However, the bottom-line figure declined 36.2% from the year-ago quarter's adjusted earnings of \$1.16.

Including one-time items, the company reported GAAP earnings of 10 cents compared with earnings of 76 cents per share in the year-ago quarter.

The year-over-year deterioration in the bottom line is attributable to charges related to the current economic environment, primarily the COVID-19 pandemic, along with some restructuring costs.

For 2020, the company reported adjusted earnings of \$2.73 per share, which missed the Zacks Consensus Estimate of \$2.99. The full-year figure also deteriorated from \$4.95 recorded in 2019.

Operational Performance

Raytheon Technologies' fourth-quarter adjusted sales amounted to \$16,583 million, while the company's GAAP sales came in at \$16,419 million. The GAAP sales figure surpassed the Zacks Consensus Estimate of \$16,303 million by 0.7%.

The company had reported GAAP sales worth \$11,694 million in the year-ago quarter.

For 2020, the company recorded adjusted sales of \$57.15 billion, while GAAP sales came in at \$56.59 billion. The GAAP sales figure missed the Zacks Consensus Estimate of \$64.20 billion. At the end of 2019, Raytheon Technologies recorded sales worth \$45.35 billion.

Total costs and expenses increased 50.9% year over year to \$16,327 million. The company generated operating profit of \$142 million compared with \$956 million in the year-ago quarter.

Segmental Performance

Collins Aerospace: Adjusted sales at this segment plunged 32% year over year to \$4,388 million in fourth-quarter 2020 due to lower commercial OEM sales as well as commercial aftermarket sales decline attributable to reduced flight hours, aircraft fleet utilization and commercial OEM deliveries. Impact of the 737 MAX grounding also hampered this unit's top line.

Its adjusted operating income came in at \$89 million compared with the year-ago quarter's level of \$1,061 million.

Pratt & Whitney: Adjusted sales at this segment declined 20% year over year to \$4,496 million due to a significant reduction in shop visits and related spare part sales as well as lower commercial engine deliveries.

Its adjusted operating profit was \$105 million compared with the year-ago quarter's operating income of \$470 million.

Raytheon Intelligence & Space: This segment recorded fourth-quarter sales of \$3,853 million and generated \$355 million of adjusted operating profit.

Raytheon Missiles & Defense: This unit recorded adjusted sales of \$4,395 million and \$586 million of adjusted operating profit in the quarter.

Financial Update

Raytheon Technologies had cash and cash equivalents of \$8,802 million as of Dec 31, 2020 with, up from \$4,937 million as of Dec 31, 2019.

Long-term debt was \$31,026 million, as of Dec 31, 2020, down from \$37,701 million as of Dec 31, 2019.

Net cash inflow from operating activities amounted to \$4,334 million at the end of 2020 compared with \$5,821 million at the end of 2019.

Its free cash flow was \$2,539 million compared with \$3,953 million at the end of fourth-quarter 2019.

Guidance

Raytheon Technologies issued guidance for the first quarter of 2021 as well as full-year 2021. For the first quarter, the company expects to generate EPS in the range of 70-75 cents on revenues in the band of \$14.8-\$15.4 billion.

The Zacks Consensus Estimate for first-quarter EPS, pegged at 71 cents, lies below the mid-point of the guided range. The Zacks Consensus Estimate for revenues, pegged at \$16.07 billion, is higher than the guided range.

For 2021, Raytheon Technologies projects to generate EPS in the range of \$3.40-\$3.70 billion on revenues in the band of \$63.4-\$65.4 billion. The Zacks Consensus Estimate for EPS, pegged at \$3.45, lies well below the mid-point of the guided range. The Zacks Consensus Estimate for revenues, pegged at \$67.05 billion, is higher than the guided range.

The company also expects to generate free cash flow worth \$4.5 billion during 2021.

Recent News

On **Feb 1, 2021**, Raytheon Technologies' business segment, Pratt and Whitney, secured a contract involving supply of propulsion system for Lockheed's LMT F-35 jet program. The deal has been awarded by the Naval Air Systems Command, Patuxent River, MD.

On **Dec 7, 2020**, Raytheon Technologies announced that its Board of Directors has authorized the repurchase of up to \$5 billion of the company's outstanding common stock. The new authorization replaces the company's previous program, approved Oct. 14, 2015.

On **Nov 10, 2020**, Raytheon Technologies announced that it has signed a definitive agreement to acquire privately held Blue Canyon Technologies, a leading provider of small satellites and spacecraft systems components. Closure of the acquisition, expected by early 2021, is subject to the completion of customary conditions and regulatory approvals. Blue Canyon Technologies will report into Raytheon Intelligence & Space upon closing.

On **Oct 26, 2020**, Raytheon Technologies announced that Francisco Partners has signed a definitive agreement to acquire Forcepoint from the former. Debt financing for this transaction was provided by Credit Suisse. Paul Hastings LLP and Kirkland & Ellis acted as legal advisors to Francisco Partners. B.

On **Oct 6, 2020**, Raytheon Technologies announced that its business unit, Raytheon Intelligence & Space, is launching a new hardware emulation and software analysis tool called DejaVM that provides a virtualized environment to evaluate and reduce cyber threats against mission-critical systems in a modern networked space. DejaVM enables system-level cyber testing without requiring access to the limited number of highly specialized physical hardware assets.

Valuation

Raytheon's shares are up 12.6% in the last six months. Stocks in the Zacks sub-industry are up 19.1%, while the Zacks Aerospace sector went up 8.1% in the six months period. The S&P 500 index is up 17.3% in the said period.

The stock is currently trading at 19.3X of forward 12-month earnings, which compares to 26X for the Zacks sub-industry, 21.4X for the Zacks sector and 22.8X for the S&P 500 index.

Over the past six months, the stock has traded as high as 21X and as low as 14.2X, with a 5-year median of 17.9X. Our Neutral recommendation indicates that the stock will perform in line with the market. Our \$77 price target reflects 20.5X forward 12-month earnings.

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
