Summary

Shares of Spectrum Brands have outperformed the industry in the past three months, driven by better-than-expected results in third-quarter fiscal 2020. Results gained from solid demand for its products. Also, global productivity improvement plan's savings contributed to quarterly growth. Moreover, robust sales growth in Global Pet Care and Home & Personal Care segments partly offset supply-chain disruptions related to the Hardware & Home Improvement segment. Apart from these, favorable pricing and productivity aided gross margin in the quarter. However, management withdrew the fiscal 2020 view due to the uncertainty regarding the COVID-19 pandemic. The pandemic hurt adjusted EBITDA in the reported quarter. Further, sluggishness in the Hardware & Home Improvement segment and currency woes remain concerns.

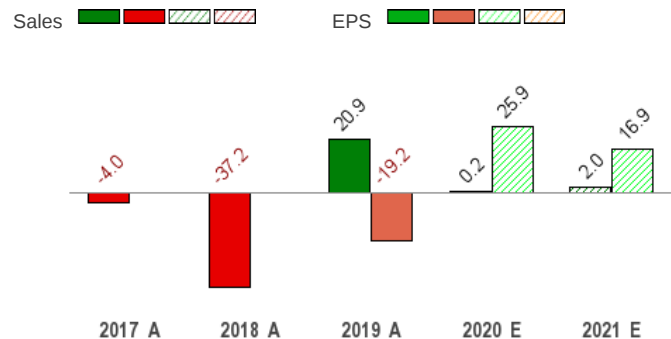
Price, Consensus & Surprise

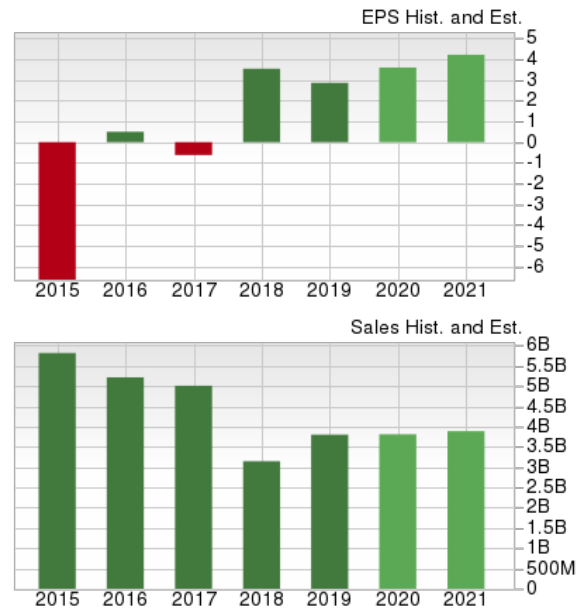
Overview

Spectrum Brands Holdings, Inc. is a global consumer products company. It offers a portfolio of leading brands in several product categories like residential locksets, plumbing, electric shaving and grooming products, personal care products, small household appliances, specialty pet supplies, lawn and garden and home pest control products and repellents.

The company manufactures, markets and distributes products in roughly 160 countries of North America, Europe, Middle East & Africa (EMEA), Latin America and Asia-Pacific regions. It markets its products through various trade channels, which include retailers, wholesalers and distributors, original equipment manufacturers ("OEMs") and construction companies.

In July 2018, Spectrum Brands merged with its controlling shareholder HRG Group, Inc. The combined company is named Spectrum Brands Holdings, Inc. and is currently headquartered in Middleton, WI.

In January 2019, Spectrum Brands completed the divestitures of its Global Auto Care business as well as Global Battery and Lighting Businesses to Energizer. Further, the company has four reporting segments, namely, Hardware & Home Improvement (HHI), Home & Personal Care (HPC), Global Pet Care (GPC) and Home & Garden (H&G).



Hardware & Home Improvement: This segment includes security product category, plumbing product category and hardware product category. The segment contributed nearly 28.6% to the company's overall net sales in third-quarter fiscal 2020.

Home & Personal Care: This segment includes Personal Care and Small Appliances businesses. The segment contributed about 25.5% to overall net sales in the fiscal third quarter.

Global Pet Care: This segment includes animal food, products and accessories; pet health and grooming products as well as aquatic supplies. The segment contributed about 24.5% to overall net sales in the fiscal third quarter.

Home and Garden: This segment includes controls product category, household product category and repellents product category. The segment contributed about 21.4% to overall net sales in the fiscal third quarter.

Reasons To Buy:

▲ **Robust Q3 Results:** Shares of Spectrum Brands have gained 21.8% in the past three months against the industry's decline of 1.4%. The stock benefited from the better-than-expected results for third-quarter fiscal 2020. Results gained from solid demand for its products throughout the quarter. Notably, the majority of its segments delivered sturdy sales growth. The bottom line gained from a fall in shares outstanding, favorable pricing and productivity, which more than offset supply-chain disruptions in the Hardware & Home Improvement segment. Moreover, gross margin expanded 10 bps to 35.4%, mainly driven by favorable pricing and productivity. Apart from these, SG&A expenses declined 3.4% to \$225 million, driven by reduced operating and restructuring costs. Moreover, it witnessed robust demand in three of its four categories. Furthermore, Spectrum Brands anticipates shipments and factory output to improve in the fiscal fourth quarter.

Spectrum Brands' impressive Q3 results were driven by sturdy sales growth stemming from solid demand for its products. Also, global productivity improvement plan savings contributed to quarterly growth

▲ **Strategic Initiatives on Track:** Spectrum Brands is progressing well with its Global Productivity Improvement Plan (GPIP), which is expected to generate at least \$100 million in run-rate savings annually. The company's third-quarter fiscal 2020 results reflected gains from the plan. This strategic initiative aims at improving the company's operating efficiency and effectiveness, while focusing on consumer insights, and growth-enabling functions including technology, marketing, and research and development. Also, it foresees achieving full run-rate savings over the next nine to 12 months. Notably, majority of these savings are expected to be reinvested into the growth initiatives and consumer insights, R&D and marketing across each of the businesses. This plan will also enable the company to deliver value creation and sustainable growth in the long term.

▲ **Global Pet Care Business Reflects Strength:** Although organic net sales fell 2.9% due to supply-chain disruptions in the Hardware & Home Improvement segment, higher sales at Home & Garden, Home & Personal Care and Global Pet Care provided aided the top line. Notably, sales for the Global Pet Care business improved 8.9%, with organic sales growth of 8.3% on high-single-digit and double-digit growth in aquatic and companion animal categories, respectively. Also, strong e-commerce sales along with a spike in demand for aquatics and reptile kits and equipment contributed to segment growth. In sync with its Global Productivity Improvement Plan, the pet business is on track with exiting non-core assets and activities to focus on core brands. Also, the company is on track with its plans to tap into the aquatics and reptile space. In this context, Spectrum Brands is progressing well with the integration process of its newly acquired Omega Sea, which is now part of its Global Pet Care portfolio of aquatic brands. Cumulatively, the pet segment remains poised for growth backed by its pipeline of robust innovation and growth strategy.

▲ **Home & Personal Care Segment:** Sales at the Home & Personal Care segment rose 3% in the fiscal third quarter, while organic sales increased 6.5%. This marked the third straight quarter of growth for the segment in a year. Growth was backed by strength in the U.S. small appliances, solid demand and sturdy online sales. This was somewhat offset by a decline in personal care due to lower inventory as a result of the COVID-19 crisis. Moreover, the segment's adjusted EBITDA of \$25 million increased 37.4% on productivity improvements and higher volumes.

▲ **Financial Flexibility:** Spectrum Brands ended third-quarter fiscal 2020 with a total debt of \$2,755.9 million, down 0.1% from \$3,978.8 million in the prior quarter. Moreover, its debt to capitalization ratio is at a respectable 0.66 as compared to 0.71 reported in the prior quarter. The company had a strong liquidity position with cash balance of \$465.9 million and roughly \$341 million available under its \$800-million Cash Flow Revolver. Further, management on Jun 30 refinanced its existing \$890-million cash revolver and issued a new five-year cash revolver of \$600 million along with \$300 million worth 10-year senior and secured notes, which are due in 2030. Also, it sold roughly one million shares of Energizers stock for \$50 million in the fiscal third quarter. The company's share repurchase program continues to remain suspended due to the unprecedented COVID-19 impacts. That said, with such well-chalked efforts, Spectrum Brands is likely to stay afloat amid this ongoing pandemic. In fact, the company envisions to generate positive free cash flow in fiscal fourth quarter as well.

Risks

- **Weakness in Hardware & Home Improvement Segment:** Spectrum Brands' Hardware & Home Improvement segment reported a decline of 20.6% and 20.4% in net sales and organic sales, respectively, in second-quarter fiscal 2020. The segment's top line was hurt by softness in the security category and supply-chain disruptions, particularly in Mexico and the Philippines, stemming from government-imposed restrictions related to COVID-19. Also, a decline in residential security due to supply-chain disruptions in Asia more than offset growth in builders' hardware on the back of product innovation in the home center and online space. Also, adjusted EBITDA in the segment slumped 35.6% to \$43.6 million.
 - **Softness Q3 EBITDA:** Adjusted EBITDA from continuing operations declined 4.9% to \$164.4 million in the fiscal third quarter. Further, adjusted EBITDA margin contracted 20 bps on sluggishness in the Hardware & Home Improvement segment, which was somewhat offset by solid performance in the Global Pet Care, Home & Personal Care and Home & Garden segments. The company also noted that supply-chain disruptions affected operating income and adjusted EBITDA to the tune of more than \$30 million.
 - **Currency Headwinds:** Spectrum Brands is exposed to major foreign currency risks due to cross-border presence, which is weighing on the company's performance. Foreign currency headwinds hurt the company's net sales by \$11 million in third-quarter fiscal 2020. Any further negative changes in foreign currency are expected to marginally hurt sales in the near term.
 - **Competitive Pressure May Result in Loss of Market Share:** Spectrum Brands faces intense competition from numerous well-established players and distributors of consumer and commercial products. In such a competitive environment, a pricing lag, non-availability of big consumer brands, lack of innovations with regard to product features and enhancements as well as inefficient customer service may restrict market share growth.

Spectrum Brands Q3 Earnings & Sales Beat Estimates

Spectrum Brands posted better-than-expected results in third-quarter fiscal 2020. Results gained from solid demand for its products throughout the quarter. Notably, the majority of its segments delivered sturdy sales growth. However, supply-chain disruptions related to the Hardware & Home Improvement segment hurt quarterly growth to some extent.

Moving on, the company's global productivity improvement plan savings contributed to quarterly growth. Encouragingly, this plan is anticipated to generate at least \$100 million of full run-rate cost savings over the next nine to 12 months. Despite such upsides, management withdrew the fiscal 2020 view. That said, demand remains positive for three of its four categories. Also, Spectrum Brands estimates shipments and factory output to improve in the fiscal fourth quarter.

Q3 in Detail

Adjusted earnings from continuing operations of \$1.36 per share surpassed the Zacks Consensus Estimate of 96 cents. The bottom line also inched up 0.7% on the back of a fall in shares outstanding, favorable pricing and productivity, which more than offset supply-chain disruptions in the Hardware & Home Improvement segment.

Spectrum Brands' net sales decreased 3.7% year over year to \$984.3 million but exceeded the Zacks Consensus Estimate of \$938 million. Excluding the negative impacts of currency and sales from buyouts, organic net sales fell 2.9% due to supply-chain disruptions in the Hardware & Home Improvement segment, which was somewhat offset by higher sales at Home & Garden, Home & Personal Care and Global Pet Care. Moreover, its e-commerce unit continued to witness significant growth across all categories. To this end, sales in this platform rose 44% year over year, accounting for roughly 16% of net sales.

Gross profit dipped 3.4% year over year to \$348.9 million. Meanwhile, gross margin expanded 10 bps to 35.4%, mainly driven by favorable pricing and productivity. However, supply-chain headwinds in the Hardware & Home Improvement segment acted as a deterrent. Apart from these, SG&A expenses fell 3.4% to \$225 million, while SG&A as a percentage of sales remained flat at 22.8%. This can be mainly attributable to reduced operating and restructuring costs.

Furthermore, the company reported operating income of \$94.6 million, up 1.9% year over year in the reported quarter. The uptick can be attributable to reduced restructuring expenses, which were somewhat offset by supply-chain headwinds in the Hardware & Home Improvement segment. Adjusted EBITDA from continuing operations declined 4.9% to \$164.4 million in the fiscal third quarter. Further, adjusted EBITDA margin contracted 20 bps on sluggishness in the Hardware & Home Improvement segment, which was somewhat offset by solid performance in the Global Pet Care, Home & Personal Care and Home & Garden segments. The company also noted that supply-chain disruptions affected operating income and adjusted EBITDA to the tune of more than \$30 million.

Segmental Performance

Sales at the **Hardware & Home Improvement** segment declined 20.6% to \$281.6 million mainly due to softness in the security category and supply-chain disruptions, particularly in Mexico and the Philippines, stemming from government-imposed restrictions related to COVID-19. Also, a decline in residential security due to supply-chain disruptions in Asia more than offset growth in builders' hardware on the back of product innovation in the home center and online space. The segment's organic sales dropped 20.4% year over year. Also, adjusted EBITDA at the segment slumped 35.6% to \$43.6 million.

Sales at the **Home & Personal Care** segment increased 3% to \$250.6 million, backed by growth at the U.S. small appliances, solid demand and sturdy online sales. This was somewhat offset by a decline in personal care due to lower inventory as a result of the COVID-19 crisis. Excluding the adverse impacts of foreign currency, organic net sales for the segment increased 6.5%. Moreover, the segment's adjusted EBITDA of \$25 million improved 37.4% on productivity improvements and higher volumes.

The **Global Pet Care** segment's sales grew 8.9% year over year to \$241.5 million, primarily driven by high-single-digit and double-digit growth in aquatic and companion animal categories, respectively. Also, strong e-commerce sales along with a spike in demand for aquatics and reptile kits and equipment contributed to segment growth. Excluding the adverse impacts of foreign currency and sales from acquisitions, organic sales rose 8.3%. Further, the segment's adjusted EBITDA grew 29.7% to \$50.6 million.

The **Home & Garden** segment's sales rose 4% to \$210.6 million mainly on higher sales in household insect controls and repellents. Also, growth in mass, home center, and online channels along with favorable weather aided segment sales. This was somewhat compensated by growth in outdoor controls. Further, the segment's adjusted EBITDA was up 4.4% to \$55.5 million in the prior-year quarter.

Other Financials

Spectrum Brands ended the quarter with cash and cash equivalents of \$465.9 million and roughly \$341 million available under its \$800-million Cash Flow Revolver. As of Jun 30, 2020, the company's outstanding debt was nearly \$2,720 million. Capital expenditure came in at \$12.8 million, down from \$13.2 million last year. The company boasts liquidity of \$800 million, which is likely to help it stay afloat amid this ongoing pandemic.

Spectrum Brands Launches Smart Locks for Homes – Sep 29, 2020

Spectrum Brands' Hardware & Home Improvement Division unveiled Halo Touch Wi-Fi Smart lock, which is an addition to its Wi-Fi enabled Smart Locks portfolio. The smart lock uses the latest technology to provide a convenient and secure smart home experience.

Through this homeowners can access their homes using their fingerprint. The lock gives access to multiple users, ensuring each family member can use their fingerprint to open or close the lock. It can be programmed to store up to 100 fingerprints (50 users) for access. It does not require a third-party hub, panel, or subscription service, but connects directly to a homeowners' existing Wi-Fi network and smartphone to create a simple, secure smart home experience. The lock is compatible to the Kwikset App, allowing homeowners to remotely monitor and control their homes via the app from anywhere in the world while connected to the Internet.

Spectrum Brands Approves Quarterly Dividend – Jul 28, 2020

Spectrum Brands' board has approved a quarterly dividend of 42 cents per share to be payable on Sep 22, 2020 to shareholders of record as of Aug 25.

Valuation

Spectrum Brands shares are down 12.1% in the year-to-date period but up 8.1% over the trailing 12-month period. Stocks in the Zacks sub-industry and Zacks Consumer Discretionary sector are down 10% and 2.6%, respectively, in the year-to-date period. Over the past year, the Zacks sub-industry is down 9.7% but the sector is up 8.7%.

The S&P 500 index is up 4.1% in the year-to-date period and 14.2% in the past year.

Our Outperform recommendation indicates that the stock will perform better than the market. Our \$65 price target reflects 15.43X forward 12-month earnings.

Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
