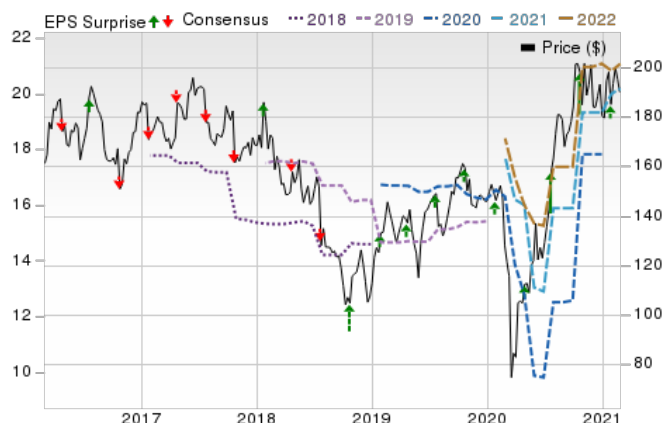

Summary

Shares of Whirlpool have outpaced the industry in a year's time on robust earnings surprise trend, which continued in fourth-quarter 2020. It reported earnings beat for the 10th straight time in the fourth quarter. Earnings and sales also improved year over year backed by exceptional execution of go-to-market and cost takeout endeavors. Growth across all regions, driven by robust demand for its products, aided sales. Management issued an upbeat sales and earnings per share guidance for 2021. Moreover, it noted signs of recovery such as improved demand and positive housing trends position it well for 2021. Also, the company generated \$500 million of net cost takeout through its COVID-19 response plan. However, results were partly negated by sales declines in Asia. Apart from this, rising input costs and stiff competition act as woes.

Overview

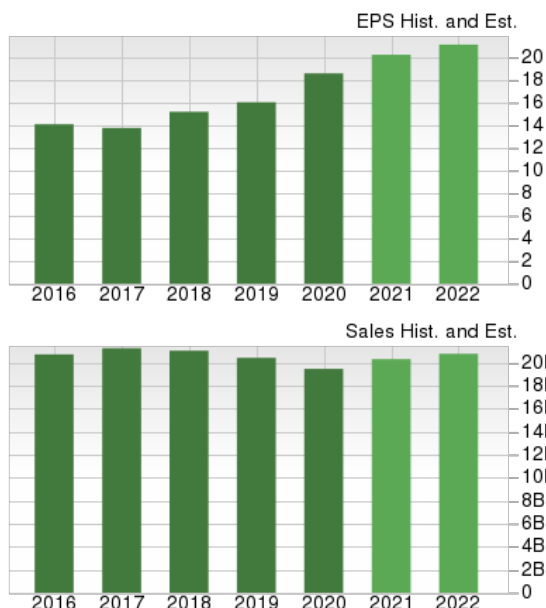
Benton Harbor, MI-based Whirlpool Corporation founded in 1955 is one of the largest manufacturers of home appliances in the world. The company manufactures products in 14 countries and markets products in nearly every country around the world.

Notably, the company's portfolio of products can be broadly classified into laundry appliances, refrigerators and freezers, cooking appliances, and other small household appliances such as dishwashers and mixers. It also produces hermetic compressors for refrigeration systems.

It markets brands including Whirlpool, KitchenAid, Maytag, Consul, Brastemp, Amana, Bauknecht, JennAir, Indesit and other major brand names. The company has the best brand portfolio in the industry, led by Whirlpool and KitchenAid. Of its brand portfolio, six brands generate more than \$1 billion in revenue.

Whirlpool, with its manufacturing and technology research centers spread globally, conducts its business through four reportable geographic segments. These are – North America; Latin America; Europe, Middle East and Africa (EMEA); and Asia. These regions contributed 56%, 16%, 21% and 7%, respectively, to total revenues in 2019.

The company is on track with its cost-based price increments and cost-reduction initiatives, which focus on improving business efficiency and boosting margins. Apart from these, the company remains well positioned to capture increasing demand of customers for the home and kitchen products. One home appliance that might boost the company's performance is the HEPA Air Purifier, which is capable of removing as much as 99.97% of particles from the air.

Reasons To Buy:

- ▲ **Surprise Trend Aid Stock:** Shares of Whirlpool have gained 54.6% in a year outperforming the industry's growth of 51.5%. The stock is benefiting from the company's positive earnings surprise trend. The company delivered earnings beat for the 10th straight time in fourth-quarter 2020. Moreover, the top line surpassed the Zacks Consensus Estimate for the third consecutive quarter. Also, earnings and sales improved year over year in the quarter. Earnings growth was backed by exceptional execution of go-to-market and cost takeout endeavors. Growth across all regions, except Asia, mainly aided sales. Also, the company witnessed significant year-over-year margin expansion in North America, Latin America, and Europe, Middle East and Africa (EMEA) regions. Moreover, demand for home appliances drove the quarterly results.
- ▲ **Upbeat View:** Better-than-expected performance prompted management to issue its sales and earnings per share guidance for 2021. Notably, Whirlpool envisions net sales (excluding currency impact) growth of approximately 6% for 2021, with sales growth in all regions. Additionally, it anticipates adjusted earnings in a band of \$19-\$20 per share. It noted that signs of recovery such as improved demand and encouraging housing trends position it well for 2021. Apart from these, the company envisions demand for household appliances to remain strong, driven by rising disposable income, increased investments in home space and a favorable housing shift.
- ▲ **Action Plan to Mitigate COVID-19 Impact:** Whirlpool has chalked out plans to protect margins and enhance liquidity position to navigate through this difficult time. Through the plans initiated in the first quarter, the company has generated cost savings of approximately \$175 million in the quarter and \$350 million year to date. These actions include curtailing structural and discretionary costs, capturing raw material deflation opportunity, effectively managing working capital and syncing supply chain and labor levels with demand. Moreover, the company's COVID-19 response plan helped generate \$500 million in cost takeout in 2020. Moreover, such well-chalked cost actions contributed to EBIT margins by 125 basis points and led to EBIT margin growth across all regions. Speaking of margins, the company posted fourth-quarter 2020 ongoing EBIT margin of 11.3%, marking the second successive quarter of double-digit margins. Also, the metric expanded 410 basis points year over year. Going ahead, ongoing EBIT margin is expected be more than 9% on the back of positive price mix stemming from go-to-market actions, product launches and cost-based price increases in Brazil, Russia and India. Apart from these, the company also remains well positioned to capture increasing customer demand for the home and kitchen products. The company is focused on enhancing e-commerce and improving direct-to-consumer capabilities.
- ▲ **Financial Flexibility:** Whirlpool looks financially stable amid the coronavirus pandemic with no current maturities of long-term debt and enough cash and cash equivalents to meet any obligations. As of Dec 31, 2020, the company had cash and cash equivalents of \$2,934 million. The company repaid \$1.7 billion of outstanding short-term debt by year-end, including all COVID-related short-term borrowings. Although the company's long-term debt increased 1.9% sequentially to \$5,059 million as of Dec 31, its debt-to-capitalization ratio stands at 0.53, which is below its maximum limit of 0.65. Also, the company plans to restart share repurchases, which was previously suspended since the onset of the pandemic. Management also highlighted that it has a liquidity of \$2.9 billion, which is likely to keep it afloat amid this crisis.

Whirlpool's Q4 results gained from demand for home and kitchen products and cost-saving endeavors. Management issued an upbeat 2021 view.

Reasons To Sell:

- ▼ **Sluggishness in Asia Remain a Concern:** Whirlpool has been witnessing declining sales in Asia region for the past few quarters. Notably, net sales from Asia decreased 0.7% to \$354 million in fourth-quarter 2020. Excluding the currency impact, sales for the region fell 0.7%. This might be attributable to pandemic induced disruptions. Prior to this, sales in this region dropped 1.4%, 27.1% and 22.3% in the third, second and first quarters of 2020, respectively. Persistence of this trend is likely to get reflected in the company's top line in the near term.
- ▼ **Rising Costs, A Worry:** Whirlpool's operating performance is significantly dependent on the price of raw materials, particularly steel, oil, plastic resins, aluminum, copper, zinc and nickel. Therefore, we believe that volatility in commodity prices may adversely impact the company's operating performance in the future. Keeping in these lines, raw material inflation, particularly led by higher steel and resin cost is likely to weigh on margins by 150 basis points in 2021. Moving on, while the company's heavy investment in innovative products and technology is likely to buoy its future prospects, it may strain the near-term financials. In fact, increased investment in marketing and technology is expected to hurt margins in 2021 by 50 basis points.
- ▼ **Stiff Competition:** Whirlpool operates in a highly competitive home appliance industry having rivals namely Arcelik, Bosch, Electrolux, Haier, Kenmore, LG, Mabe, Midea, Panasonic and Samsung. The company faces competition on attributes such selling price, product features and design, consumer taste, performance, innovation, reputation, energy efficiency, service, quality, cost, distribution, and financial incentives. Moreover, with more and more companies adopting e-commerce channel and direct-to-consumer business models the competition has increased. Definitely, this may hurt the company's market share.
- ▼ **Risk of Operating in Overseas Markets:** Whirlpool derives a significant portion of its revenues from international operations, which exposes it to risks in the global market. Some of these risks involve exposure to foreign currency exchange rate fluctuations, changes in foreign country regulatory requirements, imposition of foreign tariffs and other trade barriers, government price controls as well as political, legal and economic instability.

Whirlpool's Asia business continues to remain soft in fourth-quarter 2020. Also, higher input cost as well as increased investments in marketing and technology is likely to weigh on margins.

Last Earnings Report

Whirlpool's Q4 Earnings & Sales Beat Estimates on High Demand

Whirlpool posted impressive fourth-quarter 2020 results wherein, both top and bottom lines not only beat the Zacks Consensus Estimate but also improved year over year. This marked the company's third successive quarter of record adjusted earnings. Markedly, the company witnessed significant year-over-year margin expansion in North America, Latin America, and Europe, Middle East and Africa (EMEA) regions. Clearly, demand for home appliances drove the quarterly results.

Moreover, management envisions signs of recovery such as improved demand and encouraging housing trends that position it well for 2021. As a result, Whirlpool envisions net sales (excluding currency impact) growth of approximately 6% for 2021. Additionally, it anticipates adjusted earnings in a band of \$19-\$20 per share, whose mid-point of \$19.5 suggest an increase from the current Zacks Consensus Estimate which is pegged at \$19.3.

An Insight into Q4

The appliances maker delivered adjusted earnings of \$6.64 per share that increased 35.2% year over year on the back of exceptional execution of go-to-market and cost takeout endeavors. Notably, the bottom line also surpassed the Zacks Consensus Estimate of \$6.39 per share.

Net sales of \$5,798 million rose 7.7% from the year-ago period and outpaced the Zacks Consensus Estimate of \$5,576 million, marking the third successive beat. Organic net sales increased 10.3% to \$5,937 million. The company delivered sales growth in all regions, except Asia.

Adjusted operating profit (EBIT) came in at \$657 million, up from \$389 million in the year-ago quarter. We note that the adjusted operating margin expanded 410 basis points to 11.3% with all regions registering meaningful margin expansion.

Regional Performance

Net sales from **North America** increased 4.4% year over year to \$3,208 million, driven by encouraging consumer trends. Excluding the currency impact, sales for the region rose 4.3%. Markedly, the segment's EBIT surged 41.7% to \$581 million, while the EBIT margin expanded 480 basis points to 18.1%. Aggressive cost-containment efforts and go-to-market actions fueled margin expansion.

Net sales from **EMEA** increased 21% to \$1,416 million. Excluding the currency impact, sales for the region rose 17.8%. Management highlighted that demand recovery drove solid volume growth of 6.5% year over year, with double-digit growth in key countries. Notably, the segment's EBIT of \$40 million improved significantly from \$11 million in the year-ago period, as higher demand and cost discipline offset currency headwinds.

Net sales from **Latin America** grew 5% to \$821 million. Excluding the currency impact, sales for the region advanced 27.9% owing to industry growth in Brazil. The segment EBIT of \$100 million surged from \$42 million in the year-ago period. Impressively, the EBIT margin expanded 680 basis points to 12.1%, courtesy of increased demand and positive price/mix that helped mitigate currency headwinds.

Net sales from **Asia** decreased 0.7% to \$354 million from the prior-year quarter's reported figure. Excluding the currency impact, sales for the region fell 0.7%. The company experienced demand recovery and share gains in India, despite pandemic-induced disruptions. The segment EBIT came in at \$21 million, reflecting a sharp rise from \$2 million reported in the year-ago period. The segment EBIT margin expanded on the back of significant share gains and stringent cost efforts.

Financial Position

As of Dec 31, 2020, Whirlpool had cash and cash equivalents of \$2,924 million, long-term debt of \$5,059 million and stockholders' equity of \$3,799 million, excluding non-controlling interest of \$910 million. The company repaid \$1.7 billion of outstanding short-term debt by year-end, including all COVID-related short-term borrowings. Management also highlighted that it has a liquidity of \$2.9 billion.

During the twelve-month period ended on Dec 31, 2020, Whirlpool has generated a free cash flow of \$1,246 million. The company expects a free cash flow of more than \$1 billion for 2021. Management anticipates incurring capital expenditures of \$410 million in the current financial year.

Recent News

Whirlpool Hikes Dividend – Feb 16, 2021

Whirlpool approved its quarterly cash dividend to \$1.25 per share to be payable Mar 15, 2021 to shareholders of record as on Feb 26.

Valuation

Whirlpool shares are up 9.5% in the year-to-date period and nearly 54.6% for the trailing 12-month period. Stocks in the Zacks sub-industry and the Zacks Consumer Discretionary sector are up 9.1% and 6.6% in the year-to-date period, respectively. Over the past year, the Zacks sub-industry and the sector are up 51.5% and 39.5%, respectively.

The S&P 500 index is up 4.3% in the year-to-date period and 32.2% in the past year.

The stock is currently trading at 9.72X forward 12-month earnings, which compares to 8.39X for the Zacks sub-industry, 34.66X for the Zacks sector and 22.52X for the S&P 500 index.

Over the past five years, the stock has traded as high as 13.41X and as low as 4.17X, with a 5-year median of 10X. Our Neutral recommendation indicates that the stock will perform in-line with the market. Our \$210 price target reflects 10.32X forward 12-month earnings.

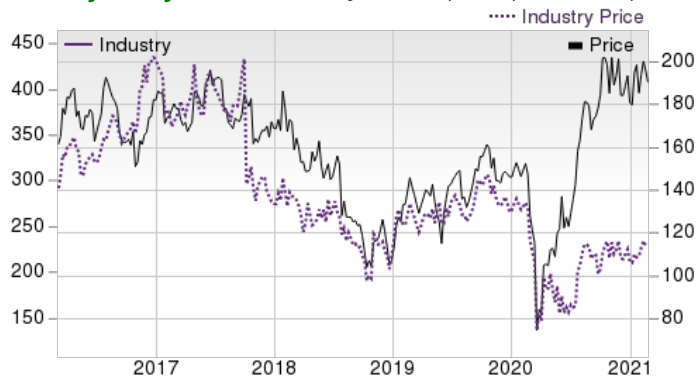

Zacks Rank

The Zacks Rank is our short-term rating system that is most effective over the one- to three-month holding horizon. The underlying driver for the quantitatively-determined Zacks Rank is the same as the Zacks Recommendation, and reflects trends in earnings estimate revisions.

Zacks Style Scores

The Zacks Style Score is as a complementary indicator to the Zacks rating system, giving investors a way to focus on the highest rated stocks that best fit their own stock picking preferences.

Academic research has proven that stocks with the best Value, Growth and Momentum characteristics outperform the market. The Zacks Style Scores rate stocks on each of these individual styles and assigns a rating of A, B, C, D and F. We also produce the VGM Score (V for Value, G for Growth and M for Momentum), which combines the weighted average of the individual Style Scores into one score. Glossary of Terms and Definitions

52-Week High-Low: The range of the highest and lowest prices at which a stock has traded during the past year. This range is determined based on the stock's daily closing price which may differ from the intra-day high or low. Many investors use it as a technical indicator to determine a stock's current value and future price movement. The idea here is that if price breaks out from the 52-week range, in either direction, the momentum may continue in the same direction.

20-Day Average Volume (Shares): The average number of shares of a company traded in a day over the last 20 days. It is a direct indication of a security's overall liquidity. The higher the average daily trading volume, the easier it is to enter or exit the stock at a desired price with more buyers and sellers being available.

Daily Price Change: This is the percentage difference between a trading day's closing price and the prior trading day's closing price. This item is updated at 9 p.m. EST each day.

1-Week Price Change: This is the percentage change in a stock's closing price over the last 5 trading days. This change reflects the collective buying and selling sentiment over the 1-week period.

A strong weekly price increase for the stock, especially when accompanied by increased volume, is an indication of it gaining momentum.

4-Week Price Change: This is the percentage change in a stock's closing price over the last 20 trading days or past 4 weeks. This is a medium-term price change metric and an indication of the stock gaining momentum.

12-Week Price Change: This is the percentage change of a stock's closing price over the last 60 trading days or past 12 weeks. Similar to 4-week price change, this is a medium-term price change metric. It shows whether a stock has been enjoying strong investor demand, or if it has been in consolidation, or distress over this period.

52-Week Price Change: This is the percentage change in a stock's closing price over the last 260 trading days or past 52 weeks. This long-term price change metric is a good reference point for investors. Some investors seek stocks with the best percentage price change over the last 52 weeks, expecting the momentum to continue.

Market Cap: The number of outstanding common shares of a company times its latest price per share. This figure represents a company's size, which indicates various characteristics, including price stability and risk, in which investors could be interested.

Year-To-Date Price Change: Change in a stock's daily closing price in the period of time beginning the first day of the current calendar year through to the previous trading day.

of Analysts: Number of EPS estimates used in calculating the current-quarter consensus. These estimates come from the brokerage analysts tracking this stock. However, the number of such analysts tracking this stock may not match the number of estimates, as all brokerage analysts may not come up with an estimate or provide it to us.

Beta: A measure of risk commonly used to compare the volatility of a stock to the overall market. The S&P 500 Index is the base for calculating beta and carries a value of 1. A stock with beta below 1 is less risky than the market as a whole. And a stock with beta above 1 is riskier.

Dividend: The portion of earnings a company is expected to distribute to its common shareholders in the next 12 months for each share they own. Dividends are usually paid quarterly. Dividend payments reflect positively on a company and help maintain investors' trust. Investors typically find dividend-paying stocks appealing because the dividend adds to any market price appreciation to result in higher return on investment (ROI). Moreover, a steady or increasing dividend payment provides investors a cushion in a down market.

Dividend Yield: The ratio of a company's annual dividend to its share price. The annual dividend used in the ratio is calculated based on the most recent dividend paid by the company. Dividend yield is an estimate of the dividend-only return from a stock in the next 12 months. Since dividend itself doesn't change frequently, dividend yield usually changes with a stock's price movement. As a result, often an unusually high dividend yield is a result of weak stock price.

S&P 500 Index: The Standard & Poor's 500 (S&P 500) Index is an unmanaged group of securities considered to be representative of the stock market in general. It is a market-capitalization-weighted index of stocks of the 500 largest U.S. companies. Each stock's weight in the index is proportionate to its market value.

Industry: One of the 250+ groups that Zacks classifies all stocks into based on the nature of business. These groups are termed as expanded (aka "X") industries and map to their respective (economic) sectors; Zacks has 16 sectors.

Zacks Industry Rank: The Zacks Industry Rank is determined by calculating the average Zacks Rank for all stocks in the industry and then assigning an ordinal rank to it. For example, an industry with an average Zacks Rank of 1.6 is better than an industry with an average Zacks Rank of 2.3. So, the industry with the better average Zacks Rank would get a better Zacks Industry Rank. If an industry has the best average Zacks Rank, it would be considered the top industry (1 out of 250+), which would place it at the top 1% of Zacks-ranked industries. Studies have shown that roughly half of a stock's price movement can be attributed to the industry group it belongs to. In fact, the top 50% of Zacks-ranked industries outperforms the bottom 50% by a factor of more than 2 to 1.

Last EPS Surprise: The percentage deviation of a company's last reported earnings per share from the Zacks Consensus Estimate. Companies with a positive earnings surprise are more likely to surprise again in the future (or miss again if they recently missed).

Last Sales Surprise: The percentage deviation of a company's last reported sales from the Zacks Consensus Estimate.

Expected Report Date: This is an estimated date of a company's next earnings release. The information originated or gathered by Zacks Investment Research from its information providers or publicly available sources is the basis of this estimate.

Earnings ESP: The Zacks Earnings ESP compares the Most Accurate Estimate to the Zacks Consensus Estimate for the yet-to-be reported quarter. The Most Accurate Estimate is the most recent version of the Zacks Consensus EPS Estimate. The idea here is that analysts revising their estimates closer to an earnings release have the latest information, which could potentially be more accurate than what they and others contributing to the consensus had predicted earlier. Thus, a positive or negative Earnings ESP reading theoretically indicates the likely deviation of the actual earnings from the consensus estimate. However, the model's predictive power is significant for positive ESP readings only. A positive Earnings ESP is a strong predictor of an earnings beat, particularly when combined with a Zacks Rank #1 (Strong Buy), #2 (Buy) or #3 (Hold). Our research shows that stocks with this combination produce a positive surprise nearly 70% of the time.

Periods:

TTM: Trailing 12 months. Using TTM figures is an effective way of analyzing the most-recent financial data in an annualized format that helps neutralize the effects of seasonality and other quarter-to-quarter variation.

F1: Current fiscal year. This period is used to analyze the estimates for the ongoing full fiscal year.

F2: Next fiscal year. This period is used to analyze the estimates for the next full fiscal year.

F12M: Forward 12 months. Using F12M figures is an effective way of analyzing the near-term (the following four unreported quarters) estimates in an annualized manner. Instead of typically representing estimates for the full fiscal year, which may not represent the nitty-gritty of each quarter, F12M figures suggest an all-inclusive annualized estimate for the following four quarters. The annualization helps neutralize the potential effects of seasonality and other quarter-to-quarter variations.

P/E Ratio: The price-to-earnings ratio measures a company's current market price per share relative to its earnings per share (EPS). Usually, the trailing-12-month (TTM) EPS, current-fiscal-year (F1) EPS estimate, or forward-12-month (F12M) EPS estimate is used as the denominator. In essence, this ratio shows what the market is willing to pay today for each dollar of EPS. In other words, this ratio gives a sense of what the relative value of the company is at the already reported level of earnings or at a future level of earnings.

It is one of the most widely-used multiples for determining the value of a company and helps comparing its valuation with that of a competitor, the industry group or a benchmark.

PEG Ratio: The price/earnings to growth ratio is a stock's P/E ratio using current fiscal year (F1) EPS estimate divided by its expected EPS growth rate over the coming 3 to 5 years. This ratio essentially determines a stock's value by factoring in the company's expected earnings growth and is thus believed to provide a more complete picture than just the P/E ratio, particularly for faster-growing companies.

P/S Ratio: The price-to-sales ratio is calculated as a company's current price per share divided by trailing 12 months (TTM) sales or revenues per share. This ratio shows what the market is willing to pay today for each dollar of TTM sales per share. The P/S ratio is at times the only valuation metric when the company has yet to become profitable.

Cash/Price Ratio: The cash-to-price ratio or Cash Yield is calculated as cash and marketable securities per share divided by the company's current share price. Like the earnings yield, which shows the anticipated yield (or return) on a stock from earnings for each dollar invested, the cash yield does the same, with cash being the source of return instead of earnings. For example, a cash/price ratio of 0.08 suggests a return of 8% or 8 cents for every \$1 investment.

EV/EBITDA Ratio: The EV/EBITDA ratio, also known as Enterprise Multiple, is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by EBITDA (earnings before interest, taxes, depreciation and amortization). Usually, trailing-12-month (TTM) or forward-12-month (F12M) EBITDA is used as the denominator.

EV/Sales Ratio: The enterprise value-to-sales ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by annual sales. It is an expansion of the P/S valuation, which uses market value instead of enterprise value. The EV/Sales ratio is perceived as more accurate than P/S, in part, because the market capitalization does not take a company's debt into account when valuing it.

EV/CF Ratio: The enterprise value-to-cash flow ratio is calculated as a company's enterprise value (market capitalization + value of total long-term debt + book value of preferred shares - cash and marketable securities) divided by the trailing-12-month (TTM) operating cash flow. It's a measure of how long it would take to buy the entire business if you were able to use all the company's operating cash flow.

The EV/CF ratio is perceived as more accurate than the P/CF ratio, in part, because the market price does not take a company's debt into account when valuing it.

EV/FCF Ratio: The enterprise value-to-free cash flow metric compares a company's enterprise value to its trailing-12-month (TTM) free cash flow (FCF). This metric is very similar to the EV/CF ratio, but is considered a more exact measure owing to the fact that it uses free cash flow, which subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding growth activities and payments to shareholders.

P/EBITDA Ratio: The P/EBITDA ratio is calculated as a company's per share market value divided by EBITDA (earnings before interest, taxes, depreciation, and amortization). This metric is very similar to the EV/EBITDA ratio, but is considered a little less exact measure as it uses market price, which does not take a company's debt into account. However, since EBITDA is often considered a proxy for cash income, the metric is used as a measure of what the market is willing to pay today for each dollar of the company's cash profitability in the trailing 12 months (TTM) or forward 12 months (F12M).

P/B Ratio: The price-to-book ratio is calculated as a company's current price per share divided by its book value (total assets – liabilities – preferred stocks) per share. In short, the book value is how much a company is worth. In other words, it reflects the total value of a company's assets that its common shareholders would receive if it were to be liquidated. So, the P/B ratio indicates whether you're paying higher or lower than what would remain if the company went bankrupt immediately. Investors typically use this metric to determine how a company's stock price stacks up to its intrinsic value.

P/TB Ratio: The price-to-tangible-book value ratio is calculated as a the per share market value of a company divided by the value of its tangible assets (total assets – liabilities – preferred stocks – intangible assets) per share. Tangible book value is the same thing as book value except it excludes the value of intangible assets to get a step closer to the baseline value of the company.

P/CF Ratio: The price-to-cash flow ratio measures a company's per share market price relative to its trailing-12-month (TTM) operating cash flow per share. This metric is used to determine whether a company is undervalued or overvalued relative to another stock, industry or sector. And like the P/E ratio, a lower number is typically considered better from the value perspective.

One of the reasons why P/CF ratio is often preferred over P/E ratio is the fact that operating cash flow adds back non-cash expenses such as depreciation and amortization to net income. This feature helps valuing stocks that have positive cash flow but are not profitable because of large noncash charges.

P/FCF Ratio: The price-to-free cash flow ratio is an extension of P/CF ratio, which uses trailing-12-month (TTM) free cash flow per share instead of operating cash flow per share. This metric is considered a more exact measure than P/CF ratio, as free cash flow subtracts capital expenditures (CAPEX) from a company's total operating cash flow, thereby reflecting the actual cash flow available for funding activities that generate additional revenues.

Earnings Yield: The earnings yield is calculated as current fiscal year (F1) EPS estimate divided by the company's current share price. The ratio, which is the inverse of the P/E ratio, measures the anticipated yield (or return) from earnings for each dollar invested in a stock today.

For example, earnings yield for a stock, which is trading at \$35 and expected to earn \$3 per share in the current fiscal year (F1), would be 0.0857 ($3/35 = 0.0857$) or 8.57%. In other words, for \$1 invested in the stock today, the yield from earnings is anticipated to be 8.57 cents.

Investors most commonly compare the earnings yield of a stock to that of a broad market index (such as the S&P 500) and prevailing interest rates, such as the current 10-year Treasury yield. Since bonds and stocks compete for investors' dollars, stock investors typically demand a higher yield for the extra risk they assume compared to investors of U.S. Treasury-backed securities that offer virtually risk-free returns. This additional return is referred to as the risk premium.

Debt/Equity Ratio: The debt-to-equity ratio is calculated as a company's total liabilities divided by its shareholder equity. This metric is used to gauge a company's financial leverage. In other words, it is a measure of the degree to which a company is financing its operations through debt versus its own funds. The higher the ratio, the higher the risk for shareholders.

However, this ratio is difficult to compare across industry groups where ideal amounts of debt vary. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-equity ratio should be compared with other companies in the same industry.

Cash Flow (\$/share): Cash flow per share is calculated as operating cash flow (after-tax earnings + depreciation + other non-cash charges) divided by common shares outstanding. It is used by many investors as a measure of a company's financial strength. Since cash flow per share takes into consideration a company's ability to generate cash by adding back non-cash expenses, it is regarded by some as a more accurate measure of a company's financial situation than earnings per share, which could be artificially deflated.

Current Ratio: The current ratio or liquidity ratio is a company's current assets divided by its current liabilities. It measures a company's ability to pay short-term obligations. A current ratio that is in line with the industry average or slightly higher is generally considered acceptable. A current ratio that is lower than the industry average would indicate a higher risk of distress or default. A higher number is usually better. However, a very high current ratio compared to the industry average could be an indication of inefficient use of assets by management.

Debt/Capital Ratio: Debt-to-capital ratio is a company's total debt (interest-bearing debt + both short- and long-term liabilities) divided its total capital (interest-bearing debt + shareholders' equity). It is a measure of a company's financial leverage. All else being equal, the higher the debt-to-capital ratio, the riskier the stock.

However, this ratio can vary widely from industry to industry, the ideal amount of required debt being different. Some businesses are more capital intensive than others and typically require higher debt to finance their operations. So, a company's debt-to-capital ratio should be compared with the same for its industry.

Net Margin: Net margin is calculated as net income divided by sales. It shows how much of each dollar in sales generated by a company translates into profit. For example, if a company's net margin is 15%, its net income is 15 cents for every \$1 of sales it makes.

A change in margin can reflect either a change in business conditions, or a company's cost controls, or both. If a company's expenses are growing faster than sales, its net margin will decline. However, different net margin rates are considered good for different industries, so it's better to compare net margin rates of companies in the same industry group.

Return on Equity: Return on equity (ROE) is calculated as trailing-12-month net income divided by trailing-12-month average shareholder equity (including reinvested earnings). This metric is considered a measure of how effectively management is using a company's assets to generate profits. For example, if a company's ROE is 10%, it creates 10 cents profits for every \$1 shareholder equity, which is basically the company's assets minus debt. A company's ROE deemed good or bad depends on what's normal for its peers or industry group.

Sales/Assets Ratio: The sales-to-assets ratio or asset utilization ratio or asset turnover ratio is calculated as a company's annual sales divided by average assets (average of assets at the beginning of the year and at the year's end). This metric helps investors understand how effectively a company is using its assets to generate sales. For example, a sales-to-assets ratio of 2.5 indicates that the company generated \$2.50 in sales for every \$1 of assets on its books.

The higher the sales-to-assets ratio, the better the company is performing. However, similar to many other ratios, the asset turnover ratio tends to be higher for companies in certain industries/sectors than in others. So, a company's sales-to-assets ratio should be compared with the same for its industry/sector.

Historical EPS Growth (3-5 Years): This is the average annual (trailing-12-month) EPS growth rate over the last 3-5 years. This metric helps investors see how a company's EPS has grown from a long-term perspective.

Note: There are many factors that can influence short-term numbers — a recession will reduce this number, while a recovery will inflate it. The longterm perspective helps smooth out short-term events.

Projected EPS Growth (F1/F0): This is the estimated EPS growth rate for the current financial year. It is calculated as the consensus estimate for the current fiscal year (F1) divided by the reported EPS for the last completed fiscal year (F0).

Current Cash Flow Growth: It measures the latest year-over-year change in operating cash flow. Cash flow growth tells an investor how quickly a company is generating inflows of cash from operations. A positive change in the cash flow is desired and shows that more 'cash' is coming in than going out.

Historical Cash Flow Growth (3-5 Years): This is the annualized change in cash flow over the last 3-5 years. The change in a longer period helps put the current reading into proper perspective. By looking at the rate, rather than the actual dollar value, the comparison across the industry and peers becomes easier.

Projected Sales Growth (F1/F0): This metric looks at the estimated sales growth for the current year. It is calculated as sales estimate for the current fiscal year (F1) divided by the reported sales for the last completed fiscal year (F0).

Like EPS growth, a higher rate is better for sales growth. A look at a company's projected sales growth instantly tells you what the outlook is for their products and services. However, different sales growth rates are considered good for different industries, so it's better to compare sales growth rates of companies in the same industry group.

EPS F1 Estimate 1-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past week. The change in a company's consensus EPS estimate (or earnings estimate revision) has proven to be strongly correlated with the near-term price movement of its shares. It is an integral part of the Zacks Rank.

If a stock's consensus EPS estimate is \$1.10 now versus \$1.00 a week ago, that will be reflected as a 10% upward revision. If, on the other hand, it went from \$1.00 to 90 cents, that would be a 10% downward revision.

EPS F1 Estimate 4-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past four weeks.

A stock's earnings estimate revision in a 1-week period is important. But it's more meaningful to look at the longer-term revision. And, of course, the 4-week change helps put the 1-week change into proper perspective.

EPS F1 Estimate 12-Week Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal year over the past 12 weeks.

This metric essentially shows how the consensus EPS estimate has changed over a period longer than 1 week or 4 weeks.

EPS Q1 Estimate Monthly Change: The percentage change in the Zacks Consensus EPS estimate for the current fiscal quarter over the past four weeks.

While the revision in consensus EPS estimate for the current fiscal year is strongly correlated with the near-term price movement of its shares, the estimate revision for the current fiscal quarter is an important metric as well, especially over the short term, and particularly as a stock approaches its earnings date. If a stock's Q1 EPS estimate decreases ahead of its earnings release, it's usually a negative sign, whereas an increase is a positive sign.
